POWERS FINE TOWN

MUCH BUILDING ACTIVITY AT NEW METROPOLIS OF THE SOUTHERN SECTION

Many New Structures Under Way—Plat Fixing Name For Well Known Man Approved

"Powers," the new town that is springing up at the terminus of the Smith-Powers logging road south of Myrtle Point and which is named in honor of A. H. Powers, is one of the most promising towns along the coast, according to W. C. Bradley, who has just returned from there. On every side there is activity in erecting business houses and dwellings for the city to be and which it is claimed by some will have a population of about 3,000 in the course of a few years. It will be the headquarters of the Smith-Powers logging company for many years to come and will be the center of operations during the many years it will take to remove the timber from that district.

The new town is on the south side of the river. A depot is nearing completion and the office buildings of the company have been erected nearby. Not far distant is a new building, 20x40 which the Lockhart Parsons company is erecting for a drug store. B. F. Mathes of Myrtle Point is erecting a two-story building, 20x70, for a billiard parlor, etc.

G. W. Craig, former proprietor of the Bunker Hill boarding house which was destroyed by fire last winter, is erecting a hotel 22x50, two stories high. Spencer & Shelly of Myrtle Point have bought a lot and will erect a building for a men's furnishing and dry goods store.

A hotel is also projected and an \$18,000 school building is projected. The Smith-Powers company is just finishing an eight-story round house. They will also erect a machine shop 52x100, which will be practically a duplicate of the machine shop at the Smith mill here, and also a car shop 30x100. J. W. Bomar is superintendent of construction and is doing fine work.

A NEW TIME CARD

LOCAL RAILWAY WILL EXTEND SERVICE TO WAGNER

May Result in Mail being Delayed Couple of Hours Unless Contractor Hurries

Supt. W. F. Miller, of the Coos Bay, Roseburg & Eastern, announces that the train service will be extended to the new town of Powers next Sunday. Under a contract, the Southern Pacific will operate over the new logging road of the Smith-Powers Company, handling all business except the logging and allied business of the company. In return under this contract, the Smith-Powers company has a wheelage contract over the local railway from Myrtle Point to Marshfield.

The new time card will result in Coos Bay's incoming mail arriving a couple of hours later unless the contractor is able to get it into Myrtle Point by 4 o'clock in the afternoon, in which case it would arrive here about fourteen hours earlier than at present. Superintendent Miller is hoping that the good weather and auto service will permit the mail to arrive earlier.

The new time card provides for morning train to leave Marshfield at 7:10 each morning and returning here at 12:38. This will run through to Powers. The afternoon train will leave Marshfield at 2:25 and return at 5:35. The afternoon train will run only as far as Myrtle Point.

On Sundays there will be two trains clear through to Powers. These will leave Marshfield at 7:10 in the morning and 1:30 in the afternoon, returning here at 12:28 and 6:35 respectively.

Superintendent Miller has appointed H. S. Tower official watch inspector of the local railway.
