FIVE FIRES STARTED

WASTE BURNER AT MILL BELIEVED RESPONSIBLE

Four Residences in Bay City Have Holes Burned in Roofs and Tank at Mill Has Small Blaze

Four fires were started yesterday afternoon on the roofs of Bay City residences and a fifth this morning on the water tank at the mill, presumably from sparks out of the refuse burner at the C. A. Smith mill. All five were hastily put out and without much damage resulting.

With the wind blowing from the west early yesterday afternoon, it is believed that the sparks were carried across to the roofs where they settled down and gradually burned their way through.

Mrs. H. Roger Brinkley was out searching for the origin of smoke when men came over from the mill and aided in putting out a small blaze that had started in the roof over the front porch. She said a small hole was burned there.

Later fire was found in the roof of the J. A. Chapin residence, over the front porch of the L. S. O'Connor home and also on the roof of the residence of L. B. Kelley.

Shortly after eight o'clock this morning the fire whistle at the Smith mill was sounded and in a few minutes a fire that had started on the timbers of the water tank was extinguished with a very small loss.

BROTHER AT FRONT

FRANK ALCIATI HAS RELATIVE IN ITALIAN ARMY

Gets Letter But So Censored Impossible to Tell Where it Was Mailed

Frank Alciati, at the Chandler Hotel, received a letter yesterday from his brother Jack Alciati in Italy saying that he has joined the artillery corps and is on his way to the front. The brother is 38 years of age and leaves behind him a wife and large family. Frank Alciati has not seen him in 10 years. The letter, he said, had been so censored that he could not tell from what town it was mailed, in what regiment his brother is or anything at all about their movements. He says that taking into consideration the fact his brother is 38 years old shows that already the Italians are calling for their second reserves.

INTERESTING SERVICE IS HELD ON NORTH INLET

Rev. O. C. Wright, Superintendent of Mission, Makes Principal Address of Occasion.

(Special to The Times.) HAUSER, Or., June 24.—The North Inlet chapel was formally dedicated on Sunday, June 20, by Rev. O. C. Wright, superintendent of State Missions, for the Baptist Association.

The morning session, at ten o'clock, opened with a song service, followed by prayer, offered by Elder L. H. Steinhoff, District Missionary, after which Steinhoff introduced Rev. Wright, of Portland, who delivered an earnest address urging the real living of a Christian life.

During the service a beautiful solo was sung by Mrs. Laura McCrea, and a duet by Mrs. McCrea and Mrs. Spencer Small, Miss Gladys Howard organist and Harvey May, violinist, accompanying. This session closed by the singing of the hymn "Sunshine on the Hill," and the benediction by Rev. Wright.

Served Picnic Dinner.

At the noon hour an excellent picnic dinner was enjoyed by all present, after which a short, informal business meeting was held, while awaiting the arrival of Rev. G. LeRoy Hall and party, who came over on the Life-Line, from Marshfield. The low tide delayed them until about three o'clock. With Mr. Hall were the following: Rev. Dr. C. A. Woody, of Home Missions for the Pacific Coast; Whitford Hall, Mr. and Mrs. Herbert Lupton, Mr. and Mrs. Spencer Simmons and daughter, Lois, Mr. and Mrs. D. L. Rood, of Marshfield, and Miss Ella Gurnea, of North Bend.

The afternoon session opened with the congregation singing "How Firm a Foundation," led by the choir, composed of Mrs. McCrea, Mrs. Small, Mrs. Ned Galloway, Mrs. Alice Archer and Miss Arctura Sprague. Invocation was then offered by Mr. Steinhoff, and the singing of "Rock of Ages" followed. Scripture lesson was read by Mr. Steinhoff.

Delivers Sermon.

Mrs. McCrea then sang "Hold Thou My Hand." Prayer was offered by Rev. G. LeRoy Hall, and Rev. Wright introduced Dr. Woody, who spoke. Dr. Woody went straight to the hearts of his hearers, who will never forget his earnest and tender presentation of the absolute love of God for the world. He said in part: "There are three things on the surface of this text, just as there appear to be three separate peaks to a great mountain, yet they all make the one mountain. First of all, the fact that God loved the world; second, the act: He gave His Son; and third, the compact with the Son, that whosoever believeth shall have eternal life.

There is no promise in this text, but there is a compact here. He loved and He gave, He gave His Son in such a way that He never again can be just the same. There was no taking back the gift; it was an absolute surrender. Let us suppose a conversation between Father and Son, about the needs of the beloved. The Son offers Himself to secure their salvation. He said "All this will I do; I will take upon myself all the sins of the world, but promise me that every one who believes on me shall be saved and that there never shall be a failure at that point. An infinite fact, an infinite act and an eternal compact. That is the only kind of salvation and the only kind of an offer of salvation that the Scriptures contain. He loved us; we can do nothing but to love Him in return."

Rev. Hall Speaks.

Mrs. McCrea and Mrs. Small then sang "No Night There," and after a few impressive and well chosen remarks by Rev. Hall, the dedicatory prayer was offered by Rev. Wright.

Wm. Howard was then called upon for a few words, and he closed by thanking the visiting pastors, and also all who had contributed to the successful building of the chapel. It was made plain that while the chapel was built and dedicated by the Baptist Association, it is to be feely used as a meeting place of all our people and friends, of whatever denomination, and pastors from various churches will be asked to conduct services there from time to time.

Closing remarks were made by Rev. Wright and Elder Steinhoff, and the congregation sang "Blest Be the Tie that Binds," and the benediction was pronounced by Dr. Woody.

Members of the congregation accompanied Mr. Hall's party to the Life-Line, Mr. Steinhoff going with them to North Bend, where he conducted evening worship at the Christian Church.
