GET GRAIN EXHIBIT COMPLAINT IS MADE

MARSHFIELD CHAMBER OF COMMERCE PLANS DISPLAY

Number of Ranchers Send in Exhibits—Investigation of Logansberry Industry Is Begun

Secretary J. W. Motley is gathering quite a collection of agricultural products of this section for exhibit here. He is endeavoring to get ripened products so that they will be a more lasting exhibit. Among those who have given products so far are: L. F. Price of Sumner, oats; L. D. Smith of Daniels Creek, clover, rye orchard grass, and alfalfa; Merchant Brothers, Bullards, tree oats.

P. E. Larson of Allegany, oats. Logansberry industry. Mr. Motley is writing to a number of Willamette valley and Washington towns and also to officials of the Oregon Agricultural College at Corvallis for information regarding the logansberry industry. He is trying to get facts regarding the growing of the berries, the cost of installing canneries and dryers to handle the crop, etc., for the benefit of local ranchers who are figuring on developing the industry here.

JUSTICE PENNOCK APPEALED TO BY BUNKER HILL PEOPLE

Charge that James Durrand Frightened Them With Threats During Last Few Weeks

"A reign of terror" is existing in part of Bunker Hill according to complaints made by Justice C. L. Pennock yesterday by some of the residents there. They appealed to him to have James Durrand put under peace bonds or dealt with in some other way as they claim that they fear Durrand will do bodily harm to some of them.

Justice Pennock is puzzled as to the steps he shall take but will probably send for Durrand and explain the situation to him.

According to the complaint made, Durrand drinks to excess frequently and at such times threatens the residents of that neighborhood. Durrand was placed on the "black list" some time ago but it does not seem to have kept him on the water wagon.

BUSY COURT TERM GOOD ROAD BONDS ARRANGE A MATCH

MUCH BUSINESS TO COME UP IN CURRY COUNTY

Grand Jury Will Investigate Several Cases and a Number of Civil Suits on Docket

District Attorney J. C. Johnson, of Curry County, who was in the city yesterday, says that there will probably be a longer term than usual in Curry County when the Circuit Court opens August 24. Judge Calkins, of Jackson County, is to be on the bench and Mr. Johnson will have a number of cases to prosecute and will also appear as attorney in several of the civil cases.

Criminal Cases
Among the criminal cases to be investigated by the grand jury is that of Coleman Roberts, in jail awaiting action on a charge of assault with a deadly weapon. It is alleged that he hit a man over the head with a hammer.

Jack Chiddock is under bond on a charge of assault and battery. The case is one from the Port Orford district.

A. Carey, of the Port Orford neighborhood, is charged with stealing a sheep and the grand jury will look into his case and a man named Wilhite is charged with stealing a hog.

It is quite likely that some bootlegging cases will develop before the grand jury and District Attorney Johnson will probably have a busy term of prosecuting.

Civil Suits Up.

There are several civil suits of interest to be tried. Editor Stewart of the Tribune, and Editor Masters of the Globe, have a legal controversy over the county printing. The Globe has been awarded the work and there is a dispute as to which has the larger circulation.

The Seaborg cannery has a suit against the Wedderburn Trading Company for \$800 damages claimed because a temporary injunction was asked for by the Wedderburn Company and was afterward dissolved.

Another suit to be tried is between the Macleay estate and Alf Miller regarding some boundaries of property. There is also a mandamus proceeding against the County Court involving some road work. A number of other civil cases will be up for trial.

CIRCULATE PETITIONS CALLING SPECIAL ELECTION

Provides \$75,000 for Bandon-Curry Road—Balance Between Myrtle Point and South Slough

Petitions asking the Coos County court to call a special election to vote \$375,000 good roads bonds are being circulated today. No date is set for the election. It is said that 250 petitions are being circulated in the county.

The petitions provide for a general division of the \$375,000 issue and are as follows:

"We, the undersigned registered voters of Coos County, Oregon, respectfully petition that you call a special election for the purpose of submitting to the voters of this county, the question of issuing bonds to provide for the construction of permanent roads in this County, to the amount of \$375,000, to run for a period of twenty years and bearing interest at the rate of five and one half per cent per annum. To be redeemed one-tenth annually, beginning at the end of the eleventh year. Seventy-five thousand dollars of the money raised from the aforesaid bond issue to be expended in the construction and improving of a highway between the City of Bandon and the Curry County line.

Two hundred ninety-five thousand dollars to be expended in the construction and improvement of a permanent highway at such places as your Honorable Body may direct, between Myrtle Point, Coquille, Marshfield, North Bend, Empire and South Slough bridge on Coos Bay.

Oppose the Plan.

Hank Diers was here from North Bend today and said that the division of the good roads bond money as proposed in the petitions would cause a fight on the proposition.

No provision is made for any of the money going to the Ten Mile district or to the Coos River or Allegany sections and they will oppose it.

GEO. LAMBERT AND JIM WILSON WILL WRESTLE

Event to Take Place at Myrtle Point on the Night of August Seventh

(Special to the Times.) MYRTLE POINT, Aug. 4.—Arrangements have been made for a wrestling match to take place here August 7, between Geo. Lambert and Jim Wilson.

This is promised to be a match of unusual interest as Lambert has won five matches here, suffering no defeat, and is scheduled to wrestle with M. G. Lutsey at the county fair on September 12. Wilson secured two out of three falls over Lutsey at Bandon last Saturday evening in a match lasting one and one-half hours.

Mr. Baxter plans to take eleven men over and has not decided on the lineup. The players he expects to take to Roseburg are Catchers Perkins and Thomas, Pitchers Norm Johnson and Collier, and Kissam, Merchant, and Burke of Coos Bay and Dement, Koontz Oerding and Howell from the Coquille valley.

FOLLOW COOS PLAN

Two More Cow Testing Associations Added in State.

Two more cow-testing associations have been added to the list of Oregon dairy clubs, reports W. A. Barr, O. A. C. and federal field dairy specialist. One of the new associations was formed at Monmouth, Polk County, and the other in the neighborhood of Carleton and McMinnville, Yamhill County. These make a total of fourteen cow-testing associations, according to Professor Barr, but the associations are formed with fewer cows than in local clubs, some of them having not more than 300. In Oregon the number of cows to the association runs from 500 to 800, so that it is quite likely that there are now more cows under test in Oregon than in any other state of the Union.

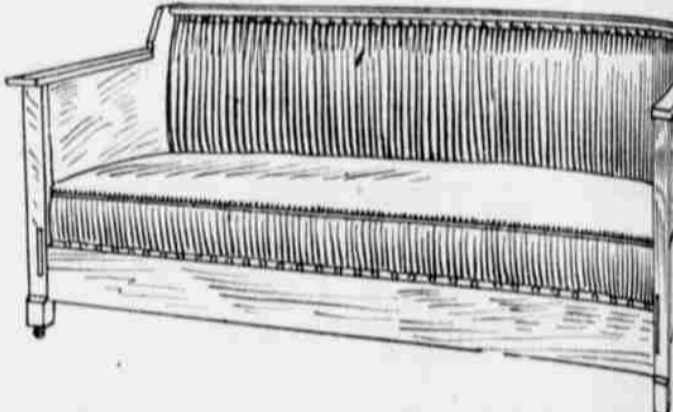

SUMMER HOME IS TROUBLED BY SKUNKS

Dr. Bartle and Family Have Unpleasant Experience at Their Coos River Cottage

Dr. Ira B. Bartle has about recovered from a harrowing experience he had with a skunk at his summer home on South Coos River. The last trace of the unwelcome visitor has been eliminated after strenuous use of many gallons of formaldehyde and other disinfectants and deodorizers.

They had been having trouble for some time by wood rats and a number of steel traps were being used successfully in eliminating the pest. The traps were set at various places around the house, including one on the front porch near the sleeping quarters. The skunk got into this one the results can be imagined better than they can be told.

A number of South Coos River people have suffered from similar experiences during the past few months. Dr. Bartle says that henceforth all steel traps around the place will be set where there is no chance of a skunk getting into them.

LAYING RAILS FAST

SOUTHERN PACIFIC TRACK COMPLETED TO SAUNDERS LAKE

Only Four Miles More of Track to Reach Lakeside—Get Plenty of Ties

Hillis Short was in from Saunders Lake today and state: 3rd Engineer Hindmarsh, in charge of the Southern Pacific track construction, informed him that they would have rails laid to Saunders Lake tomorrow night. It is only four miles from Saunders Lake to Lakeside and that gap will be closed up soon.

For sometime they have been handicapped in the track work by a shortage of ties. However they have contracted for 1,500 which Mr. Short has taken off his homestead and also for 6,000 from Miller as that they will have plenty to finish the track to the lakes.

With the track laid, it is expected that service will soon be instituted between Marshfield and Lakeside.

Particular mention of the Myrtle wood furniture shown at the exposition which is one of the products of which Coos Bay is proud, is made by Anne Shannon Monroe, writing in the Oregonian of the Oregon building at the Panama-Pacific Exposition as follows:

"The runners for the floor of the same soft gray as the walls, but relieved with touches of blue, orange and red; the chairs have cushions of the exposition orange shade and the window curtains are of a pinky orange through which the light comes in a warm glow. The long myrtle wood table with the eight chairs perhaps is the most obviously attractive exhibit, people simply rave over the set. One woman said she heard about it in Brooklyn, N. Y., and when she reached the exposition she made a bee-line for the Oregon room to see it. Wood workers consider the design for the chairs especially happy for so hard a wood. In order to facilitate matters, he held many night sessions and heard many cases in Chambers here.

Judge Skipworth of Eugene will hold the September term of court at Coquille for Judge Coke in order that a number of cases in which Judge Coke is disqualified may be tried. In these actions, Judge Coke was interested as any attorney prior to his elevation to the bench.
