WIRELESS COMING? RADIO MEN FROM MARE ISLAND INSPECT SITES Say Government Willing to Spend \$20,000 If Tract Can Be Obtained Here for Big Station Four possible wireless sites are under consideration today by Lieutenant E. J. Blankenship and George E. Hanson, of Mare Island. They expect to leave in the morning for the south again and unless, by that time, a site is definitely chosen a new government station in all probability will not be brought to Coos Bay. Bandon has several times made alluring inducements to get the Cape Blanco Station. Inspection of the site on the Klahn tract, Isthmus Inlet, was made yesterday by the radio men. They were accompanied by Henry Senzstacken, R. M. Jennings, Dr. Leslie, J. H. Flanagan and Fred Gettings. Too much hilly land, said the visitors, makes the site undesirable and they were shown other possible five acre tracts. One was on Coal Bank Inlet, close to the Libby road, another at the foot of Fifth street, on Coal Bank Inlet. Negotiations are being carried on with the Reynolds Development company regarding the price and purchase of this land if needed. This morning Henry Senzstacken showed the officers a possible tract in Eastside, situated on the flats along Coos River. They said that this is too far from the railroad, telegraph and telephone. Should a site be definitely accepted today Lieut. Blankenship says within two weeks work would be started on the station. Under a new system the receiving and sending of messages is entirely silent so there would be no noise to bother nearby residents. Two poles, 300 feet in height, would be necessary. These would be built of native lumber, not all in one piece, but of lattice work type. There would also be a station, and a house for the four operators, this to cost about \$5,000. He expected that the station would be finished and ready for operation by December. G. E. Hanson is a civilian, an expert radio aid, and would have charge of construction here. WALRATH NEAR DROWNING IN COOS RIVER SUNDAY Rescued from Water by Jesse Frantz Sixteen Years ago Acts Promptly Jesse Frantz, aged 16 years and a nephew of Dr. Houseworth with whom he resides, made a heroic rescue on Coos river Sunday. He saved Ed. Walrath who was very nearly drowned. There was a large party of resorters at the Goodwill place Sunday. Walrath shortly after eating dinner went into the water bathing. He was not accustomed to swimming and he attempted to swim across the river when he was taken with cramps. It is believed that he went into the water too soon after eating a hearty dinner and that stomach trouble caused him to give out. Goes to Assistance Frantz saw Walrath was in trouble and went to his assistance. He floated out a toboggan used on the slide at the Goodwill place. Walrath seemed unable to take hold of the toboggan and Frantz got hold of him and by keeping cool and managing himself splendidly in the water got Walrath ashore. V. C. Gorst was some distance away and saw that someone was drowning and hurried to the spot. He said that Frantz showed excellent judgement and a cool head in getting the victim out of the water. Narrow Escape Walrath was unconscious when taken out and would have in a few seconds gone to the bottom of the river had not he been rescued when he was. Dr. Houseworth was also there and directed what should be done and after several worked for nearly an hour Walrath was revived. He is 30 years old and the son of R. J. Walrath who conducts the Rogers rooming house. Frantz not long ago saved a girl from drowning.

The doctor found it necessary to put her under the influence of chloroform in order to stitch the cuts on her face.
