EUROPEAN WAR ONE YEAR AGO TODAY

SEPT. 22, 1914. General Joffre, in command of the allied troops, reports that he is advancing and that the German center is weakening. Nine miles of dead in the trenches are reported between Peronne and St. Quentin. Military experts estimate that 2,000,000 or more men are in the zone where the battle has been in progress for ten days. The British cruisers Aboukir, Hogue and Cressy were sunk by a German submarine flotilla with the loss of 1,500 British sailors. The Austrians are reported defeated by the Serbians in a battle which lasted several days on the Drina river. The Serbian and Montenegrin troops occupy Sarajevo, the capital of Bosnia, which was abandoned by the Austrians. French ships bombarded Cattaro, the Austrian seaport on the Gulf of Cattaro.

SALEM—The state land board has given another extension of time to Jason C. Moore of New York in which to begin work on his Sumner and Albert lakes project for the securing of minerals.

BAKER—In an attempt to jump from a buggy when the horses were running away, Mrs. J. L. Masters plunged head first to the pavement and was killed.

HOOD RIVER—The first exhibit of live stock in the Hood River district was such a success that it will be made an annual affair.

PORTLAND—Mrs. L. A. McGregor, widow of Captain Robert McGregor, civil war veteran, died at the age of 80 years at her home.

ALBANY—With 4 teachers, a new junior high school and operating under a new system the Albany schools opened Monday.

TILLAMOOK—At the homesteaders' fair Rev. J. L. Samples had his jaw broken in two places when hit by a baseball while batting in a game.

The Lane county work was the last lap of the improvement necessary for the opening of the road so that it would be passable for motor travel. The completion of the project will mean much to the western part of Lane county and the summer business of future years. Mr. Mackey states that the first motor car has already made the trip from Newport to Florence and that little difficulty was encountered along the way, according to the occupants of the car.
