In a short time the Pioneer stone quarry will begin shipping random stones for the new city hall at Salem. There will be about fifty or sixty carloads of this stone used in the construction of that building.

Mr. and Mrs. R. Dedrick, Mr. and Mrs. Fred Stanton, and a cousin of the latter from Albany, will start the latter part of the week for a pleasure trip to the mouth of the Siletz river. They expect to be gone a week or ten days and will enjoy themselves hunting and fishing.

The water is conveyed to the mill from a distant spring by means of a pipe. This pipe had sprung a leak and wasted the greater part of the flow. Austin Rosebrook and his mother are rejoicing over the reopening of the Oregon National Bank, at Portland. They had we understand, about \$1,400 on deposit at that place when the bank closed its doors.

County Clerk Jones informs us that the comparing of the records which have now all been transcribed, will be completed about the first of October and will be then brought to the court house at this place. Lincoln county will then have a complete set of records, and a set that for neatness and correctness will be second to none in the state.

F. M. Stanton is completing, on his place north of Toledo on the Siletz road, one of the best and largest farm houses in Lincoln county. The house is 32x32 feet on the ground and 21 feet high, with bay windows and porches in the proper places to give it a handsome appearance. The building speaks well for the enterprise and thrift of Mr. Stanton, as it also does for the workmen who erected it, Messrs. R. Dedrick and Fred Stanton.
