Last night was Hallowe'en and the signs and other portable fixtures, made strange exchanges. It's funny, but boys will be boys.

N. Snow has rented the Mackay farm across the Bay for one year with the privilege of a longer lease. He has not yet decided as to whether or not he will move onto it.

Several of the farmers in this vicinity clubbed together and got a car load of flour and feed from the Stayton mill, which arrived this week. We were informed that they made a saving of seven cents per barrel on the flour.

The work at the government quarry has almost suspended, all the men but five being let out yesterday. This gang will be transferred to Yaquina where they will handle the stone from the cars onto the scows. The telephone at the quarry has been taken down, and Vincents moved down today.

It is expected that the payment of the Indians on the reservation will begin tomorrow. The money has been transferred from the sub-treasury in New York to Portland, and the Indians will be paid in checks on that place. Col. Lane, the inspector, has the census rolls and all the preliminary work finished.

Prof. David Rosebrooks has accepted a position as cornetist in a Portland orchestra, and left for the scene of his labors Saturday. For the present his wife will remain here. Prof. Rosebrooks' departure is much to be regretted as under his direction the Marine band and orchestra attained a degree of musical proficiency seldom found in country places.—Times.

The additions to our show window have been so plentiful this week that space forbids us making an extended mention of each one. The products are universally good and the show attracts much attention. Rev. L. M. Butler's samples of carrots and mangels are superb, and Alonzo Dunden brought down from their place on Depot, a fine display of apples of five varieties. We wish that our friends from the Alsea, as well as from all other parts of the county could add some of their products to the display. We desire to show all parts of the county if possible, and we know that the Alsea country is not behind in quality.

The sample of tobacco left here last week indicates another industry which might be profitably pursued in Lincoln County. The sample referred to is well developed and indicates that the soil is congenial to its culture. The principal objection which could be raised would be that it would not cure in this climate. If the plants are set out early and ripen as early as the latter part of August there would be enough fine weather to cure it in ordinary years. Jas. Hamar informed us that Mr. L. C. Norton and himself had cured quite an amount of it this year. We would like to hear from them more fully as to when it ripens and the success they have in curing. Tobacco is a staple crop and one that always brings in ready money. The soil of this county seems peculiarly adapted to it and if this crop can be successfully cultivated here it would be a resource of much importance.

Hotch Potch From Yaquina

Arrived in at 8 o'clock Sunday morning, the steamer Homer from San Francisco, Capt. Charles Patton, master. On the voyage up the brig T. W. Lucas was sighted about 15 miles off Port Orford, flying a signal of distress. She was 21 days out from the Sound loaded with piling for San Francisco. The Lucas is a very old vessel and encountering the severe southeast gale which has been blowing for the last week, she could not stand the strain and very promptly filling with water was kept afloat only by the buoyancy of the timber with which she was loaded. Capt. Patton took the crew of seven men on board the Homer and the brig was abandoned and is doubtless piled up on the beach by this time.

Sunday morning the first pile was driven for a forty foot extension on the south end of the O. P. company to be used for loading stone onto the government scows.

Friday evening a social party was given in the school room by the students of the Institute. It was an informal meeting, there being no set program. All were left to enjoy themselves in lively games, music and social chat according to their own sweet wills. The room was filled to overflowing. All were pleased and enjoyed themselves to the fullest extent. Yes, all things considered, down the beach is the best place for a life saving station.
