It relates a story of abuse and wrong done his wife and family by Henderson. The general impression here, and so far as we can learn at the Summit, is that Henderson has met his death in the mountains.

At the coroner's inquest held up on the remains of Wm. A special telegram to the LEADER at 11 o'clock today states that no trace of Pryor Scott has been discovered. The river has been dragged with no result.

Rev. F. J. Strayer, of Hillsboro, is in Toledo. Mr. Strayer is the owner of considerable Lincoln county real estate, and is looking after his interests here.

Word comes from Corvallis that Pryor Scott, an old time resident of Benton county is missing, and it is feared that he has committed suicide. He has been very despondent of late, having been much worried by financial troubles. His hat has been found on the river bank and it is confidently believed that he has met his death by drowning, either by accident or with suicidal intent. He has been missing from his home since Sunday last.

The government is doing considerable improving at the Cape Foulweather light house. Cement is being laid at the bottom of the walls, and tiling is being run around underneath the foundation. Some new cement, or grout, walks are being laid. Everything there has to be made good and solid or the wild winter winds would soon blow it all away. R. F. Storm on the Bay.

Last Sunday the coast was visited by one of the severest wind-storms that has visited the coast for years. Reports come from the whole coast of damage done to shipping and wharves. On Yaquina Bay the storm was very severe. The wind blew from the southwest and the waves rolled mountain high. The tide of Sunday was the highest that has been known for years. At Newport the average tide is about six or seven feet, but the tide of Sunday was said to have risen thirteen feet. Considerable damage was done to the wharves and bulkheads, both at Newport and Yaquina. It began to look for a while as though the long expected tidal wave had come. The extremely high tide was caused by the strong southwest wind piling the water up. The bar at the mouth of the Bay was in an extremely rough condition, and has continued so since Monday. The South Coast, which was due a week ago, is still out. The South Coast would stand in during the day, but at night would put to sea. The bar for a mile out has been a solid mass of foam. Dispatches tell of a schooner going to pieces on the rocks near Tillamook. The storm was a very severe one and the seafaring people do not want to see it repeated.

HENDERSON FOUND.

The body found in the Woods about six miles from Home.

(Special to the LEADER.)
Summit, Or., Nov. 12, 1894.—

The body of John Henderson, the man who has been lost for several days was found by Frank Yantis about six miles southwest of Summit, in Lincoln county, today. It was found at a place where they sometimes take stand for deer. It is supposed at this time that he came to his death by an accidental discharge of his own gun. The body was found lying across his gun and in the gun was a discharged shell. His hat and jumper were lying by him. The body is quite badly decomposed, though there were no marks of any wild animals on it. The finder did not disturb the body, or other articles, but at once notified the authorities at Toledo. The general supposition is that his death was accidental, as it is not known of anyone having a grudge against him. It was not ascertained in what part of his body he was shot. His wife was notified of the finding of the body to-day.

It is about three weeks since Henderson was lost. He took his gun and started deer hunting and never returned. Dr. Carter, the county coroner, has gone to the Summit to-day and will hold an inquest over the remains.

Prof. Bether's school will give a public school entertainment on the evening of December 22nd. It will consist of musical and literary exercises. The program will be published next week.

The California potato market has again taken a slump, but it is thought to be only temporary. There is an undoubted shortage in the potato crop on the coast, particularly in California, and it is thought that potatoes will be a fair price by February 1st. At the present prices it does not pay to ship.

Yesterday there were two parties from Drift creek appeared at the county clerk's office and tried to file on the same piece of government land. Clerk Jones did not think himself thoroughly advised in the matter and refused both filings. Both parties will appear before the clerk with witnesses next Friday and again submit the matter.

A correspondent of the Roseburg Review tells an interesting story about a herd of wild cattle now roaming the mountains between Rogue river and the south fork of the Umpqua. Such a herd has existed, he says, for 20 years past, and now numbers in the neighborhood of 500 cattle. They are wild as deer and difficult of approach. The practical harm they work is that gentle cattle belonging to farmers are killed off and join this wild band. It is proposed now to round them up and kill them, if some equitable agreement can be reached as to the ownership of the recent additions and the disposition of the remainder.
