The steam schooner Chilcat came into the Bay Sunday and discharged a part of her cargo at Newport. Some of the goods discharged were for Toledo merchants, and they tried to get the Richardson to bring them up, but failing in this a scow was sent down after them. Owing to the stormy weather the scow had time getting up with its cargo.

A branch of the Labor Exchange organization was formed at this place on Monday last. The officers are, Otto O. Krogstad, president; Wm. Enos, vice president; T. P. Fish, accountant and manager; J. W. Parrish, secretary, and Wm. Brazelton, treasurer. More than 30 members have joined, including men of all professions and standing. A Portland firm has a crude notion of Benton county finances. A county warrant was issued to them last January and some time ago they wrote County Treasurer Buchanan, asking when it would be paid. As the county is just now paying off warrants issued more than four years ago, the treasurer is unable to answer with any degree of accuracy.—Times.

Comparisons are sometimes odious but we could not help making comparisons when the recent prize fight occurred. All the time the legislature was hanging fire at Salem our people were deeply interested, and whenever there was a rumor that an extra move of some kind was made or even contemplated, there would be a rush for the daily papers when the train came in that evening, but never at any time did the rush anywhere near equal that made for the papers that contained an account of the Corbett-Fitzsimmons fight. In this latter case the interest ran so high that an order for papers to be reserved was telegraphed ahead to the news agents.

The record at Portland for twenty-three consecutive years shows that March has a daily average rainfall of .189 of an inch. That on March 21, for the same number of years, the daily average for that day was .12 of an inch; that for the five days previous to March 21, the daily average was .089 of an inch, and for the five days after the daily average rainfall was .141 of an inch which is .048 of an inch below the daily average for the month. If unusual weather condition prevailed about the equinox, does it not appear reasonable to assume that such would be shown by twenty-three years' record, and that more rain would be shown within the eleven days than during the other twenty days of the month? The record shows less rain than the average during this period, hence the conclusion that there is no credence to be placed in the old legend.—U. S. Weather Report.

One Slip.

Just now the papers of the state are poking the Oregonian about a semi-obscene advertisement that appeared in its columns last Thursday. That the advertisement was one that should not have been allowed to appear is beyond doubt, but it is equally certain the management of the Oregonian knew nothing of the nature of the objectionable matter until it was too late. It is but fair to the Oregonian to say that as a clean newspaper it is absolutely in the first ranks of the papers of the whole country. While we do not admire nor agree with the methods of the paper in its politics, yet in the character and amount of matter published the paper ranks high. That it has made one slip should not be held against it, for it is very likely that the deepest regret is felt in the office over it.

Seeds From Far-Off Lands.

Much interest attaches to a collection of seeds just received for experimental purposes at the Oregon experiment station. They are seeds of grasses and plants, and some of the varieties came all the way from far-off Persia. Others are from Australia, still others are from remote islands of the sea, while the remainder were gathered in China, Japan, Africa, South America and other foreign countries. The seeds are to be planted on the college farm in the hope of discovering in the plants and grasses they produce, forage plants or grasses that will thrive in Oregon soil and sun, and add to the crops of stock foods already produced in the country.

The collection comprises 150 varieties, and was sent to the Oregon station by the bureau of agriculture at Washington. The collection is one of its kind sent out by the department, the others having been sent to nine other experiment stations in the country. The addition increases the number of plants and grasses under observation at the station this season to more than 200.

The seeds will be, at the proper time, planted on the college farm, under direction of Professor H. T. French, agriculturist. Notes will be made, the characteristics of each plant will be watched, and in due time a report will be made. Each growing plant will be labeled, and the visitor to the station plats will be able to see in Oregon soil some of the strange herbage of distant climes.

Professor French has recently forwarded to the department at Washington sample seeds of the wild pea, wild vetches and various varieties of wild clover, all of which are of little use in this country; but which domesticated under other soil and climatic conditions, may develop into valuable forage plants.—Albany Herald.
