

OREGON'S UNION TICKET.

The Silver Knight-Watchman, published at Washington, D. C., and edited by Senator Wm. M. Stewart, pass the following compliment upon the Union party in Oregon and the ticket nominated by the silver forces:

"No better ticket could have been nominated in any state. It is first class from top to bottom. We wish to call especial attention to the candidates for congressmen. R. M. Veatch has been a life long democrat. We notice in the Eastern press that he is charged with being a gold-bug democrat. We know the charge to be false. We have been in correspondence with him for the last year or more and know his views. He is for the free and unlimited coinage of silver and gold at the ratio of 16 to 1 by the United States acting independently without regard to the action of any other government. Not only this, but he is an enthusiastic worker in the good cause, and if elected would be a credit to his state in the halls of congress. He would be an American, and not a follower of the English Tory goldites of the Cleveland republican stripe.

"Mr. Donaldson is a silver republican. He has made sacrifices in leaving the republican party to serve his country. There is no class of men so bitterly hated by gold monopolists as silver republicans who have been compelled to choose between the gold standard and patriotism, and have taken the side of the people. The silver republican who stays in the republican party and votes to keep the gold party in power is a very different individual from a silver republican who has come out of the party and is doing what he can to overthrow gold monopoly. An intelligent silver republican in the republican party is certainly a rare bird. To vote for gold men and talk for silver is too inconsistent to be honest. While there was any hope for bimetalism in the republican party many good men who were silver men stayed with it, but now that that hope is gone, and the republican party has become a gold party per se, no man can be a silver man and a republican. If he is a republican he is a gold man first, last and all the time, and any pretense on the part of the politician that he is a silver man while he supports the republican party is a sham and a disgrace.

"Again we congratulate the people of Oregon on the patriotic stand they have set for the other states. Three hundred millions of Hindoos were reduced to bondage and are now held in slavery by a handful of British soldiers, because they were divided into castes, and the cunning of the enemy compelled them to fight each other. Thank God! there are no Hindoos in Oregon. They will not fight each other in the face of the common enemy for the benefit of the Rothchilds combination. They will not sacrifice patriotism for former political differences, nor for the patronage of filthy lucre offered them by the money trust, but will stand united in defense of the rights of the people."

We will admit that there are some kinds of economy practiced by the present county court. For instance they economized by cutting a bill of Jack Prantz's for guarding the vault when the county had the railroad money therein. It was agreed to pay Mr. Prantz \$2.00 per night for guarding the \$16,000, but the court economized by cutting it in two. They allowed their own bills in full, however, and all the extra mileage usually allowed.

An Associated Press dispatch to the Gregorian says:

One of the interesting things in the outfitting of the Manila expedition has been announced. The government has purchased 250,000 Mexican silver dollars, which General Merritt will take along to defray the expenses of the expedition. This will not be enough, but more will be sent from time to time.

By purchasing Mexican dollars, a great saving is made. It is possible to obtain Mexican dollars at 45 cents each. In other words Uncle Sam was able to buy 250,000 of them for \$112,500. They were bought in San Francisco. In the Philippines a Mexican dollar is worth more than an American dollar.

Will some of our gold standard friends explain to us why a measly, scrawny, 46-cent Mexican dollar should be worth more than a bright, new, solid American dollar with a gold standard behind it. One of the strongest arguments for a gold standard is to make a dollar good the world over, and yet we find that they are not as good as a free silver Mexican dollar in some parts of the world.

It would appear, after all, that we have only cheapened our own money by the unconstitutional discrimination against silver.

The last issue of the Corvallis Union discards the truth, and says:

When Lincoln county voters cast their ballots for judge and commissioner don't lose sight of the fact that the current receipts of the county are in excess of the expenses, and that county warrants which two years ago went upon the market begging at 85, 90 cents are now eagerly sought at 98 cents on the dollar. This is not politics. This is business, and it is the business of the county that needs your closest attention. A vote for the republican candidates means a vote for a good business like administration of county affairs.

In the above the Union makes two absolutely false statements, either through ignorance or maliciousness. In the first place the books and records of the county show that the expenses of the county since August, 1896, have exceeded the receipts by nearly \$8,000 and we defy the Union to prove the contrary by any public record of the county. It may be that the doctored expert's report will show a different aspect in county affairs, but as this report was made for purely political purposes, and has never been made a public record, but is supposed to have been carried around by the county judge in his little red leather grip, the people have no confidence in it. The books and records will prove the statement of the Union to be false.

As for the price of county warrants, they were selling at 95 cents, when Lord appointed Mr. Stearns judge contrary to the expressed wish of two-thirds of the people of the county. Since then they have

raised to 98 cents. During the same period Benton county's warrants raised from 93 cents to 1 per cent premium, and we suppose that Judge Stearns is entitled to credit for that, also.

It would seem to us, however, that by the time that the editor of the Union puts up his own political fences and takes care of his own local ticket, that he will have a plenty to keep him busy until after the election.

SUPREME COURT DECISION.

The case of Sears vs. Kincaid appealed from Judge Hewett to the supreme court, has been decided. Justice Bean rendering decision reversing the case. In the opinion, he has sustained Smith's motion to dismiss and remanded the case to the circuit court. The opinion takes the position that by Hewett's action the court tries to compel Mr. Kincaid to do something that he has already done. As the tickets have been ordered printed by Secretary Kincaid, in the form adopted by him before Judge Hewett's order was made, the decision has no effect further than to show that Hewett made a partisan decision and a foolish break besides.

UNION WILL WIN.

The indications from all over the state is now, on the eve of the battle that the entire Union ticket will be elected from governor down. The hard fight on the state ticket has been made on governor and the chances seem to be all in favor of Will King. In the first congressional district there seems to be no possible doubt of Veatch's election. In fact several very conservative politicians have estimated Mr. Veatch's majority at not less than 5,000. It is thought by close political observers that Donaldson's majority in the second district will be in excess of that estimated for Veatch.

In the race for judge and prosecuting attorney in this district the Union candidates seem to have largely the best of it. Judge Hamilton and Henry Deninger, have made an active, clean canvas and it will be undoubtedly a successful one. These men will make excellent officers.

In the county campaign the result will very probably be the same. The chances seem to be largely in favor of the Union candidates. The campaign has been conducted by them on liberal and honest lines, and the character of the man on the ticket inspires the confidence of the people. The Union ticket seems to be a winner this year.

It is given out in Portland that Graham Glass, Jr., will get the position of private secretary for Mr. Geer, should he be elected governor. This will be a sweet dose for the decent republicans of the state to swallow. No longer ago than the last session of the legislature Glass was a red-hot democrat, and was a candidate four years ago for the nomination for state printer at the hands of the democratic convention. It will fill the souls of all honest partisans with unction to see Joe Simon's sack-holder at the right hand of the governor, should Mr. Geer be elected.
