It is the unanimous sentiment of the taxpayers and residents of the county that the Court should order a cruise made at the coming term of court, as is evidenced by the many petitions filed, and the Court being simply the agents of the people we believe should and will consider their wishes, especially when there will not be a dissenting voice against the proposition, unless there should be Brother Matthews of the Newport some timber syndicates or t'ei, agents, who desire to avoid their propertien of taxation. We do not believe Lincoln county has any such, as far as our acquaintance go we believe our timber dealers all to be fair men, not seeking to avoil any just assessments to the detriment of Lincoln county.
