In the matter of the Local Option liquor election: It duly appears friends for their past patronage, and to the court that in the following named election precincts in said county, namely, Alsea, Beaver Creek, Five Rivers, Big Elk, Elk City, Little Elk, Nashville, Tidewater and Toledo, the majority of the votes cast at said election on the first day of June 1908, in each of said election precincts were in favor of prohibiting the sale of intoxicating liquors in each of said election precincts.
