SHERIFF'S NOTICE OF DELINQUENT TAXES, 1910.

Complying with Chapter 275 of the General Session Laws, enacted by the State Legislature at the 1911 session, notice is hereby given that any time after the first Monday in October, 1911, Certificates of Delinquency may be issued upon any of the following described parcels of real property remaining delinquent. Taxes will be due in the amounts set opposite each parcel of property plus penalty of ten per cent and interest at the rate of twelve per cent per annum from the first Monday in April, 1911, to which will also be added the cost of advertising. Certificates of Delinquency draw interest from date of issuance until redeemed at the rate of fifteen per cent per annum.
