The state-wide movement to interest pupils of the public schools in gardening and poultry raising is to receive the support and encouragement of the leading officials of the Portland school system and of thirty-five principals of city schools. In addition, President Kerr of the Oregon Agricultural College, has pledged the support of that institution. It will have bulletins distributed to the principals, teachers and pupils of the schools. Officials of the Portland Y. M. C. A. reported that last season more than 300 gardens were planted by the school children of Portland, most of them in the back yards of the thickly settled sections of the city. The interest in the movement this year will result in a great increase over the number of gardens planted in 1911.
