Regulatory commissions will learn to have more respect for these properties and radical action will be minimized.


WOULD CHANGE

LEGISLATION

Salem, Oregon, Jan. 16, 1917. To the Editor:

Supposedly free American workmen, on their way to shops where they are employed upon terms and conditions which are satisfactory to them, are beset and intimidated by crowds of pickets representing organiza-tions which are called strikes. These crowds gather around the entrances to the shops, and although they perpetrate little violence while police are in sight, they terrorize the workmen by menacing gestures and degrad-ing imprecations. This is the situation today in Portland at the steel ship-building plants.

A slight amendment to Oregon's picketing law would prevent such terrorizing and threatening demonstrations on the ening demonstrations on the public streets adjacent to plants where strikes have been declar-ed; it would also prevent pickets from gathering in front of a store or restaurant in crowds, with banners, doing everything to ruin the shop-keepers busi-ness by intimidating his patrons ness by intimidating his patrons line to Crane, 127 miles, Cal. &
