COMMUNITY CO-OPERATION

Any American farmer who is worthy of the name likes to be associated with a good, clean, up-to-date, enterprising business town as his postoffice and trading center. It's an asset to the farming community to have good churches, good schools, a good commercial club, and good business houses within easy reach. The growth and prosperity and service which such a town can render to its country neighbors depends much more largely upon the farmers themselves than they are apt to think. The more you trade with the town merchant the better stock he can keep. The more you help out the creamery or the cheese factory or the grain warehouse company or the grange or the farmers' union, or any other organization that is helping out the town and country alike, the better town you will have.

Your town is sure to have some sort of a moving picture show. It is far better that you should have a good, reputable movie than a low-class picture show. Farm fathers and mothers can exert a great influence in the matter of clean amusements in the town.

If the town has a public library, it can double its value and efficiency by the cooperation of the surrounding farming families.

If the business men of the town help out in the matter of good roads, why should not the farmers cooperate in town betterment?

The fact is that the rural town is a farming town and depends not only upon the production of the farms within its territory for its own success, but this rural is of itself an index to the farmers who live within its territory.

Community cooperation, community development, means that the farm women join with the town women as members of the commercial club, as they do in Garfield, Whitman county, Wash.; it means a community cooperation in caring for and beautifying the local cemetery, as at Oakesdale, in the same county; it means that the town people unite with the farm people in the community clubhouse, as at Oroville, in Okanogan co., Wash.; it means that the farmers and the townspeople unite in an institution of the annual picnic, as on the irrigation project a few miles out of Caldwell, Idaho; it means that the townspeople and the farm people unite in that marvelous institution, the children's fair, as at McMinnville, Ore.

Wherever you find the farmers cooperating with the townspeople you have a good town, and when you have a good town you are pretty sure to find good people living on the farms around that town. You can not build up a successful social life without community effort. Good stores, good churches, good schools, good roads, good farm organizations must have the cooperation of the farmers as well as of the townspeople themselves.—Oregon Farmer.

MAYOR'S PROCLAMATION

WHEREAS, The Common Council of the City of Toledo by its Ordinance No. 148 duly passed on the 11th day of June, 1917, and approved by the mayor on the same day, and thereafter duly posted as required by law, submitted to the legal voters of said city at a special election duly called and held in said city on the 13th day of August, 1917, a measure, the ballot title of which is as follows:

AN ACT to amend the charter of the City of Toledo, entitled, "An Act to incorporate the City of Toledo, Lincoln County, Oregon," filed in the office of the Secretary of State February 18, 1905, by adding thereto section 75 which said section provides for an issue of bonds in the sum of twelve thousand dollars (\$12,000) for procuring funds for making improvements to the city water system. And,

WHEREAS, The Common Council of the City of Toledo

by its Ordinance No. 149 duly passed on the 11th day of June, 1917, and approved by the mayor on the same date, and thereafter duly posted as required by law, submitted to the legal voters of said city at said special election held in said city on the 13th day of August 1917, a measure, the ballot title of which is as follows:

AN ACT to amend the charter of the City of Toledo entitled "An Act to incorporate the City of Toledo, Lincoln County, Oregon," filed in the office of the Secretary of State February 18, 1905, by adding thereto section 76 which provides for an issue of bonds in a sum not to exceed nine thousand dollars (\$9,000) for funding the outstanding warrant indebtedness of said city and validating said indebtedness. And,

WHEREAS, The Common Council of the City of Toledo by its Ordinance No. 150 duly passed on the 11th day of June 1917, and approved by the mayor on said date, and thereafter duly posted as by law required, submitted to the legal voters of said city at said special election held in said city on the 13th day of August 1917, a measure, the ballot title of which is as follows:

AN ACT to amend the charter of the City of Toledo entitled "An Act to incorporate the City of Toledo, Lincoln County, Oregon," filed in the office of the Secretary of State February 18, 1905, by adding thereto section 77 which provides for an issue of bonds in the sum of six thousand dollars (\$6,000) to refund a like amount of Water Bonds now redeemable heretofore issued to Toledo Water & Electric Light Company. And,

WHEREAS said election was duly and legally held and the returns thereof duly and legally made and canvassed, and said election, as shown by the returns thereof and the canvass of said returns, the vote upon the three measures above set was as follows:

Whole number of votes cast, 80 for first measure; 80 for second measure; 76 for the third measure. Number of votes cast in favor of the first measure 64; for the second measure 63; for the third measure 54. Number of votes cast against the adoption of the first measure 16; second measure 17; third measure 22. And,

WHEREAS said measure and each of them were approved by a majority of the legal voters of said city voting thereon at said election,

NOW THEREFORE, I, R. D. Burgess, the duly elected, qualified and acting Mayor of the City of Toledo, do by this proclamation declare the result of said election as hereinbefore stated, and that the said measures, and each of them, the ballot titles of which are as above set out, were approved by a majority of the votes cast thereon and each of them at said election and do accordingly hereby declare said measures and each of them to be in full force and effect as a part of the Charter of said City of Toledo from the date of this proclamation.

SUNSHINE AFTER CLOUDS

The members of all homes have their little differences now and then. But after a time the clouds are cast aside and the make-up adds a new and dearer strand to the love-cord that binds the members of the home together.

In a similar manner we work out the little neighborhood gangles, in the course of time, which divide its members into two factions and make them incapable for a while of seeing any good in each other. They call one another hard names, and dig up all the naughty acts and misdoings that have been buried away for years and give them a good airing. The unprincipled slanderers—the greatest social curse on earth—seize upon the opportunity to manufacture a few more—mostly out of whole cloth.

After letting their wrathful feelings hold sway for a time over their better selves, and usually good and fair judgement, and making the stranger, who comes among them, think the opposing faction a gang of lawless I. W. W.'s. They finally exhaust their unworthy anger and wake up some morning to find their level headed judgement staring them in the face. They come to the conclusion their

neighbors are the same big hearted, fair minded, good intentioned, quick tempered, impulsive sinners they always were; ever ready to apologize, forgive and forget when the contentions are soberly brought before them; in fact just like themselves. They think the more of each other, and pull together better than ever before for having had their little misunderstanding, and thereby getting better acquainted with one another. A common result is—they celebrate their reunion by planning and carrying out some scheme for the betterment of the neighborhood.

All during the spring months the Orton Methodist Sunday School aroused little neighborhood interest. Oft' times there were hardly sufficient scholars present to carry out the Sunday program. One week part of the members made up their minds they ought to move the Sunday School to the Upper Farm school house. They carried their point, leaving a wrathful feeling among the dissenting members, who proceeded the next Sunday to organize a Union Sunday School at the old stand. Of course a keen rivalry sprang up between the two schools to see which could gain the larger attendance—the members of each prophesying the complete downfall of the other. Of course at first the rivalry had a little of bitterness toward one another mingled with it. But time has, as usual, eroded the feeling away and a friendly rivalry which tends well to keep up the interest in both Sunday Schools has sprung up in its stead, and today instead of one little insignificant Sunday School with probably a dozen pupils present, they have two wide awake schools with a combined attendance of sixty to seventy scholars. Gangles that end in such a glorious manner are what we like to see in all communities. But of course we wouldn't start one and take our chances on its ending properly.

Sunday, August 5th, The Rev. Moore, elder of the Methodist Church preached at the Upper Farm school house. His sermon on the subject, "Faith", fairly glittered with gems of deep well worded thoughts that kept even the children interested from the beginning to the end. If the people of the surrounding country had had an inkling of what they were going to miss the building would not have held the crowd that would have been there.

The Union Sunday School at the Orton school house had the big attendance of thirty-seven pupils whose lusty voices in singing the hymns could be heard a mile away.

Next Sunday it is possible the Rev. Searies will preach at the Orton school house where the people always welcome him.
