

DELINQUENT TAX LIST FOR YEAR 1916

The following list of real property situated in Lincoln County, State of Oregon, is hereby advertised for delinquent taxes assessed for the year 1916. The advertisement is authorized by an act embodied in Chapter 266 of the General Laws of Oregon, as passed by the 1917 session of the legislative assembly.

The taxes on the following advertised list of real property became delinquent October 6, 1917, and are subject to a penalty of 5 per cent and interest at the rate of 12 per cent per annum until the said taxes shall have been paid.

Notice is hereby given that six months after the taxes charged against the following real property first became delinquent the Sheriff is required by law to issue certificates of delinquency against the said property for delinquent taxes. The said certificates of delinquency shall bear interest at the rate of 12 per cent per annum until the certificates are redeemed.

Any time after the expiration of three years from the first date of delinquency on any tax included in a certificate of delinquency, the holder of such certificate may cause summons to be served on the owner of the property described in the certificate, notifying the owner that he will apply to the Circuit Court of the county in which such property is situated for a decree foreclosing the lien against the property mentioned in such certificate.

The cost of publishing this notice will be added to and become a part of the penalty charged against each description, proportionately.
