## SILETZ

Miss Elizabeth Hope Haupt (pronounced Hop) claiming to be a missionary traveling in the interest of the Indians came to Siletz Friday and spoke in the M. E. Church in the evening to a good sized audience. She claimed to be traveling among the Indians of the different reservations gathering information and data to be published in newspapers and magazines and used in her lectures for the benefit of the redmen in their efforts to become citizens. She claims to be a teacher and was introduced by Superintendent E. L. Chalcraft, Mr. Chalcraft speaking of his own experience and work among the Indians for more than thirty years. Said the Indians had already attained a very high state of civilization, many of them in this county were large property owners and tax payers. He did not believe the Indians should be pampered and indulged in idleness any more than the white man but should manage his own affairs and make his way same as other people. This the younger generation can do with their education and knowledge of civilized life. Miss Hope prefaced her remarks by saying that Siletz was the best advertised and most talked of reservation in Oregon, Washington or California. She visited the homes of several of the Indian families and spoke of the neatness with which they were kept. She also took a number of photographs of their homes to be used in her work. She did not believe in the "Owl dance" as she calls the white dance at night as practiced by the white people. She thought it immoral and degrading and caused more trouble than any other kind of social enjoyment. Miss Haupt said the Indians should forget the past and look forward to a brighter and better future. The person of mixed blood should not be ashamed of it, neither should the boy or girl be ashamed of their parents because they were full blooded Indians. People are not judged so much by their color as by what they are—their character. Miss Haupt left Saturday to visit other reservations and continue her work among the Indians. She came most of the way up the coast from Crescent City on foot so she could visit the Indian homes along the way from Florence she walked all the way to Newport. She claims to be a member of the Episcopal Church and have letters of recommendation from that organization.

It is evident that a mistake was made in counting the blasts as they exploded, and one of the 300 pound charges of TNT had not gone off yet, and exploded just as the men arrived there.

## LINCOLN-TILLAMOOK ROAD ASSURED FACT

At the meeting of the State Highway Commission in Portland this week the matter of building a highway from Newkawa in Tillamook county to Salmon River in Lincoln county came on for consideration. County Judge Miller last evening received a telegram from State Engineer Nunn stating that the Commission had decided to go ahead with this project now, providing Lincoln county was still ready to do its share. Under the terms of agreement heretofore made out Lincoln county is to put up \$12,500, Tillamook county will put up a like amount, the state will put in \$25,000 and the Forest Service \$50,000, making \$129,000 in all.

Judge Miller assured the Highway Commission that Lincoln County is ready to put in its share.

This is good news for the residents of the north part of the county, as they will now have a gravel road connecting up with the paved road from Sheridan to Tillamook.
