Magnificent Site For Log Parthenon

One objection which has been advanced against bringing the Oregon building from the exposition to Ashland park is that no suitable site is available. Far from it. Lithia park offers a location so far superior to the present location of the Oregon building in the exposition grounds as to offer no comparison. At the fair the building is on level ground backing on the water front and having the entrance which is used by 90 per cent of the visitors, on a narrow driveway. It is set on one of the lowest portions of the grounds and has nothing behind it to set off the magnificent timber effect.

In Ashland a beautiful site is available in the great stretch between the Lithia drive and Granite street. The building could be set on this sloping eminence overlooking all of Ashland park. The timbered mountains behind would provide a magnificent and fitting background, there would be plenty of space on all sides for great slopes of shrubbery-dotted lawns without encroaching on the other park features. The building of giant logs would be in perfect harmony with the setting and a more suitable location does not exist anywhere.

Valley Pioneer Died at Medford

George H. Merriman, pioneer of the Rogue River valley, long a leader in republican politics, formerly postmaster of Medford, and one of the most widely known, popular and prominent of its citizens, died at his home in Medford after an illness of an hour, Saturday evening, November 6. He had spent the evening attending to business matters down town and his sudden death came as a shock to the community. The deceased is a brother of Mrs. L. A. Harvey of Ashland and well known locally.

Mr. Merriman was 60 years of age, being born September 16, 1855, in Douglas county, coming to the Rogue River valley when a child two years of age. He resided here continuously since, with the exception of three years spent in Oakland, Ore.

In 1877 Mr. Merriman married Miss Mary E. Murray, who survives him, with seven children, Thos. T., George H. Jr., Sharon C., Mrs. Robert W. Telfer, Mrs. Claude Miles, Miss Mollie and Miss Vera Merriman.

Mr. Merriman was the son of William H. and Mrs. Artie Merriman, who left the east for Oregon in 1851, first settling in Douglas county and coming to the Rogue River valley in 1857. His mother, who celebrated her 85th birthday last month, survives him, residing with her daughter, Mrs. S. L. Bennett. Twelve brothers and sisters survive him.

The funeral was held Tuesday in Medford under the auspices of the Medford lodge B. P. O. E., of which he was a member.

DEPOT DOINGS.

A big Chicago & Northwestern freight car standing on the siding near the Sixth street crossing in Grants Pass was badly wrecked when a helper engine being driven by Engineer Orme of that city collided with it late Friday night. The car was standing in the shadows and was unseen by the approaching engineer, who thought the way was clear and who struck it a heavy jolt. The ground was strewn with broken bolts and the car was nearly knocked from its trucks. It was loaded with merchandise, the most of it billed through to points in the north, and while no great injury was done to the contents, it looked as though a cyclone had struck it.

County Will Sell Tax Certificates

At a recent meeting of the county court the sheriff was instructed to proceed with the sale of delinquent tax certificates against the O. & C. railroad grant land. The court has received legal advice from the attorney general to the effect that the land is liable for the taxes, now two years delinquent, and the same course will be followed as with other property, the United States supreme court having decided that the land belongs to the railroad.

Taxes and penalties on the 400,000 and over acres of land in the O. & C. grant in Jackson county now total \$170,000, and the lack of this money has badly crippled the county financially. Efforts to induce the railroad to settle have come to naught, and it is evident that the railroad is awaiting congressional action, hoping thereby to avoid payment.

However, the land is liable for the taxes, whoever the owner, and delinquent certificates will be issued on demand.
