

EX-SECRETARY SHERMAN DEAD

Great Republican Statesman Suffered From Brain Exhaustion.

SEVENTY-SEVEN YEARS OLD

Funeral Services Will Be Held at Washington and at Mansfield, Ohio, His Home, Where Interment Will Take Place.

WASHINGTON, Oct. 22.—Hon. John Sherman, who for a period of 40 years occupied a prominent place in the legislative and administrative branches of public affairs in the United States, died here at 6:45 o'clock this morning, of brain exhaustion.

Death came to the aged sufferer peacefully, after almost thirty-six hours of nearly complete unconsciousness. During the last fifteen hours of his life he was all the time unconscious and passed away while in this condition.

A number of relatives and friends who have assembled in Washington in response to summons were at the bedside when the end came. The most devoted of them was Mrs. McCallum, the adopted daughter of the secretary and Mrs. Sherman, who remained constantly at the bedside during the last hours.

Funeral services over the remains will be held in this city and Mansfield, the Ohio home, where the secretary and Mrs. Sherman spent so many of their summers. Interment will be in the family lot at that place and will occur in all probability on Thursday, the remains lying in state in the Episcopal church at Mansfield for about a day preceding the funeral services.

Brief services also will be held Tuesday and the body taken to Mansfield on a train leaving this city that night. The details are necessarily incomplete but are of the general nature of those stated.

[Hon. John Sherman was born at Lancaster, Ohio, May 10, 1823; academically educated; studied law and admitted to the bar, May 11, 1844; delegate to Whig national conventions, 1848 and 1852; president of the first Republican convention in Ohio, 1856; elected to 34th, 35th, 36th and 37th congresses; elected to United States senate, March, 1881; re-elected, 1886 and 1892; appointed secretary of treasury by President Hayes, March 3, 1881; distinguished for advocacy of resumption and success in refunding United States debt; re-elected to senate for term beginning March 4, 1891, and again in 1896 and 1899; chairman of committee on foreign relations and member of other important senate committees.]

WASHINGTON, Oct. 22.—Out of respect to the memory of John Sherman, who died this morning, President McKinley issued the following:

"In fitting expression of the sense of bereavement that afflicts the republic, I direct that on the day of the funeral the executive offices of the United States display the national flag at half mast and that our representatives in foreign countries shall pay in like manner appropriate respect for the illustrious dead for ten days."

The secretary was a large holder of real estate in this city. Conservative estimates of his wealth place it at a round million dollars.

FEDERAL GAME LAWS.

Government Wishes to Prevent Rather Than Punish Violations.

CHICAGO, Oct. 22.—There is a great deal of uncertainty among game dealers in this city as to the construction of the federal laws in reference to the handling of game from states where the shipping of game is prohibited. Thus far no seizures have been made under the Lacey act in Chicago.

To learn just what the government intended to do in this matter, a letter of inquiry was sent to Secretary Wilson, of the department of agriculture. Following is an extract from Secretary Wilson's reply:

"I am in receipt of your letter, of recent date, in which you request a statement as to the steps taken by this department to enforce the Lacey act. Since the majority of offenses against game laws are due simply to ignorance of the restrictions imposed for the protection of the game, our efforts thus far have been directed mainly toward preventing rather than prosecuting such violations.

"Our object has been to make the laws more generally known and to bring game protective associations into closer touch with one another.

"Although congress has thus far made no special appropriation to carry out the Lacey act, there is ample provision for dealing with violations which may arise under it."

The construction of this letter by the few game dealers in Chicago who have seen it is that the federal authorities are inclined to be lenient this season, but to sew up tight the shipments next season.

AMERICAN TOUTS ABROAD.

Turman Says They Caused Lord Durham's Criticism.

NEW YORK, Oct. 22.—Edward Corrigan, the Western turfman who has raced a stable of horses in England this year and has just returned, expresses himself as delighted with his experience at the English courses.

"During all my racing," he said, "I

never saw turf affairs so well conducted. British turfmen are admirable gentlemen, particularly anxious to be fair and their treatment of visiting turfmen is cordial to an extreme.

"Since my return I have heard that Lord Durham has made charges against American turfmen. Lord Durham is a good man who has the reputation of being considerable of a radical. I know just what is causing the trouble. A lot of American touts that were chased from the tracks of this country have invaded England. The sooner the English Jockey Club takes action against these fellows the better it will be for the turf interests everywhere.

"As for the American jockeys, I do not see what fault can be found with their work. They have been riding to win out and, to say the least, have been fairly successful. The Jockey Club is very strict and the boys have to govern themselves accordingly.

"It is not unlikely that in the future there will be more swerving than in the past, for the reason that the races are being run differently. Now it is racing all the way just as it is here, and in brushing flashes tired horses are likely to swerve more or less. But it will be obligatory upon the boys to keep their lines as nearly even as possible on tired horses and not permit their mounts to interfere with other horses and risk not only disqualification but suspension. I am glad it is so, because it makes racing clean and fair."

BIG POLITICAL RALLIES.

Spectacular Gatherings for Roosevelt and Bryan Are Planned.

NEW YORK, Oct. 22.—It is planned to make the reception by the league of Democratic clubs for Colonel Bryan, at Madison Square Garden next Saturday night, one of the most spectacular political gatherings ever held.

The general public will be admitted to the entire main floor. Five bands will play in the garden. Fifteen thousand electric lights will be used to illuminate the garden and Madison square park. The speakers will be Anson P. Stokes, chairman; ex-Senator Hill, W. Bourke Cochran, Colonel Bryan and Senator Wellington.

The Republican mass meeting in honor of Governor Roosevelt, in Madison Square Garden next Friday, promises to be picturesque. There will be a series of parades from almost every quarter of the city converging on Madison Square, and will be divided into 15 groups. With one group will be 700 Columbia college students marching in a body. Charles S. Fairchild, secretary of the treasury under President Cleveland, will be one of the speakers.

DAUGHTERS OF REVOLUTION.

Will Elect Mrs. Roosevelt or Mrs. Bryan President.

NEW YORK, Oct. 22.—Whilever way the presidential election goes may decide who is to be the next president general of the Daughters of the American Revolution, says a special from Washington to the Herald.

It has been decided by many of the leading members to ask either Mrs. Roosevelt or Mrs. Bryan to fill the position. Neither is at present a member of the organization but both are eligible and one of the board of managers has just made the statement that within the last week papers have been made out for the admission of both to the ranks of the Daughters.

If McKinley and Roosevelt are elected then the choice will fall upon Mrs. Roosevelt and if the Democrats win, the honor will be conferred upon Mrs. Bryan. The election will not take place until next February.

If both Mrs. Roosevelt and Mrs. Bryan should fall of election then Mrs. Donald McLean, of New York, comes in for third choice.

CHILE TOO AGGRESSIVE.

Argentine Papers Urge That the United States Should Not Tolerate It.

NEW YORK, Oct. 22.—A dispatch to the Herald from Buenos Ayres says: The Argentine press continues to condemn the Chilean reply to Bolivia as well as Chile's attitude toward the country. It is urged that the United States should not tolerate the aggressive policy of Chile.

JETTY COMPLETED.

Thirty Thousand Tons of Rock Used at San Diego.

SAN DIEGO, Cal., Oct. 22.—The United States government jetty at the entrance to this harbor has just been completed. About thirty thousand tons of rock from Coronado Island have been put into the work by the contractors.

SANTO DOMINGO PACIFIED.

Leading Revolutionists Prisoners and Everything Quiet.

NEW YORK, Oct. 22.—A dispatch to the Herald from Santo Domingo says: The whole country is pacified. The leading revolutionists are prisoners. They have submitted and the government is being conducted without trouble.

RUSSELL TO FIGHT CHOYNSKI.

Match Has Been Arranged for November 2 at Denver.

DENVER, Oct. 22.—Billy Edwards, manager for Fred Russell, the California heavyweight, has matched him with Joe Choyinski, the fight to take place in this city on November 2.

DOWIE MAKES A STIR.

Informa a Refractory London Audience That They Have Much to Learn From America.

NEW YORK, Oct. 22.—Dr. Dowie, says a London dispatch to the Herald, attempted to convince a refractory London audience in Holborn town hall that England had much to learn from America. They refused to listen, but noisily insisted his suggestions were neither Christianity or Zionism. Finally four men had to be ejected.

Before dismissing his audience Dr. Dowie stated that eighty-two skilled Nottingham lace workers would leave for Zion City, Ill., early in November.

"Secretary Gage," said he, "has instructed T. V. Powderly, commissioner of immigration, to keep hands off those pilgrims. He told me that Zion will be permitted to land all the imported labor it wants to."

With respect to this last statement a dispatch from Washington to the Herald says:

That Mr. Dowie can bring workmen into the United States under contract is true, so far as it applied to Nottingham lace workers. There is a provision in the alien contract law expressly permitting the bringing into the United States under contract of men who are skilled in an industry which is not established in the United States and which it is proposed to establish. Dr. Dowie told the officials of the treasury department that there were no men in the United States skilled in Nottingham lace work, and in order to enable him to establish the industry here he was authorized to bring men into the United States under contract.

SANDY HOOK OR NEWPORT.

Proposition to Have the International Race at the Latter Course.

NEW YORK, Oct. 22.—Since Sir Thomas Lipton's challenge, yachtsmen have resumed with new warmth the discussion as to the advisability of abandoning the historic course off Sandy Hook for the more breezy neighborhood of Newport. This question will, of course, be settled behind closed doors at a joint conference of the cup committee of the New York Yacht Club and a special committee of the Royal Yacht Club.

A course off Newport presents many advantages. Good sailing breezes are to be had in those waters almost any day and Bristol not far from Newport, where the Herreshoff shops are, affords every opportunity for quick repair of damages. But there is a very serious drawback. The stiff breezes off Newport often bring fogs which preclude racing. Moreover, racing on the Sandy Hook course means many more spectators than would be the case off Newport. Those conditions make it more than likely the old course will be chosen.

CABINET RUMORS.

Mongers Now Declare That Salisbury Cannot Be Spared.

NEW YORK, Oct. 22.—Lord Salisbury's success in making terms with Germany and interfering in the Chinese negotiations with authority silences the talk about his retirement from the foreign office, says the Tribune's London correspondent. The most industrious cabinet makers now admit that he cannot be spared from that office and that he must be allowed to hold it and the premiership as long as possible.

Lord Lansdowne is now relegated by the rumor mongers to Dublin. Lord Balfour, of Balfour, is named for the office, and Mr. Ritchie for the admiralty. Mr. Wyndham and Mr. Broderick are promoted to the cabinet. Each day produces a new combination from the friends of ambitious or restless statesmen.

BARTHOLDI'S STATUE.

Is in a Deplorable Condition and There Are No Funds for Repairs.

NEW YORK, Oct. 22.—The Journal and Advertiser says: Bartholdi's statue of Liberty on Bedloe's Island is in a deplorable condition and an expenditure of from \$75,000 to \$100,000 will be required to put it in proper repair. If these repairs are not made soon a much larger sum will be needed to keep it from falling into ruin.

The only reason for this deplorable condition of affairs is that there is no money for the use of the committee to whom is entrusted the proper care of the gift of the French republic.

Several efforts have been made in past years to have congress appropriate sufficient money to complete the pedestal and grounds but the bills have always been defeated.

METHODIST HOME MISSIONS.

Women Are Holding Anniversary Exercises in Chicago.

CHICAGO, Oct. 22.—The anniversary exercises of the Methodist Home Missionary Society were held last night. The principal features of the meetings were the address by the president, Mrs. C. B. Fisk, of New York, and the annual address by Mrs. T. J. Everett, of New Bedford, Mass. Mrs. B. L. Williams, corresponding secretary, gave an abstract of her report and Mrs. George H. Thompson, treasurer, submitted a report.

Mrs. J. M. Robinson, at the meeting of the Woman's Home Missionary Society that is being held in the South Park Avenue church, has raised \$12,000 to be used in the building of the Rush Memorial house at Washington. The money was subscribed by members of the organization and others.

AMERICA FAVORS THE AGREEMENT

(Continued from page one.)

Glenogle, which reached Tacoma last night, brings an interesting story of the flight of the empress dowager from Peking. The escape of the court furnishes one of the most entrancing stories of the Chinese campaign. The Shanghai Mercury tells the story as follows:

"It appears that in accordance with the regular practice of the Chinese officials in similar cases, false reports of supposititious victories, over the allies were persistently rendered to the palace with the result that the court was lulled into a feeling of fancied security and it was not until the allies had actually entered the capital that the real facts became known to the empress and a rude awakening took place.

"On the early morning of the 15th of August, the dowager, in company with the emperor, left the palace clothed in common Chinese cotton garments, traveling in an ordinary Chinese cart and accompanied by an insignificant retinue. Such was the hurry of their departure that no money or valuables of any quantity were taken with them and for several days the imperial party is said to have suffered the greatest hardship. The only food with which they were supplied was the common millet of the country and at night they had to sleep in wayside inns on the rough brick kang furnished for the accommodation of travelers.

Among those who accompanied the court were Prince Tuan, Kang Yi and Wang Wen Shao, and it is said that the empress, feeling sympathy with the latter, on account of his age, urged him to return to his residence at the capital, but the old man begged with tears to be allowed to share in the exile of the court.

"The humiliating effect of this experience upon the proud Manchus can better be imagined than described, and it has evidently inspired a desire for vengeance, as is indicated in the secret orders sent to Li Hung Chang for the recapture of Tien Tsin and Peking as well as the tone of recent edicts.

"In the light of the above, the account given by the Sin Wen Pao of the reported disgrace of Prince Tuan, with reference to the discomforts attending the flight from Peking, gains some circumstantial evidence of its accuracy and the fact that the same paper, in its issue of this morning, again refers to the empress' displeasure with the prince adds further weight to its previous statement."

RETURNING MISSIONARIES.

TACOMA, Oct. 22.—Among the cabin passengers on the Oriental liner Glenogle, which arrived in port last evening, were Miss Maude Hancock, of Washington, D. C., Miss M. Worthingham, of Baltimore, Miss R. C. Arnett, of London, England, missionaries of the English-Chinese Inland Mission, province of Szechuan, in extreme northwestern China.

They left Szechuan in August, being warned out by the viceroys before an uprising occurred in the province. They were eighteen days at Tien Tsin and were on a boat ready to leave when the bombardment of Tien Tsin took place, lasting six and one-half hours. During part of which time their boat was under fire. They believe in the future of China, if placed under a strong, righteous government. They do not believe in either Li Hung Chang or the empress dowager, neither of whom they think can be trusted.

BANK ROBBERY AT UNION.

Robbers Secured Three Thousand Dollars From the First National Bank.

UNION, Ore., Oct. 22.—The First National Bank was blown open this morning between 2 and 3 o'clock. The vault was blown open by nitro-glycerine and broken particles passed through the front of the building.

The robbers then appeared to have attempted to pry open the same but fled on the approach of citizens who had sounded the fire alarm.

No arrests were made, though the men were seen walking away. The loss is about three thousand dollars.

LIBERAL PARTY LEADER.

Sir Henry Campbell-Bannerman Not Radical Enough.

NEW YORK, Oct. 22.—The impending retirement of Sir Henry Campbell-Bannerman from the leadership of the Liberal party is foreshadowed, says the Tribune's London correspondent. He finds it almost impossible to be radical enough for the members of his party who give offense to the Roseberys. He will leave, it is said, unless he gets promise of better support than he received in the last parliament.

MCKINLEY AT CANTON.

Will Remain There Till He Casts His Vote.

WASHINGTON, Oct. 22.—President and Mrs. McKinley left tonight for Canton, Ohio, where they will remain until Mr. McKinley casts his vote on November 6.

INVENTOR DEAD.

All Railroad Brakes That Are Now in Use Are Patterned After His Invention.

NEW YORK, Oct. 22.—Henry Miller,

a neighbor of Horace Greeley, is dead at Chappaqua, N. Y., in his eightieth year. He was a son of Colonel Isaac Miller, the first mayor of Auburn, who was related by marriage to William H. Seward.

Mr. Miller came to Chappaqua forty years ago from Detroit. He was the inventor of the steam and air brake, his patent having been issued January 2, 1853, and all railroad brakes now in use, it is said, are patterned after his invention. The idea came to Mr. Miller after an accident near Norwalk, Conn., in 1835, and in the years 1846 and 1857 there were several successful trials of his brake on the New Haven and Michigan Central. They were witnessed by his friends, Horace Greeley, William Seward and other public men. A widow and three children survive him.

ROOSEVELT AND THE HOBBO.

Teddy Told Him He Had All the Symptoms of a Bryantite.

KINGSTON, N. Y., Oct. 22.—Governor Roosevelt finished the first day of his flying campaign through the state, in Kingston tonight, after traveling 89 miles and making eight speeches. At Newburg, the home of the Republican governor, he talked to a vast assemblage, having to speak in two places. Spectators interrupted the speaker with questions, in every instance receiving a reply.

At West Nyack, a man close to the ear cried and reiterated:

"Hurrah for Bryan," and Roosevelt replied: "Why don't you hurrah for Altgeld and Aguilado?"

The governor was interrupted a number of times by shouts of "What's the matter with Bryan?" "Down with the trusts."

Governor Roosevelt remarked: "That gentleman has all the symptoms of a Bryantite. You look like one of those men who work exclusively with their mouths. What do you mean to do with the cotton bale trust of Mr. Jones or the ice trust of Mr. Croker?"

"Cries of 'What's the matter with Bryan? He's all right.'"

"That is an argument of wind," said Roosevelt. "You are afraid to hear the truth. You interrupt this meeting because you are a hoodlum. You represent those people who not only object to prosperity, but who do not get any of it, because you won't work. Now go back to your fellow-hoboes and learn after this (more yelling and the man evidently turned to depart) that you stand against the flag. I am glad you are going away. I think you have learned enough hereafter not to monkey with the buzzsaw."

CAUGHT IN SEATTLE.

Thief Who Stole \$45,000 Worth of Jewelry in New York.

SEATTLE, Oct. 22.—Detectives today arrested in a down town hotel C. E. Matther, who is accused by several wholesale jewelry and diamond merchants of New York City of the theft of jewels valued at not less than \$45,000.

OUT OF COMMISSION.

Rear-Admiral Farquhar Shifts His Flag From the New York to the Kearsarge.

WASHINGTON, Oct. 22.—The cruiser New York has been ordered out of commission. Rear-Admiral Farquhar will shift his flag to the new battleship Kearsarge.

HANNA TO NEGRO TROOPS.

CHICAGO, Oct. 22.—A crowd of 3000 colored volunteers listened to an address tonight by Senator Hanna at the First regiment armory.
