Captain Goodale, in charge of the contracting quartermaster's department, visited Fort Stevens yesterday and inspected the barracks and fortifications. The new hospital at the fort will be occupied by the 1st Cavalry, and the remaining buildings will be turned over to the troops by Captain Goodale to the surgeon in charge.

Warden Van Dusen reports the following license collections for the month just ended: One hundred and twenty-one individual licenses, \$121; fifty-three gillnet licenses, \$12.50; seventeen net licenses, \$17; three trap licenses, \$45; five 1500-foot seine licenses, \$120; one 1500-foot seine license, \$11.80; four ten-foot seine licenses, \$11.80; total, \$667.30.

Advices from New York indicate that nothing definite regarding the formation of the Onfray combination of salmon packers will be made known until Wednesday, some of the coast packers having departed later than the Astoria canners. From messages received in this city, it is thought that all the negotiations have proceeded satisfactorily, and that the \$2,000,000 trust will soon be a reality.

The letter-carrier's excursion to Seaside Sunday was one of the most successful affairs of the kind ever held. In all there were thirty-three cars and each one was a success. The number of people who made the Seaside trip is estimated at 2100. The rough element was not in evidence, and the people who attended spent an enjoyable day, the weather being perfect. The excursion was run in three sections.

The light-house tender, Manzanita, Captain Gregory, returned Sunday from Portland, where she had been engaged. The tender has also been repaired and overhauled. Captain Gregory is now taking on a load of boxes and will leave Friday morning for Astoria and will return to Seaside Saturday night. He expects to be gone three weeks, and while away the Manzanita will visit all the stations in Southeastern Alaskan waters.

The Knappton Coal Company has commenced actual development work, and boring was begun yesterday. The stockholders are satisfied that there are rich coal deposits there, and look for good returns. From the examinations thus far made, it is thought the region will also prove a valuable oil field. The present operations will be of an extensive nature, and will give the company an accurate idea of the extent of the coal deposits.

At last night's meeting of the council Judge Gray appeared to ask the assistance of the city in the purchase of a rock crusher for road building purposes. Judge Gray explained that the city would have to contract a road to connect with the Nehalem highway, and that if city and county worked together in the matter, the purchase of the machine would be less expensive. The matter was discussed at length, but no definite action was taken.

The monthly report of Weather Observer Johnson shows that the precipitation was only 2.14 inches, or 19 inches below the average. Last year the rainfall for June was 6.80 inches. On June 15 the thermometer reached the highest point—76. A breeze which the coldest day was June 8, when the glass dropped to 42 degrees. Astorians sweltered when the glass was at 76, and from their uncomfortable experience in that hot day can get some suggestion of the condition of the people of Baltimore, who yesterday had a temperature of 101.

Great local interest is being taken in the Clatsop Fourth of July celebration, and hundreds of Astorians have signified their intention of visiting the "river town." Clatsop is leaving nothing undone to make the celebration a grand success, and has provided amply for the pleasure of the crowd from this city. The ball teams of the Elks and Foresters will add to the attraction with a ball game, which promises to be most interesting. Several excursion steamers will leave the city, but the boats and the time of departure have not yet been announced through the papers. For the account of the celebration, generally, it would appear that announcement should be made at once.

Trouble is brewing between the city of Astoria and the Oregon Telephone & Telegraph Company. The Scherneck ordinance imposing a quarterly license of 30 cents on the company for each telephone operated in the city became effective yesterday, but the telephone people neglected to call at the office of Auditor Nelson to settle the account. Miss Rouslow, local manager for the concern, states that she has received no instructions from the Portland headquarters of the company, and is unable to tell whether or not the company will pay the license. However, if it proposed submitting to the city, Superintendent Thatcher would doubtless have called at the office of the auditor yesterday to settle, and his failure to do so makes it clear that the company proposes fighting the ordinance. City Attorney Smith says he will institute suit against the company to compel payment of the tax, and that the papers will be filed some time during the present week. He is satisfied that the ordinance is up to all legal requirements, and expects that the courts will compel the company to pay the license.
