The body was turned over to Coroner Pohl and will be shipped to La Cienra, Washington, where the family of the deceased reside.

The Eagle's baseball team were beaten badly by the Elks in the game played Sunday at A. F. C. grounds, the final score being 21-7. Ross, Halderman and Grant were successively in the box for Eagles but before the run getting could be checked a lead had been piled up that could not be overtaken. Next Sunday the Elks and Foresters will try conclusions.

The fishing boat, owned by G. O. Jacobson was found floating down the river yesterday morning by a fisherman employed by the Trexco Company. It was towed in and turned over to Deputy Fish Warden Henry Bullman who subsequently found the owner. The boat had been securely moored in its accustomed place and it is thought that someone deliberately sent it adrift.

McCormick Lumber Company.

From the present outlook the completion of the Nehalem road will be an event of the far off future. Despite the fact that offers have been made to accept the entire issue of warrants at par a majority of the county court declines to authorize the construction of the road this year beyond the four-mile post. This will be a disappointment to the farmers of the Nehalem valley, who hoped that the commissioners would act upon the recommendation of the county surveyor, Mr. Astbury was of the opinion that the entire road could be made passable by straightening out and grading the worst places, leaving its ultimate completion to a time when plenty of funds would be available. Under Judge Gray's plan, as outlined to the court, the road would have been opened to Olney so that traffic could be carried on. There is a decided sentiment among residents along the proposed route that the work be rushed forward and some of the men who have been working on the road have gone so far in their enthusiasm as to offer to accept warrants for their pay and hold them without interest until such time as the country can pay.

The Tribune of Warrenton says: "Spore & Robinson, the Portland contractors who secured the contract for building the barracks at Fort Columbia, have thrown up the sponge and sublet the whole work to a Salem man by the name of Langdon. As they only had thirteen months to do the job and over a month has passed without any work being done, the government may yet have to finish the contract."

The well known shipping firm of Dodwell & Co. has retired from the Alaska and Puget sound shipping fields. The ocean going vessels formerly controlled by the firm plying between Seattle and the Orient have been sold to a committee representing the Northern Pacific railroad and the Pacific Coast Company will probably take over the others. The consideration for the transfer of the Oriental liners is reported to be in excess of \$1,000,000.

They had on weapons but a yoke, such as carriers sometimes use, but rushed toward him with that. HONORS FOR DR. GUE.

Tributes Paid the Memory of a Splendid and Sincere Churchman.

With impressive ceremony and in the presence of the clergy of the district which he had served as presiding elder, the remains of the Rev. George W. Gue were laid to rest Sunday afternoon in the Lone Fir cemetery in Portland. The services at the Centenary Methodist church, of which Dr. Gue was pastor when death came, were conducted by Bishop Cranston. On the platform were clergymen of Methodist churches in Oregon, and other denominations. The empty chair of the pastor stood on the altar, draped with an American flag and decorated with G. A. R. emblems. In front of the church was the casket, draped with flags from the G. A. R. posts. Guards of honor from the G. A. R. and from the Epworth League were present at the church during the services. There were over 1500 people in the church and outside were 200 more. Magnificent floral tributes from sorrowing friends and from organizations with which the deceased was affiliated were in the vestibules and on the grounds outside.

Bishop Cranston said in part: "This great company is significant of a greater fact. The human heart remains true to itself. When a man, so well known for integrity, largeness of spirit, and unbounded zeal, passes into the great beyond, the many who have been benefited by such a life resemble to express their sympathy. This is no chance gathering. We are all partners in this sorrow and all feel akin on occasions like these."

"I feel moved by the power of such a life. There was never a truer or braver heart than that which has ceased to beat. Knowing a long time of impending death, Dr. Gue never for a moment faltered in his work. He went steadily onward, cheerful, full of zeal and undiminished interest. His courage was sublime and his powers as a leader wonderful. It was this remarkable spirit of enthusiasm and optimism that led to his success."

Bishop Joyce also dwelt on the unusual personality of the minister, saying in part: "We are in the presence of a great sorrow. The shadows have fallen. Under them the range of vision is not wide nor the sight very plain. We wipe the tears away and look again. The world is not rich in such men as he was. Could I have had my wish I should have said, 'Live, live, live!' But the one mind, the mind omnipotent, that planned and built the universe, sees and can answer the question 'Why has our brother died?' It was never intended that the little space lying on this side of the cradle, should be the last of the masterfulness of a great life. This life is the drill ground, no place character is built and mind unfolded. All this means a journey in the end and when the gates are opened, pen there will come the regard for all this labor and toil."

"Early in life, Dr. Gue awoke to the fact that life was a mission. Life is not a time to play, to loiter and spend idly. Our departed friend thought it all too short for such levity as is, and lived that thought through to the end. In this man's record, the cheer with which he did his work showed him to be thoroughly in love with it. With him the Bible was a message of good news. I have never heard him express a word of doubt, fear or depression. He reached the gospel of good cheer. Another characteristic fact in his life was that he never bowed the seed of doubt in any instance; therefore, I do not wonder at his success. His presence was a magnetic one, inspiring cheer and hope. I felt this the first time I ever saw him. It was but the outward expression of a full, beautiful inner life."

Dr. G. C. Wieding, of New Jersey, and the Rev. P. A. Coal, of Spokane, also spoke. Mrs. Gue was ill and unable to be present at the services.

CANNERRIES AGAIN BLOCKED.

Unprecedented Run of Salmon Continues and Packers Need More Help.

The urgent need for additional help is still confronting the salmon packers, and because of the scarcity in this direction several of the canneries were again blocked yesterday while none of them could receive all the fish offered. At the Kinney cannery, of the Columbia River Packers' Association, the boats began to line up shortly after 6 a. m., and until late in the afternoon was a long line waiting a chance to discharge. The association is taking 400 pounds from the gill netters and a day from its own seine.

No great has been the rush that the traps owned by the association in Bakers bay have not been lifted for five days.

It was reported around the streets yesterday that four traps had either been broken because of too many fish or had been cut but no information had been received at the association's office regarding the matter and so there is telephone connection it is thought that the report is untrue or confirmation would have been given. The reports from Bakers bay and the lower and upper rivers would indicate that the fish in the present run are circling around in the river between Snag Island and Sand Island.

The Co-operative cannery called in their fishermen Sunday night and yesterday all hands were working in the cannery cleaning up the accumulated fish. At all the canneries women and children are working and there is employment for many others. The fish are all large, averaging thirty pounds and over and the belief is prevalent that the majority are hatchery fish.

The present large run is general all along the Pacific coast. The Rogue river canneries have started up after waiting in vain for fish earlier in the season. Private advice received yesterday from Fairhaven stated that the largest run of sockeyes ever known had entered the Sound and the fish are selling for three cents apiece. This means thirty cents a case for raw material and as the canning is all done by machinery the total cost is exceedingly small. It was reported, however, that in the haste to handle as much of the run as possible the work is being hurried to such a degree that a part of the pack will be considerably below the standard.

Considerable interest is manifested in the shipment of fresh fish to the canneries on the upper river, Seufert Bros. are buying fish here that local packers cannot handle at three cents a pound, and an average two carloads are being shipped daily to their cannery at The Dalles.

Refrigerator cars are scarce and many of the local packers do not believe that the fish will stand the long trip and be in condition to be packed. Shipments are also being made to the Warren and McGowan up river canneries.

Apparently the run has also reached Alaskan waters. Captain Walbran of the D. G. S. Quadra arrived at Nanaimo Friday from the north and reported the run of fish light in all northern waters. Just as the Quadra left, better returns were being had. Rivers inlet fishing has been a failure. Mr. Wadhams, of the Wadhams canneries, said his boats between Black Rock and Zero Rock were taking from two hundred to three hundred each. Fine runs also are reported at Bella Coola and Kimsquit, where the canneries have been operating eighteen months.
