The French bark Bourbaki arrived down the river yesterday, after a day's having expired, no doubt, and cleared for the United Kingdom. She takes 112,142 bushels of wheat, valued at \$67,000.

The steamer George H. Vonburg arrived yesterday from Tillamook, with a quantity of salmon and hides. The Elmore departed yesterday evening, after several unsuccessful attempts to get into Tillamook harbor.

Nancy D. Welch cabin, Native Daughters of Oregon, will give a reception in honor of the members of the Oregon Pioneer Association on Thursday evening, November 7, at Page hall. All pioneers are cordially invited to be in attendance.

The popular river steamer Bailey Gatzert is to be returned to the Astoria-Portland run. For several months she has been on the run to The Dalles, but the water has become so low in the upper river, that the Tahona, now on the lower river, will be substituted. The return of the Gatzert will be pleasing to Astorians.

The lightship tender Columbine returned to port yesterday, after delivering supplies to Puget Sound light stations. The Columbine also visited the Umatilla reef lightship on her return, and after starting for Astoria ran into a storm. Captain Richardson put back to Tillamook and remained there until Monday, when he proceeded to port. He reports a nasty trip.

Members of the committee appointed by President Van Dusen, of the Chamber of Commerce, to investigate the proposal submitted by F. D. Butler for the establishment of a saw and door factory here, left last night for Portland, to consult with the firm. On their return further information will be given out and a more definite proposal submitted to the people. It is now thought the enterprise will be secured for the city.

Frank McDaniel, convicted of the murder of Claire Fitch, in Cycle Park,

Portland, will probably be compelled to serve his full 15-year sentence in the penitentiary. His resources are exhausted and he will be unable to carry the case to the highest courts in the land, as was his original intention. In a letter to Henry B. Rayner, his counsel, McDaniel protests his innocence and asks that further legal steps be taken in his case.

There was great local interest last evening in the Eastern elections, and as is usual, The Astorian was repeatedly "rung up" for information as to the result. Yesterday even old Republicans conceded that Shepard would defeat Low for mayor of Greater New York, while the Democrats were confident of Tammany's ability to win out. Early in the evening, however, came Croker's concession that Low was elected, causing surprise among Democrats and Republicans alike. Interest locally seemed to center entirely in the New York election, little attention being paid to the contest in Ohio. There was some inquiry about the Maryland election, which an early bulletin announced was going for Gorman.

A special meeting of the Push Club was held last evening at the Commercial Club rooms, when the report of the committee chosen to sound sentiment as to the proposal to consolidate was presented. There were only two signatories in the column marked "No." After considerable discussion, President Gaston was authorized to take the necessary steps to incorporate the Push Club. After this is done, the park will be turned over to the Push Club by the trustees to be selected by the Push Club. In this manner there will be no possibility of losing the property through failure of payments. The club adjourned to meet November 15, the date of the regular meeting, when the plan of incorporation will be submitted. Last evening there were only eight or ten members in attendance, but it is hoped there will be a full representation at the next meeting.

John Doe, a well-known character, who has frequently come into flare-ups, had a peculiar experience before Police Judge Nelson yesterday afternoon. John was arrested Monday afternoon for drunkenness, but his case came up late for consideration that day. The man was released on bail after the facts of his case had been told, and it was expected that he would not appear in the police court yesterday, as he usually forgets his bail. But after being released, he again became soaked, and this time did not have the necessary five. He appeared in court to answer both charges, to which a plea of guilty was made. In passing sentence Judge Nelson suggested that, in view of the fact that Doe was arrested not less than 100 times yearly, it might save trouble if he would arrange at some future date to appear at one time to answer the prospective charges in bulk.

Astoria Council, Federation of Labor, met in regular session last evening. William Williams, F. Bauer and William Halyhouse, of the Carpenters' Un-

ion, and M. Huff, of the Machinists' Union, were admitted to membership. A communication from the steamboat engineers relative to the engineer on the Vanguard, was read and referred to Curtis Nelson and Adolph Johnson, with instructions to see Captain Haslam and request him to make a change. A communication from the National Metal Workers, stating that the Davis sewing machine was made by seam labor, was filed. A communication from the Bartenders' Union, stating that Fitzgerald, the Occident saloon and Stand-ard Concert Hall had been declared unfair, was read, and the action of the union endorsed, and the secretary instructed to notify all local unions. Communications from the Portland Council were read and filed. The teachers reported that several merchants had refused to allow non-union men to haul their freight. The local unions were instructed to notify their employers not to give freight to Miller, Deahy or Smith. Reports from all the local unions showed an increase in membership.

"Hunting for Hawkins," the new comic play which will be the attraction at Fishers' opera house next Monday, seems to have much to commend it to players. It has been accorded unanimous praise by critics who have reviewed the performance as a cleverly written play with an interesting plot, brimful of bright humorous dialogue, breezy action, laughable situations and an abundance of new music. Songs, dances and other pleasing vaudeville features presented by a large company of superior excellence. "Hunting for Hawkins" was written by Guy F. Steele, and is considered his best effort. The author claims his sole object was to create laughter, and that object has evidently been accomplished, as it is said to be one of the most emphatic laughing hits that has been presented for many years. The production was made under the direction of M. L. Hecker, to whose thorough knowledge of stage craft is to a great extent due the success of Willie Collier's latest plays, "Mr. Smooth," "On the Quiet," etc. "Hunting for Hawkins" is considered the biggest hit of any new production he has ever staged. The French bark Lamoriciere, Captain Christien, succeeded in making port yesterday, after a week's sojourn with the elements. Pilot Matthews was taken aboard several days ago, but was compelled to stand off. On Monday afternoon he had worked back to the river's mouth, and just as he was preparing to cross in the weather, which had been clear, suddenly clouded again, and the wind increased to the proportions of a gale. The pilot says Captain Christien alone could understand English, and when Captain Matthews' orders to shorten sail were given the men refused to understand the orders. In the blow that followed the main and foremast sails were carried away, with loud accompanying reports. Like the booming of cannon. Loss of the sails ended the ship, and she answered her helm nicely when the pilot stood off. The crew of the vessel seemed very

much alarmed for the safety of the ship and were much relieved when they found that the danger had passed. For a time, however, things looked pretty black, but the Lamoriciere, like nearly all French ships, was not only finely ballasted, but is a magnificent sailer as well, and readily answered the helm. The Lamoriciere comes from Hull and is owned by a Nantes bounty-earning firm. She is under charter to load grain.

Walter Stokes arrived in the city yesterday from Skagway, where, with his brother, Harold, he conducts the Pacific Hotel, one of the finest establishments of the kind in that part of the country. Mr. Stokes was originally interested at Dyea, where the firm did an immense business. He is one of the best-versed traders in Alaska, being thoroughly acquainted with the Yukon country, through which he has made many trips. Mr. Stokes reports an oil excitement at the head of Lynn canal, covering the Skagway and Dyea districts. Just before he left for Astoria, a number of Pennsylvania oilmen arrived to examine the discoveries, which give promise of being quite valuable. The Stokes brothers are largely interested in the Porcupine district, where they have several placer claims, located by Harold in 1899. Walter has great faith in the future of Skagway and all southeastern Alaska. When he determined to make his present trip he was serving on the United States petti jury, but was excused. Harold is now engaged in shipping frozen halibut into Dawson, where there is a ready market for the fish. Sam Holberg, formerly in business at Skagway, has retired and is now located at Puddington, this state. Mr. Stokes left last night for San Francisco, to visit at the home of his parents.

Property owners are making considerable complaint because of the action of the council in attempting to force extension of Astor street, and there is likely to be a strong remonstrance against the work. It is contended that the street will benefit only a few canneries, and that it will be of little benefit to the people. The canneries, it is pointed out, receive most of their goods by rail and water, and that Bond street is good enough for the traffic that must be done. It is also contended that the valuation of this property is not great enough to pay for the street. One tract of 268 feet of water-frontage, is assessed for only \$1700, while the cost of making the improvement cannot legally exceed 50 per cent of the valuation. It is said this condition of affairs will be found to exist throughout the improvement district. Owners of property on Astor say they offered to extend that thoroughfare when Bond street was put through, agreeing to defray all the expenses. The council refused to entertain the proposal. They believe Astor street should have been extended in the first place, but insist they should not be made to pay for an error made by a former council. The anti-improvement spirit, which seems to be based on logic, is quite strong, and it is believed the improvement will be defeated. As to extension of the car line, which must be made in order that the present franchise may not be rendered void, the property owners say they are not in any way opposed to it.
