The Norwegian ship Albatross cleared yesterday at Portland with 47,340 bushels of wheat, worth \$40,000. A large part of her cargo will be lightered down the river.

According to a Portland story, the American Cuo Company is negotiating for lease of the Wolff & Zwicker property, for the purpose of removing its Astoria plant there. It has been understood in this city that the local plant would not be removed from Astoria.

At the residence of Mrs. C. W. Fulton, on the afternoon and evening of November 22, the ladies of the Monday Club of the Presbyterian church will hold their annual tea and sale of fancy articles. Extensive preparations are being made for the event. The proceeds of the sale will be devoted to the church.

The Columbia river above Astoria is now at the lowest stage recorded for years. It is six inches below zero and only small draught vessels are able to navigate between Portland and Astoria. The Loyd Bros., which arrived down yesterday, made the trip with difficulty, and at that had only a partial cargo. 80 has on board 121,421 bushels of wheat, worth \$49,500, but 150 tons of wheat will be lightered down for her.
