MAKE THEM RESPONSIBLE.

Perhaps there is no one thing which demands correction more than the practice which seems to be growing of irresponsible and unstable business ventures being allowed to parade under the name of some well-known and responsible person for the sole purpose of establishing the confidence of the public in the stability of the institution. Every few weeks we hear of some venture going to the wall which numbers among its officers and directors men who had a reputation for probity and successful business acumen. Until failure comes the public are led to believe that these men are controlling the management of these enterprises. But when disaster befalls these wild-cat schemes and the victims of their mismanagement attempt to recover some of their losses from the men who have allowed their names to be used in order to inspire the confidence of these very people, they are met with the complacent statement that the only connection they had with the concern was the receipt of a certain stipulated amount monthly for the use of their names; that they have no other interest whatever in the concern, and are not responsible for any of its losses.

An interesting example of this comes from Grand Rapids, Mich., where a former bank president is on trial for aiding and abetting the making of false reports to the Controller of the Currency. This banker, on the stand to his own defense, declared that he was made president of the bank on the understanding that he was not to devote his time to it. So the business went on under him, using his name to win confidence, without his knowing anything about it and the false reports had been raised by him without any examination of the books to see that they were correct.

This is not a rare occurrence. Prominent men lend their names to banks, trust companies and insurance corporations of whose management they know nothing, and think that their ignorance excuses them if the institution is wrecked and people who confided in it because of their names are ruined.

We are far too lenient on this subject in this country, and there is need of copping the Germans, who have taught their business men the meaning of responsibility in connection with office in financial institutions. No man has any right to put his name on the list of a directors who does not to the full perform the duties of his office. He is not there to trust other people, though he may in his personal relations trust them. He is there to be the representative of the public, who do not know or trust them, to see with his own eyes that everything is right.

In his speech naming ex-Senator Davis, chairman of the American delegation, for president of the Pan-American congress, General Rafael Reyes, delegate of Columbia, said a high compliment to the United States. He said: "In offering the proposition which has just been read I feel sure that I have interpreted the wishes and sentiments of all the delegations of Latin-America. In tendering the office of president of the conference to the chairman of the United States delegation we are performing an act of courtesy in assigning the place of honor to the chief representative of the nation which has taken so important a part in convening both Pan-American conferences and which, if on no other ground than that of language, figures among all Latin-American nations here represented in the role of a guest."

In addition of this duty of courtesy, there are other reasons of great weight for the appointment which I have proposed, and among these reasons I may mention the fact that our several nations recognize the civilizing influence of the United States and the influence which they confidently believe will ever be exerted on behalf of their prosperity and welfare under the auspices

guarantee of independence, justice and liberty for all."

An American employee of the Congo Free State who has just returned to his country tells a tale of cruelty practiced by Belgian troops upon the natives in the rubber districts of that western which is hard to credit. According to his story 300 natives were killed in the first expedition of Major Lemaire commander of the Belgian troops, after a rubber. While a similar expedition commanded by a Belgian lieutenant, killed 300 natives in three weeks. He further declares that the so-called punitive expeditions are in reality rubber squeezing raids, conducted in such a way that the natives are in a constant state of revolt. While the conditions are somewhat improved in the territories worked by the concession companies, the lot of the natives in the state domain is far worse than before the advent of the whites. The natives are practically forced to work rubber at the muzzle of rifles, receiving 2 cents per pound for what is sold at 75 cents at Antwerp.

Thousands of natives have fled to the bushes, living like wild animals. Along the jungle paths the bodies of those who have died of starvation are frequent sights.

Bradstreet's report of bank clearances for the chief cities of the United States for the month of October show they exceeded the record for the same month of 1900 by \$1,000,000,000 or an increase of more than 25 per cent. This continued increasing in the volume of business transacted by the banks of the country is quite a different picture from that of bank suspensions during the last Democratic regime, and is assurance of the fact that the prosperity of the country is based upon a solid business foundation.

A report comes from Amsterdam that ex-President Kruger has outlined the peace terms which the Boers are willing to accept, as follows: First, amnesty for all rebels; second, the restoration of prisoners and the withdrawal of troops; third, compensation for burned farms; fourth, a convention providing autonomy for the Boer republics, which shall be guaranteed by France and Russia; fifth, the cession to England of the Witwatersrand gold fields, in lieu of Boer indemnity.

Some idea of the stupendous work before the Schley court of inquiry may be found when it is remembered that the records of the evidence contain more than one million words, comprising 2000 printed pages. It is very probable the first thought of the members of the court when they beheld the records stacked upon the tables in their private room was to execute a long and a retrograde movement.

It is really amusing to see the state with which our German friends are trying to devise methods to prevent American capitalists from securing control of many of their big institutions. They do not seem to learn from observation that when our financiers go gunning for game they always return with well filled bags.

It is safe to say the war dance our own "La Lolo" Fuller executed upon finding all her costly scenery ruined through the carelessness of the Berlin transfer company was a far more realistic and spectacular performance than her famous "fire dance" in which she is recognized supreme.

The King's coronation promises to be the stellar attraction of the season in England, and it is safe to presume our financial kings will be on hand and see that ample provision is made for a genuine American midway.

TELEGRAPHIC BRIEFS.

Colonel W. R. Wallace, one of the best known mining men in the West is dead at Whittier, Cal. He aided in opening the Comstock district in Northern Idaho and founded the town of Wallace.

The British ambassador to the Porte, the Right Hon. Sir Nicholas B. O'Connor, is energetically pressing the outstanding British claims. The ambassador's attitude intensifies the Yildiz Kiosk and the Porte.

It is believed that the Chilean cabinet crisis will end as once in nearly all of the ministers retaining their portfolios. The controversy between Argentina and Chile over the opening of pathways in the disputed territory will be amicably settled.

The scarcity of labor in Rhodesia is still a matter of great difficulty and one pressing for immediate solution. The dislike which is shown to the importation of Asiatic labor is being met by the experimental introduction of 2000

Arabs into the colony at the instance of Cecil Rhodes.

William Hooper, whose extradition was requested by the United States government because of charges of defalcation and forgery against him has sailed from Buenos Ayres on the British steamship Oropesa for Liverpool, whence he will sail for New York. He is accompanied by a detective.

James Bruce, said to be a notorious eastern crook was arrested just as he was boarding the transport Mead at San Francisco, bound for Manila, and lodged in the city prison. He will be held pending the arrival of a requisition from Chicago, where it is alleged he is wanted for participation in a diamond robbery.

Henry Fournier, who on Saturday broke all automobile records by going a mile in 31.4 seconds on the Ocean Parkway is far from being satisfied that the limit of automobile speed has been made. In fact, he says the automobile machine has just begun to demonstrate its power and declares next year he will make a mile in 22 seconds.

A dispatch from Melbourne to the London Times and the New York Times says the customs authorities, in pursuance of the provision of the customs regulations act, have sealed the stores of mail steamers at Sydney, in order to prevent the consumption of them while the vessels are in port or traveling between Australian ports. The company's agents will probably test the validity of the law by breaking the seals outside territorial limits.

The Rome correspondent of the London Times and New York Times says Signor Carcano, the finance minister has obtained the approval of the cabinet for a scheme to abolish the duties on bread, flour and other farm products. The scheme is more moderate than those drafted by Signor Carcano two years ago and by Signor Wolperting last spring. The communal losses would be compensated partly by the state and partly by increasing other forms of local taxation. The total cost of the state is estimated at about \$300,000 lire (\$1,544,000).

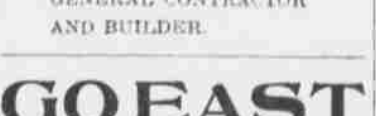
