Albany, N. Y., March 5 .- The democratic state convention, which will select delegates to the rational convention, will be held here April 18. This was the unanimous decision of the democratic state committee which met today. The result was arrived at before the committee met at a meeting between ex-Senator Hill and Leader Murphy, of Tammany. It was believed that some acrimony would result at the meeting over the selection of the place and time, it being known that Tammany desired to have it held in New York, but Senator Hill acceded to Murphy's request to set the date for the 18th instead of the 13th, and Murphy finding Hill controlled the majority of the committee, acquiesced in the selection of Albany.

COMMITTEE IS ARRAIGNED.

Irate Woman Speaks Her Mind on Disputed Grade.

Seattle, March 5 .- An irate woman, prepared to defend what she regarded as her rights, appeared before the street committee yesterday afternoon and gave variety to the otherwise monotonous proceedings. Chairman Mullen was vanquished early in the fray and before the end of the colloquy Councilman James selected a back scat and sat down. Engineer Jeffrey succumbed and Mrs. W. S. Ham's Shortage Is Large.

Boston, March 5 .- While the warrant, upon which the arrest of Wallace H. Ham was made, charges the embez ziement of \$194,000, it is understood the amount of the original shortage may grow to \$240,000, or even \$285,000. As learned from the New York officer in charge of the case, from that end the shortage of the American Surety Company may go as high as \$175,000, after the return of the \$50,000, Improperly turned back by Mrs. Ham; that would indicate an original deficit on the American Surety Company of \$225,600. Take, then, the possible wiping out of at least two-thirds of the vested stock of the St. Luke's Home for Convalescents, that would add \$60,000, and there is \$285,000 in the gross.
