FOR A WIDOW'S LOVE

Californian Kills Himself When Suit Is Rejected.

MATRIMONIAL AGENCY MATCH

Waldemar Hertwick, a Lonely Rancher, Seeks Comfort in a Pretty German Widow, Who Promptly Declines His Suit and Returns to the Fatherland.

Fresno, Cal., Nov. 12.—Strange was the romance that came late into the life of elderly Waldemar Hertwick and quickly drove him to his death.

It was a marriage bureau romance, the conclusion being that the man killed himself because the woman who had been selected for him by the bureau refused, at last, to marry him. The prosy world might sooner expect, in such a case the matrimonial realization to be the cause of suicide.

Hertwick, lived in Lindsay, a Tulare country town, and he lived alone. He came into the state from some part of the east, and originally came from Germany. His physician had advised him to lead an out-of-door-life, and so farming was tried as a remedy for a long illness that might be cured in the California climate.

Hoped to Find a Wife

On the ranch, Hertwick improved in appearance and believing that he was sure to get well he wrote to a marriage bureau in the hope of finding a woman who would marry him. He stated that he was a German, prosperous, of middle age, and that he was entirely alone in the world. He wanted a good wife, German preferred, who would be content on a California ranch with him. The thought of existence on California soil is a lure all over the world, and somehow the advertisement of Hertwick made its way to Germany.

Mrs. A. H. Tilloch, a good-looking young widow, wrote to Mr. Hertwick. She believed that she could be a satisfactory helpmeet to the lonely man on the Tulare ranch; and those who saw her when she finally arrived at Lindsay say that all her praises of herself, such as she wrote when seeking to win the man and the home in California were entirely too modest.

Sends Good-Looking Picture.

The rancher sent his photograph to Germany, selecting, as was natural, perhaps, one that had been taken some time before he became afflicted with consumption. He had been a good-looking man in earlier days. The German widow's photograph was not as alluring as the widow herself proved to be when she reached the ranch; but the lonely Waldemar Hertwick, with the name that would adorn a novel if his little life-ending story should ever be elaborated into fiction, fell desperately in love.

Arrangements were quickly made, as quickly as trains and steamers could carry between California and Germany a few letters that were straightforward and to the point. The rancher had the money to send; the widow in far-away Germany was eager to meet the rancher and see the new home that was awaiting her. In the latter, she was undoubtedly disappointed; in the man she certainly was. It was a poor, little \$1500 farm, in no respect like those of which the widow had heard and read. The man was emaciated, rather oldish-looking, and in hardly any respect like his picture.

Widow Was Stunned.

Mrs. Tilloch arrived at Lindsay, and

when she stepped off the train she seemed almost stunned at finding the invalid in place of the man of whom she had dreamed. She shrank away from his caresses as he greeted her and when she had listened to a few words of welcome she asked if his health was good. She questioned closely, and finally Hertwick admitted that he had consumption.

That ended the romance and the dream. The farm was examined, but the woman from Germany could not be persuaded to marry. Mrs. Tilloch concluded to go back to Germany, and after spending a few days in San Francisco visiting relatives she went.

Hertwick sold his ranch for \$1000 and drew \$700 from the bank. He followed Mrs. Tilloch to San Francisco and went across the continent with her, but the old promise of marriage could not be regained. He saw the woman sail away for Bremen, and then it was that, as told in "The Examiner" dispatch this morning, he ended his existence by taking poison.

LINER YET AGROUND

Graf Waldersee Still in the Mud in New York Harbor.

ATTEMPTS TO FLOAT HER FAIL

Freight Being Lightered Onto Other Boats But Passengers Are Still Aboard—Thirty Thousand Tons Must Be Removed Before Ship Can Float.

New York, Nov. 12.—Efforts to float the Hamburg-American liner, Graf Waldersee, which grounded Saturday in the upper harbor of New York were unavailing at high tide today. No attempt will be made tonight, but it is expected she can be floated at high water tomorrow.

According to Captain Kerch, the Graf Waldersee is resting two feet in depth of her bulk for her entire length, in the bottom, a mile off Brooklyn shore and nearly 30,000 tons of her cargo must be removed before she can float. Some of the cargo has been unloaded.

Early today an attempt by a dozen tug boats and the ship's own power to start her astern, was made, but after two hours of work the task was given up.

The Venetia, one of the liners in the West Indian service was brought alongside and hundreds of tons of cargo were placed on her decks. All lighters that could be had were ranged around the big ship and the unloading was started. The passengers are still on board.

REBATES ON BEER

Pabst Company Paid the Regular Freight Charges.

RECEIVED 12 PER CENT. BACK

Case to Be Tried in Wisconsin Under the Elkins Law, to Test Legality of the Practice of Paying Rebates After Receiving the Regular Rates

Washington, Nov. 12.—Attorney General Moody today made a statement regarding the petition which will be filed tomorrow in the circuit court of the United States in the eastern district of Wisconsin, brought under the Elkins law to test the legality of certain commissions paid by the railroads to a private car transit company, controlled by the stockholders of the corporation, shipping the freight in this cars over the railroad lines.

The case arises out of facts investigated by the Interstate Commerce Commission and also by the private interests adversely affected.

It appears some of the principal stockholders of the Pabst Brewing Company organized and own the Milwaukee Refrigerator Transit Company. To the latter corporation, control of the shipments of the Pabst company were given by various railroads, and while receiving published rates for the transportation of the commodities, have, it is stated, paid the transit company a commission of about 12 per cent upon the amount of freight money collected. This petition is designed to test the legality of such payments.

The case is regarded as of great importance and is pressed for speedy hearing.
