Said repairs shall consist of removing all the old street decking, from curb to curb, including the crossings, and between Ninth and Tenth streets, straightening up the stringers so as to bring the street to the established grade, and filling in where necessary to do so, and by replanking the street on the existing stringers from the East line of Ninth street to the West line of Fourteenth street with good sound yellow fir lumber 4 inches in thickness by 12 inches in width.
