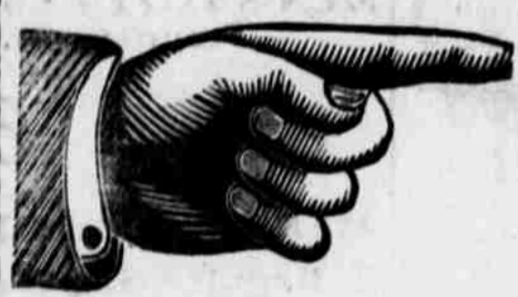



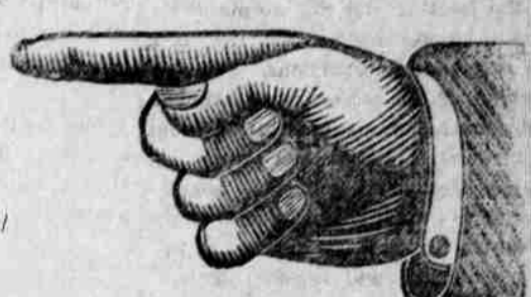




## TONIGHT'S THE NIGHT
