THE BOISE TRIAL

Rebuttal Will Close on Next Monday Morning.

A SENSATION IS IN STORE

Judge Wood is Now Inclined To Confine The Evidence To What is Material To The Case And Will Limit The Testimony After Direct Examination.

BOISE, Ida., July 12th.—William D. Haywood, the first of the men to be placed on trial charged with the murder of former Governor Frank Steunenberg this morning gave his testimony in his own behalf, under examination by Clarence Darrow, counsel for his defense. Haywood possibly will be the last witness called in direct examination. By this afternoon, or the adjournment of court tomorrow at Noon, both sides will have closed and the rebuttal will close on Monday morning. About 40 witnesses altogether have been subpoenaed for this rebuttal. Counsel for the state expects to oppose the greater part of next week in the examination of their witnesses and much depends upon what it brought out by the state as to whether the arguments will commence as soon as was expected. Counsel for the defense say that they may call a number of witnesses in rebuttal. Should this be made necessary it is possible that the court will have to adjourn for some days in order that the defense may be given time to summon their witnesses from a distance.

Both Moyer, the president, and Haywood, the Secretary of the Western Federation of Miners, have denied in the most positive terms that they knew Orchard in any other connection than as a member of the Federation. Counsel for the defense appear to be determined to bring the most minute details as to the relations between Orchard, the self-confessed assassin of a score of men, and the officers of the organization of which he was a member. They state that the Federation consistently stood by its members until they were proven guilty and that it was not until Orchard confessed his crimes that they deserted him.

It is believed that there are sensational developments in store. Both sides are threatening perjury proceedings against certain witnesses and establishing sides maintain that in the rebuttal and surrebuttal much matter altogether unexpected will be brought out.

Judge Fremont Wood is now inclined to limit the evidence to what is actually material to the case. He has given both sides an extremely wide latitude, but he has informed counsel for both sides that after the direct testimony for defense is all in, he will limit them to the material facts in the case.
