TEAR DOWN WIRES

Overhead Trolley Will Come Down in 18 Months.

SUPERVISORS WITH BIG STICK

Notice Also Served On Sutter-Street Railroad Company That Its Tracks On Market Street Are in Violation of Law And Will Be Torn Up If Rebuilt.

SAN FRANCISCO, Aug. 5.—The Board of Supervisors denied yesterday an overhead trolley permit, and took the first step looking to the abolition, eighteen

months hence, of all overhead electric wires in the district eastward from Divisadero street. It also virtually served notice on the Sutter-street Railway Company that the outside tracks on Market street between Sansome and East streets, had existed in violation of law, and would be torn up if rebuilt.

"Resolved, That the application of the Sutter Street Railway Company, filed June 4, 1906, for permission to operate its street railways in the city and county of San Francisco with electricity by means of the so-called overhead trolley system, to erect the necessary poles and to string the necessary wires and to provide and use the Company, filed June 4, 1906, for permission and necessary means to that end, be and the same is hereby denied."

The above resolution was the answer of the Board of Supervisors yesterday to the petition of the United Railroads, through its subsidiary "Sutter-street Railroad Company," for a trolley franchise, which would bind the city to tolerate four trolley wires down Market

street from Sansome for the next twenty-five years.

Supervisor D'Ancona, on behalf of the joint Public Utilities and Judiciary committees, introduced the resolution of refusal.

Supervisor Brandenstein wished a week's delay to enable the road to renew its plea before the whole membership, but found his only supporter in Supervisor Brenner. The twin petition to that of the United Railroads which summarily dismissed by their colleagues, who then proceeded to even more radical measures.

Supervisor Murphy next proposed a general "grounding of the wires" ordinance. Allowing eighteen months for the street railway, telephone and other companies to build their underground conduits and to transform their system.
