

N. C. ENTERS WALLA WALLA

Engineer Opens Headquarters and Prepares to Make Survey.

WALLA WALLA, Wash., Oct. 7 .-Edwin S. Clark, engineer for the North Coast Railroad company, reached here yesterday, and is establishing headquarters in the eastern part of the city. Mr. Clark says he will survey a route from the city in a southerly direction, probably across the Blue channel. Already the company has made its sur-

vey from Wallula to this city This survey runs along the Walla Walla river for several miles. The grade is considerably lighter than that of the O. R. & N. company, and is from 25 to 100 feet higher in elevation than that company's line. The line will probably onter Walla Walla at the northeastern part, along Ninth street.

CLE ELUM, Wash., Oct. 8.-Pinned under a log and either unable to bear the terrible pain or fearing that even if resced he would be a helpless cripple for life, Claude Harkness, 30 years old, pulled a knife from his pocket and cut his throat. Several hours later his lifeless body was found by his uncle, Marion Harkness, who was working in the timber with him. How long the unfortunate man cried for assistance will never be known. The ground was torn up on the spot where he was found and tells the mute story of the awful fight he made to free himself before he decided to take his life Harkness was working on a big timber when it rolled over and pinioner him. His libs were crushed to the thighs and doctors assert it is doubtful if he would have lived had he been rescued alive.
