COUNCIL MEETING IS CONCLUDED

LONG SESSION OF CITY FATHERS TRANSACTS MUCH BUSINESS-ORDINANCES PASSED AND BILLS ALLOWED.

The following is a continuation of Monday's proceeding which space did not allow us to publish yesterday morning:

Petition from A. Nylander and others asking the council to order the opening of Grand Ave. from W. line of 19th to the E. line of 29th. Referred to the Committee on Streets and Public Ways and the City Surveyor.

Petition from James Jackson and others asking that Irving Ave. from the W. line of Adairs to 40th street be improved at the earliest convenience and protesting against any change of grade. Ordered filed.

Petition of Wirkkala & Puusti for a liquor license. Considerable discussion was had on the subject and a vote of the council decided that the petition should not be granted.

Petition of the City Physician for leave of absence granted leave to extend from Dec. 20 to January 20, 1908.

Ordinance appropriating money for the part payment of improvement of Irving avenue from 18th street to the east line of Shively for W. A. Goodman, passed to third reading.

Ordinance providing for the time and manner of improving Exchange street, from 11th to 12th, rules suspended, read third time and ordinance passed.

Ordinance for extending time for the completion of the improvement of Lincoln Ave. from Columbia to Duane extended to the 1st day of July, 1908. Rules suspended, read third time and passed.

Ordinance providing for the time and manner of improving Irving Ave. from E. line of Shively's to 40th street. Rules suspended read third time and passed.

Ordinance providing for the time and manner of improving Exchange street from 10th to 11th to Duane passed to third reading.

Ordinance providing for the time and manner of improving Exchange street from 10th to 9th. Rules suspended and read third time and passed.

Ordinance paying L. A. Carter from Special Fund for sewer on 9th street for sum of \$650 passed to third reading.

Ordinance re-establishing the grade on Commercial street from 3rd to 1st in the Hinman tract. Rules suspended, read third time and passed.

Ordinance accepting the improvement of Bond street from McClures to west end. Laid over.

Ordinance confirming special assessment roll No. 150 for improving Melbourne avenue. Rules suspended and read third time and passed.

Ordinance confirming special assessment roll No. 151 for improving Columbia avenue. Rules suspended, read third time and passed.

Ordinance for extending the time for the completion of Columbia avenue to June 1st, 1908. Rules suspended, read third time and ordered passed.

Ordinance appropriating the sum of \$542 out of the General fund for A. G. Long passed to third reading.

Ordinance appropriating \$665.11 from general fund for Scholfield & Mattson passed to third reading.

Ordinance repealing ordinance No. 2611, entitled, "An ordinance to license and regulate nicker-in-the-slot machines and other devices of like nature." Rules suspended and read third time and passed.

Ordinance appropriating \$161.80 from the General fund for the benefit of Palmberg & Heblack passed to third reading.

Resolution fixing the time for equalizing the assessment for the construction of a sewer on 4th street from the N. to S. line of Com'l street; improvements 4th street from Bond to Com'l; for construction of a sewer on 9th from Com'l. to A. & C. right-of-way and fixing said time for December 28th.

Several other resolutions and petitions came before the Council and were adopted.
