Quotations in the Portland Market.

PORTLAND, March 31.—The end of the upward movement in sugar prices has not yet come, according to the local wholesale grocery trade.

"I look for another advance of 10 cents a hundred on sugar either today or tomorrow, and it is not at all improbable that this will be followed by still another lift this week," said an official of one of the wholesale groceries today.

The egg market was firm in tone today, with quotations in some quarters a fraction higher than those of yesterday, sales being reported at 151-2 to 161-2 cents, the latter figure for strictly fresh and carefully candled goods.
