EXTREME STREETS STILL ANOTHER RAID

COUNTRY MERCHANTS DODGE BIG FISHING CARP BUT A LITTLE ONE TAKEN BY SHERIFF'S NET.

As Deputy Sheriff Archie McLean walked down Commercial street about 5 o'clock last evening he did not raise his hand to his hat in an effort to conceal a smile that would persist in coming.

Then he stepped into Frank Grusse's cigar store at the corner of Commercial and Eleventh still smiling the smile and softly pushed open the door that leads into the back room.

The sight that met his anticipatory gaze was instantly indelibly photographed on his brain and stored away as evidence. There were two men playing cards. There was money on the table, it was about 10 cents.

The two men were placed under arrest, and a third man was also taken along and held during the trial of the proprietor, Mr. Grusse, was not arrested. He was not held responsible.

It was probably the first instance ever known in America when a game was punted and the proprietor was not taken in, and Mr. Grusse may set himself down as the man who made a new record.
