Legal Notice of the application of Milton Stevens for a United States Patent for Placer Claim, No. 108.

Notice is hereby given that in pursuance of the Mining Laws of the United States, Milton Stevens, of Grant County, Oregon, claiming twenty (20) acres of placer mining ground, designated as Lot No. 108, being situated in Granite Creek Mining District, said County and State, has made application to the United States for a patent to said claim which is more fully described as to metes and bounds by the official plat herewith presented posted and by the field notes of Survey thereof now on file in the Office of the Register of the District Lands, subject to sale at La Grande, Oregon, which field notes of survey describe said claim in relation to a natural object, as follows: commencing at a bluff of rock on the south side of Granite Creek, the same being a permanent and natural object, thence running the line of survey north 32 1/2 deg. E, 2 chains to the intersection of Granite and Bull Run Creeks, thence in the same direction 4 and 50 chains to a mineral monument, being a rock marked M M, thence in same direction 3 chains to a rock marked S W C being the south west corner of claim and described as to Boundaries as follows: Commencing at said rock marked S. W. C. extending thence S 70 deg. E 10 chains to a rock marked S. E. C. being the Southeast corner of said claim, thence N 20 deg. E 20 chains to a rock marked N. E. C. being the northeast corner of said claim thence N 70 deg. W 10 chains to rock marked N W C, being Northwest Corner of said claim, thence S 70 deg. W, 20 chains to place of beginning, containing twenty acres of placer mining ground, situated within the angle formed by the confluence of Granite Creek and Bull Run Creek and with reference to said creeks being on the North side of Bull Run and on the East side of Granite and within the above described line of survey with magnetic variations of 19 deg. E, Surveyed March 12th, 1880, and the location of said claim being of record in the office of the County Clerk for the County of Grant, State of Oregon.

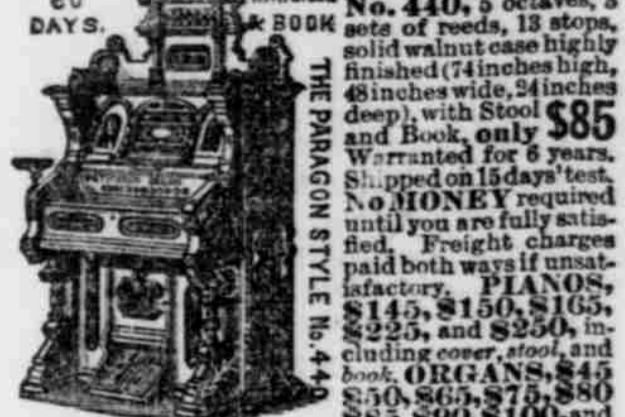
