LAWS RELATING TO NEWSPAPERS:

1. Subscribers who do not give express notice to the contrary are considered as wishing to continue their subscriptions. 2. If subscribers order the discontinuance of their periodicals the publisher may continue to send them until all arrearages are paid. 3. If subscribers neglect or refuse to take their periodicals from the office they are directed to, they are responsible until they settle their bills, and order their paper discontinued. 4. If subscribers move to other places without informing the publishers, and the papers are sent to former addresses they are held responsible. 5. The courts have decided that refusing to take periodicals from the office, or removing and leaving them uncollected for is prima facie evidence of intentional fraud. 6. Any person who receives a newspaper and makes use of it, whether he has ordered it or not, is held in law to be a subscriber. 7. If subscribers pay in advance they are bound to give notice to the publisher at the end of their term, if they do not wish to continue taking the paper, otherwise the publisher is authorized to send it on, and the subscribers will be responsible until express notice, with payment of all arrears is sent to the publisher.
