CALIFORNIA TORN BY FEARFUL EARTHQUAKES

SANTA BARBARA, July 28.—Fifteen successive shocks of earthquake were felt last night at Los Alamos, Cal., and another severe shock at 10:14 this morning, destroyed an oil tank, tore great rents in the earth, and caused great damage to buildings.

For many seconds the whole earth shook and the people were in great terror. Fears are entertained that further quakes may occur which would cause great damage as many buildings are now so weakened that they would collapse at any renewal of the shocks.

AS A COMPLIMENT TO UNITED STATES

WASHINGTON, July 28.—United States Consul McDonald at Managua, Nicaragua, today cabled the State Department that as a courtesy to the United States and in sympathy for his mother, President Zelaya will commute the death sentence of Dr. Russell Wilson, the young American doctor, who accompanied a filibustering expedition against Nicaragua, and was captured.

BATTLE PENDING

Insurgents Expected to Attack Cape Haytien Tonight.

(Scripps-McRae News Association.) PARIS, July 28.—A dispatch from Cape Haytien says the insurgent army under General Salnave is moving toward that place and an attack is expected tonight. There is no foreign warship in the harbor and foreigners and other non-combatants are in danger.

NEW LUMBER RATE.

The rates on lumber and shingles from Minnesota Transfer and St. Paul to certain points in Illinois, Iowa and Missouri have been reduced 2 cents per 100 pounds. The tariff announcing this reduction, although dated July 17, has just reached Portland. This will affect the through rate proportion. Shingles are particularly benefited by the reduction and applies to all parts of the Burlington system.

CORBETT CHOSEN
