The company proposes to engage in a general canning and packing business, including the canning, packing, preserving and pickling of all canned meats, fish, fruit and vegetables, and to deal in the canned product. Salem will be the headquarters, and the capital stock of \$20,000 is divided into shares valued at \$100 each.

### JACKSONVILLE.

JACKSONVILLE, Aug. 15.—J. W. Opp brought into Jacksonville last Tuesday a gold brick weighing 99 ounces for shipment to the mint, which is the product of a clean-up from the prospecting five stamp mill located on the J. W. Opp properties known as the Gold Standard mine. This mine is two miles west of Jacksonville, and has been undergoing development during the past three years. It is a large ledge and the property comprises five claims.

### DAYTON.

DAYTON, Aug. 15.—The Willamette River, between Newburg and Salem, is literally full of logs. The drive belongs to the Spalding Logging Company, and is one of the largest ever run down the river.

### BAKER CITY.

BAKER CITY, Aug. 15.—The Famous Balesley-Elkhorn mine, four miles from this city, the buildings of which can be seen from the city, will soon again resume operations after lying idle for a year. The Balesley-Elkhorn is one of the richest mines in the West, and is shining example of what bad management will do. The property was owned by the Eastern Gold Mining Company, a corporation made up of capitalists of Amsterdam, N. Y., and Norwich, Conn. The Amsterdam and Norwich interests clashed, and both sides did more to ruin the mine than to create wealth. It finally suspended operations after many debts had been created. The owners left things to arrange themselves, not even having an attorney to defend suits against the property. All the creditors of the company obtained judgments against the company. Recently the Amsterdam people purchased the interests of the Norwich crowd, and sent an expert, D. B. Dunlop, to Baker City to bring order out of chaos.

### INDEPENDENCE.

INDEPENDENCE, Ore., Aug. 15.—Mr. Coquillette, an old gentleman residing here, was the victim of a very painful accident Wednesday. While slaughtering with Fred Hooper, the latter accidentally struck Mr. Coquillette's hand, badly wounding several fingers.

### ASTORIA.

ASTORIA, Aug. 15.—Contractor A. B. Root is finishing up a spruce log raft of 300,000 feet for the Willamette Spruce Mills of Oregon City. The raft is coming down the Lewis & Clark and will be ready for towing up to Oregon City in about 10 days.

### NORTHWEST NEWS.

There is urgent demand for harvest hands in Eastern Washington.

### GRANTS PASS.

GRANTS PASS, Aug. 15.—The Josephine County hop crop is going to be better this season than for many years, at least all indications point that way now, and the time of picking is but a short time ahead. There are a number of yards in Josephine County, notably in Williams and Applegate Valleys.

The hops this season are large and plump, and are abundant on the vines. They are comparatively free from blight and insect pests. The only trouble that will be experienced in the matter of getting yard men will be in the matter of getting pickers. The price to be paid will be the same here as in the Willamette Valley, a better price will rule this year than for many seasons past.

## NAVAL PAGEANT

### Great Fleet of Battleships and Twenty Cruisers.

(Journal Special Service.)

PORTSMOUTH, Aug. 15.—Today's naval pageant in celebration of the coronation of King Edward, though smaller than originally planned because of the absence of many of the foreign warships that were here in June, was nevertheless one of the grandest affairs of the kind in modern history. The town and harbor were astir early. Last evening and during the early morning hours excursion trains brought thousands of sightseers from London, and the crowd was one of the largest ever assembled here. Immense throngs congregated along the sea front, and rounds of cheers mingled with the national anthem and salutes from the ships and land batteries as the royal yacht Victoria and Albert, with the royal family aboard, hove in sight.

The roads presented a striking spectacle, owing to the great gathering of warships, dressed from stem to stern and with their yards manned and their sides lined with their crews. The combined fleet was anchored in four lines, stretching from Horse Sand fort, at the lower end of Spithead, to beyond Cowes road. The British portion of the fleet combined 24 battleships and 21 cruisers, selected from the Channel, Reserve and Cruiser squadrons, together with a number of specially commissioned ships. At the

head of the principal line of ships was moored H. M. S. London, carrying the flag of the Prince of Wales as Admiral of the United Kingdom. The Prince of Wales was in supreme command, his subordinates being Vice-Admirals A. K. Wilson and Sir Gerald Noel, in the Majestic and Revenge respectively; Rear Admiral Sir W. A. Dyke Acland and Sir Baldwin W. Walker, in the Magnificent and Resolution, and Rear Admiral Pelham Aldrich and Admiral Sir Michael Culm-Seymour. Occupying a place of honor in the line was the splendid cruiser Good Hope, the gift of Cape Colony to the Imperial army.

Though the foreign warships were not numerous they made an imposing show, and most of the flags of the civilized world were to be seen fluttering from the mastsheads. Conspicuous in the line were the Japanese cruisers Asama and Takasaga. The navies of the United States, Denmark, France, Germany, Russia, Spain and the Argentine Republic were likewise represented.

The review occupied more than three hours, and was conducted amid a constant booming of guns, the playing of bands and cheers from thousands of throats. Tonight a grand scene was presented by the illumination of the ships and the harbor.

### DIED OF GRIEF

NEW YORK, Aug. 15.—The last chapter of the domestic tragedy of Mrs. Mary Meade, who strangled to death her three little children and nearly killed her baby by the same means, is recorded in the day book of the Homopathic hospital.

The book shows the death of the mother, who, the doctors say, died from the effect of the poison and poignant grief. Grief over the knowledge of her children's death hastened her end. At midnight she insisted on knowing what had become of her little ones. When told she shrieked despairingly and fell back dazed. She passed away a short while after.

## ANARCHIST DIES

### Takes His Own Life Rather Than Murder Another.

ROME, Aug. 15.—The Italian steamer Citta di Milano, from New York, July 22, just arrived at Genoa, reports that an anarchist named Spagna, of New York, committed suicide by jumping overboard while the vessel was off Gibraltar. It is alleged that Spagna had been commissioned to murder a European royal personage, and that he was on his way to Europe for this purpose, but weakened at the last moment and killed himself. Two of his companions, disappeared upon the arrival of the Citta di Milano at Genoa.

## SHOT BY SHERIFF

### He Was Killed Because He Refused to Surrender.

OSHKOSH, Wis., Aug. 15.—Samuel Burrows, aged 25, who made a murderous assault upon two young men who had stopped in front of his farm to get a drink of water, was surrounded by Sheriff Potter and his posse. In the conflict Burrows was shot and died soon afterwards. It is thought he was insane.

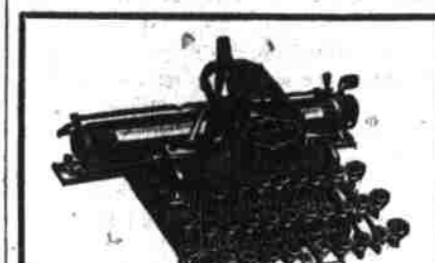
