WEATHER FORECAST.

A disturbance of decided character is central this morning over British Columbia moving eastward. Heavy rain has fallen in the middle Mississippi valley; showers and thunderstorms have occurred in the Great Salt Lake basin, and showers are indicated for tonight and Thursday in Washington and Northwestern Oregon.

It was unseasonably cool this morning in California and Southern Oregon, and it will be cooler this afternoon in the Willamette valley and cooler Thursday in Eastern Oregon, Eastern Washington and Idaho.

Western Oregon—Tonight and Thursday, cloudy, with showers—north portion; brisk, southerly winds.

Western Washington—Showers this afternoon, tonight and Thursday; brisk, southerly winds.

COUNTY INSTITUTE

Superintendent Robinson Pleased With This Year's Outlook.

ATTENDANCE WILL BE LARGE

Number of Prominent Instructors Will Be Present.

County School Superintendent Robinson is greatly elated over the prospects for the county institute which is to be held September 10-11-12 in this city. It is expected that at least 500 instructors will attend in the several departments. In speaking of it, Professor Robinson said this morning:

"The chair of instructors, as announced a few days ago, was received very favorably by the teachers. Many of the city teachers who attended the summer school at Berkeley, Cal., speak very highly of Professor T. L. Heaton, assistant professor of education of the University of California. Over 800 teachers attended the summer school. Professor Heaton will be here and will confine his instruction principally to the language arts."

"Professor W. C. Hawley, of Willamette University was one of the instructors last year at the county institute. His strong lecture on civic government and history, was so well received by the teachers that they have strongly united in a request for his return this year."

"Professor Ringler has consented to take an active part in the institute as instructor and will deliver two lectures before the entire body."

"Mrs. Josephine Lisher will have charge of the primary number work of the primary division."

"Superintendent W. F. Hartnuff, of King County, Wash., will be present during the entire institute, and will instruct in every department. His lectures will be principally in the department having the largest attendance of county teachers. His work in Seattle is much the same as mine here, he having the King County schools under his control."

"City Superintendent F. B. Cooper, of Seattle, will present a part of the time, at least, and will contribute largely to the institute. On Friday afternoon he will lecture on 'The Question of Quality.'"

What Portland Workers Are Doing for Their Advancement.

May Be Charged With Contempt

Johan Poulsen and His Attorney Before Judge Sear's Court.

Judge Sears this morning heard arguments in the citation of Johan Poulsen, manager of Inman-Poulsen & Co., and J. D. Young, attorney in fact for the company, to show cause why they should not be punished for contempt in refusing to answer the questions asked them at the examination before W. M. Gregory, a notary public.

Poulsen and Young were subpoenaed to appear before Notary Gregory on August 25 and answer certain questions, and also to produce certain letters in the suit of the Pacific Mill Company of Honolulu against Inman-Poulsen & Co., to recover damages to the amount of \$15,000.

Poulsen and Young both appeared, and were sworn, but under the advice of their attorneys, Cake & Cake, refused to answer any of the questions asked by Ralph Dunlavy, the Pacific Mill Company's attorney. Poulsen would not produce the letters required by the subpoena.

Section 53 of the Oregon statutes provides that an adverse party to a proceeding may be examined before a notary public. Dunlavy was endeavoring in this way to obtain certain information material to his side of the case. This information the defendants seem determined to keep from plaintiffs if possible. Dunlavy is now trying to have defendants answer questions from the case and to have Poulsen and Young punished for contempt for refusing to answer the questions asked them.

WONDERS OF WILD WEST

Buffalo Bill Gives Some Lessons in History.

DARING FEATS OF HORSEMEN

Crowds Assemble to See the Fighters of the World Perform.

The best and most lasting lesson in real history to both young and old that has been seen here for years was the wonderful exhibit given by Buffalo Bill's collection of fighters and horsemen from all over the world. It is the actual performance of those deeds that have come down to us from the past, an addition to the story the children of today are learning. There are the wild, dashing riders and skirmishes that can only be fully realized from this performance, for tongue or pen cannot truly describe the feat.

The great troupe of Buffalo Bill's show swooped down upon the city yesterday and captured it without resistance. The wild Indians went through the weird contortions of their war dance to the entertainment of over 35,000 people in the two performances of yesterday. Business men and men who are not so busy joined the vast army that moved to the show grounds both afternoon and evening and in admiration and wonder sat spellbound during the two hours' exhibition of nerve and skill.

The performance opened with the dash of Indian horsemen into the great arena that was waited in by a sea of eager faces. Following these were the troopers from Germany and Arabia; cowboys, British heroes, Moors and rough riders who have made history during the last 30 years. After this array had taken their positions a lone horseman was seen dashing up the long arena, and as the crowd caught the time-worn face, cheers echoed and re-echoed along the line. It was Buffalo Bill.

Act after act followed this in quick succession, causing the great crowd to be one moment silent in breathless expectancy and the next to break forth in cheers. The artillery drill was the real thing and carried some of the older fellows back to the days when guns were limbered in actual war. The action was shown. From dashing into action to firing the cap that caused many a woman to scream in surprise that the discharge was not louder.

There was a movement of familiarity when the old emigrant train slowly wended its way across the arena as the old pioneer turned to catch the eye of her who accompanied him across the prairie to make a home in the new West.

The pony express was a reminder of the hardships of travel and communication of former days, but it was not so slow as books might paint it, for with all lightning expresses there is nothing so inspiring as to see the bold rider dismount his steed at full speed and mount another to be away again before one had time to consider what he is going. The whole frontier life was brought to mind and the present generation given the best opportunity to see its reality that they will ever have.

Cowboys practiced their drills and deeds of daring, Mexicans rode as in the time when the prairie was undisturbed by civilization, and their leader gave an exhibition of handling the lasso that won unstinted applause.

The drill of the United States Life Saving Crew was realistic and instructive, and shows what the nation is doing to lessen the dangers of the storm-tossed deep.

Once or twice a horse went down, but the noble animal recovered itself so quickly that it was hardly noticeable.

Buffalo Bill gave an exhibition of his skill in shooting objects thrown into the air while riding at full speed, and to show the quickness of his mind, while the objects were being thrown the fastest one was sent in the direction of the mass of telephone wires that happen to cross the arena, the trusty rifle was raised but Cody quickly saw the possibility of cutting a wire and the rifle was lowered.

Col. Cody showed that he is a master with the rifle, and deserves the honors he receives. Many of the officers from Vancouver Barracks, who had served with Cody in Indian wars visited him yesterday, and were carried back to the old days as they watched their old comrade dash around the arena with the fire of youth.
