OVER THE WIRES.

The property of President Roosevelt at Oyster Bay has been assessed at \$40,000. An effort will be made to secure a pardon for Jim and Cole Younger, the desperadoes now out of the Minnesota penitentiary on parole.

One of the oldest summer resorts of Erie, Pa., the Grove hotel was burned to the ground yesterday. The occupants barely escaped with their lives.

Armed passengers prevented an attempt to hold up a train on the Sonora railroad near Hermosillo, Sunday morning. A report of the attempt has just reached Tucson, Ariz.

W. N. Dimmick, who is accused of stealing \$20,000 from the United States mint, is being tried in San Francisco. His former trial resulted in a disagreement of the jury.

The monthly statement of the public debt shows that at the close of business August 30 the debt, less cash in the treasury, amounted to \$98,000,321, a decrease of \$5,815,646.

Disputes from London state that Nance O'Neill bids fair to become a rival of Sarah Bernhardt, Eleanor Duse and Mrs. Patrick Campbell. She made a tremendous hit at the Ad-phia.

The Michigan bank wrecker, Frank C. Andrews, who was convicted for misappropriating the bank's funds, has filed a petition to have the verdict set aside. He gives 48 reasons why his request should be granted.

Fourteen persons were shot during an attempt of the police to arrest Harry Hunter, a negro desperado, near New York yesterday. Hunter was finally captured, but not until he had been beaten into insensibility by the officers.

Officers last night prevented an armed mob from lynching two men at Kansas City, Kan., by springing them away. The men were robbers who had shot a policeman and night watchman while trying to rob the street railway at Armourdale.

An opera singer named Amelia Gabriela, who eloped from New York with Robert Anselmo, was shot by her companion in flight at Philadelphia yesterday. It is believed that he shot the woman because she wanted to return to her husband.

A San Francisco report says that Mrs. H. D. Green, a prominent society woman of Portland, has been accused of attempting to pass dutiable goods without paying duty on them. Mrs. Green was notified that a settlement would have to be made with the collector, but she failed to put in an appearance.

The Washington State Board of Equalization met yesterday and will be in session for 20 days.

One of the richest mine owners of the Lower Yukon, James W. Dillon, died recently at Eagle City, Alaska, of Bright's disease.

Thirty-four thousand cases of Moshak salmon arrived at Seattle last night on the bark Guy C. Goss. The ship St. Paul is expected to arrive there today with 40,000 cases on board.

Washington Prohibitionists have made up their minds to make the campaign solely on the liquor question. In connection at Seattle yesterday an entire congressional ticket was nominated.

At Tacoma today a special session of the United States Court is being held to try the suit to condemn property in Grays Harbor country for the purpose of constructing the government jetty.

An explosion in a separator caused a damaging fire near Colfax yesterday and but for the presence of mind of the engineer and the efficient work of the firemen an immense crop of barley would have been destroyed.

Aberdeen was compelled to call on Hoggan for assistance in putting out a fire which threatened the entire west end of the city. While fighting the flames a fireman was overcome by smoke and heat and had to be carried to his home.

ASTORIA.

(Journal Special Service.)

ASTORIA, Sept. 3.—The trap owners at Baker's Bay have decided to remove their gear from the water during the fall fishing season, and the packers must depend on their own traps for their supplies of salmon. At a meeting of the trapmen it was agreed that there should be no fishing unless two cents a pound were offered for fish, and as the proposal of the packers is but one cent, there will be no fishing so far as the trap owners are concerned. J. G. Megler, who is in the city, states that he will operate his Brookfield cannery. Senator Megler says he has offered up river trapmen one cent a pound, and he thinks his proposal will be accepted. He says the packers cannot afford to pay more than one cent. So far as Senator Megler has been advised, no other cannery is to be operated but the plant at Eagle Cliff.

The Eagle druggery was broken into and robbed early Monday morning. The proprietor, Dr. T. F. Laurin, was called by a passer-by and on going to the store found that the front doors had been smashed in. The burglars rifled the register, in which there was about \$10, and helped themselves to several articles from a showcase. The loss was about \$50.00.

The Republican county convention is in session today in Waukegan County, Wash. The McBride supporters won in the primaries, which were held Saturday, and will control the convention. The principal business of today's gathering will be the nomination of candidates for the Legislature. Senator J. C. Megler, who has represented several counties at Olympia, has been defeated for renomination to the Senate, and is an active aspirant for the Legislative nomination. He is believed to have the greatest strength, although Starr and Irving are both strong men. The convention will name a full county ticket.

Charles Wickstrom, of the steamer Anna Barron, belonging to the Onofrey salmon combine, has returned from Alaska. He reports that the cannery had packed, up to August 23, 28,000 cases of salmon, and that 7,000 cases of cans remained to fill. The run of sockeyes was over on that date, but it was expected the silverides would soon make their appearance. The cannery is located on Admiralty Island.

The monthly weather report of Observer Johnson shows that the average temperature for August was 61.6, the highest mark reached by the glass being 82 and the lowest mark 46. The fiscal year ended August 31, and the statement for that period shows that the yearly temperature has averaged 61. The total rainfall during the year was \$3.10, or 6.44 inches above normal.

Superintendent Hansen, of the Chinook hatchery, has discontinued the receipts of salmon at that place. He has 1000 fish in the river, and these will supply more than 2,000,000 eggs.

The machinery is being installed at the new Clatsop mills as rapidly as possible. Two new boilers have arrived and new engines are on the way.

The steamer Harrison left out today for Alsea Bay, with a cannery outfit and 25 Chinamen. The Elmore cannery at Alsea is to be operated. The Harrison, which has been on the coast run, will hereafter be used as a cannery tender for coast establishments.

The property bought in by the county for delinquent taxes for the year 1899 was sold yesterday by Sheriff Linville. It brought the full amount of the county's claim.

Captain Tom Neill was badly injured at Tillamook a few days ago. He was acting as mate on the steamer Elmore and fell through the hatch of the steamer, striking on his chin. He was rendered unconscious and is at Tillamook.

A local bridge builders' union has been organized in Astoria, with 22 members. Officers have been elected as follows: President, N. Clinton; Jr. Vice-President, T. Van Buren; recorder, secretary, E. J. Armstrong; financial secretary, Charles Althorn; conductor, H. Stephenson; warden, D. Vincent; business agent, Julius Wilbur.

Articles of incorporation of the North Pacific Brewing Company were filed yesterday afternoon in the office of the County Clerk. The incorporators are John Kopp, Emil Schimpf and Joseph Schamberger. The capital stock is placed at \$200,000, divided into 200,000 shares. The company will operate the brewery in this city. Mr. Schimpf, one of the incorporators, is a wealthy Pennsylvania brewer who was driven away from his home city on account of the strikes of coal miners, which caused practical suspension of business.

Articles of incorporation of the Lewis & Clark Boom Company were filed yesterday. The incorporators are H. F. Fraol, R. D. Byer and H. D. Gray. The capitalization is \$1,000.

GRANTS PASS.

GRANTS PASS, Sept. 2.—Two Indian girls, about 18 or 20 years of age, who had escaped from the Chemawa Indian School were taken into custody by the officers here yesterday. They were evidently making their way back to their native haunts in the Klamath country, being tired of book and study. Their names could not be learned. The superintendent of the Indian School telephoned Policeman Patrick of this city to be on the lookout for two Indian girls, who had purchased tickets for Grants Pass. The two girls arrived here on the south-bound train. They confessed to being the girls wanted, and were returned to Chemawa today by Deputy Marshal Randall.

The location of timber lands continues in full swing in this section of Southern Oregon. Locators are arriving nearly every day from all parts of the East and are being taken to the mountains by the cruisers. The bulk of the timber now remaining in the western part of the county, and also over the line in Curry. It is doubtful if there will be an available tract of timber land remaining at the close of the summer, as they are being taken up.

OSWEGO.

OSWEGO, Sept. 3.—The town is enjoying a season of prosperity unknown since the panic of '93, when the furnace closed down and the town became a deserted village. The pipe foundry of the Oregon Iron & Steel Company is running full time with its entire force of men and with more orders ahead than iron can be gotten to fill them. One of the results is that men who owned houses here, but had to leave some years ago to procure work, are returning and the question of houses to rent by the many strangers coming is getting to be a problem.

General Freight Agent Bancroft, of the Southern Pacific, and family, spent Sunday with Mr. and Mrs. Wm. Gray.

Mr. and Mrs. F. L. Mintie just returned from Alaska, where Mr. Mintie has been in the United States revenue service for the past three years, the greater part of the time being spent in Seattle. They have moved into the old home and expect to remain permanently in Oswego.

H. D. Chapman, of the City Engineer's office of Seattle, has been spending several days with the family of G. H. Pettenger.

Mr. and Mrs. Gray and daughter, Margaret, returned to Portland on September 1st, after a pleasant summer in their Oswego home, "The Cabin."

The attempt of some boys to burn out some stumps in the old brick yard almost resulted in a serious conflagration and was serious enough to burn away a large section of the side walk between the depot and postoffice. The town not being incorporated, the question of making the repairs is a serious one, it having been originally built by one or two enterprising citizens, but it is whispered that some of the women contemplate a Thanksgiving dinner to raise the necessary funds.

Mr. Morgan, son, daughter and niece, arrived from Scotland a few days ago, and are the guests of Mr. Morgan's daughter, Mrs. John Gardner.

The burning of the Tualatin bridge about two miles from Oswego Saturday night is seriously inconveniencing the farmers who live in that neighborhood, as they must go a long way around to get to the postoffice and railroad. The bridge is a considerable loss to the country as it was a substantial structure and cost about \$500. It is supposed to have taken fire from sparks from a steam thrasher.

Rural delivery is assured to the farmers adjacent to Oswego. Last week the postoffice agent spent the day with the postmaster of this place, getting plans perfected to that end. Several applicants for mail carrier took the necessary civil service examination, but the appointment has not yet been made.

VANCOUVER.

VANCOUVER, Sept. 3.—Mr. A. M. Blaker, of Hopewell, arrived in the city yesterday, and is registered at the Columbia. Mr. Blaker has just completed, at Seattle, Wash., for the Robertson Raft Company, of San Francisco, a large ocean raft. Its dimensions are 52 feet wide, and 35 feet deep, and draws 20 feet of water. It took 80 tons of chain, and 10 tons of wire cable to bind it together, and contains 500,000 linear feet of piling, and 70 spars, ranging from 9' to 110 feet long and 30 inches in diameter. It was built in the quickest time on record, being just 90 days, lacking three hours, from the time it was started till it was turned over to the company. It took the Harvest Queen and two large tugs to tow it to the ocean.

The tie mill on Lewis River, owned by A. M. Blaker, of Hopewell, will be started up in a few days. It cuts from 800 to 1000 ties per day. Mr. Blaker states there is an advance in the price of ties over last year's prices.

Among those prominently mentioned are the planing mill men, bartenders, woolen mill workers, and domestics, while the numbers on the roll of the federal union which comprises miscellaneous workers, it is thought, can be greatly increased.

Dr. Benham was about 60 years of age and in apparent good health. He practiced medicine here for some time, leaving a few months ago for the western part of the state. He leaves a widow and a considerable estate.

The funeral of William Anderson, of Pasco, occurred this afternoon from the residence of Mrs. Mary Anderson, on Fajouze street. Mr. Anderson was baggage man on the Northern Pacific at Pasco, and died of typhoid fever. He leaves a family and several brothers and sisters. He was about 31 years of age.

Rev. Lee A. Johnson, who has been pastor of the First Methodist Church for three years, left for Colfax yesterday, to attend the annual conference. Mr. Johnson has done noble work in this city and carried with him a strong petition from his membership asking that he be returned for another year.

Mrs. Anna Pickard, widow of Charles Pickard, recently killed by a runaway water wheel, was yesterday appointed administratrix of the estate left by her husband. Bond was fixed at \$100,000, among the highest in the history of the county.

OREGON CITY.

OREGON CITY, Sept. 3.—Hop-picking in Clackamas County began in several yards yesterday morning. The growers report that this year there is little or no mould, or lice and the weather has been favorable during the last month, and burrs are well filled and are a good color. This will be a banner year for everyone connected with the hop industry because the price of hops is now so high as to enable the growers to pay good prices for picking which is in no case less than 40 cents a box against 30 and 35 cents, the price paid in former years. There are plenty of pickers, as many people, who can not afford to take a vacation, go to the hop fields where, in many cases, more money is made than at any other time during the year.

Risley's yard, below town, employs about 50 pickers who will finish that 15-acre yard in about 10 days. Jacob's and Magoon's yards on the west side of the river, employs about 60 persons each. These yards however take only a small part of the Oregon City people, the majority going to up-river points on the boats.

A telegram received last evening by Chas. Albright brings the sad news of the death of Mrs. J. G. Ross, nee Annie Peters in Phoenix, Ariz. The deceased was a former resident of this city but went to San Francisco about two years ago where she was married. About two months ago she was taken with quick consumption. She was immediately taken to Arizona but the change had no effect. Her mother left Oregon City Sunday night and reached her just before she died. She is survived by the mother, her husband, who is in Klondike, a brother and sister. The body will be brought to this city for burial but no funeral date can as yet be set.

A small band of Warm Spring Indians were on the streets yesterday selling berries and berry-baskets. Excepting one other time during the spring months, this is their only visit, consequently excite much curiosity. The berries are being offered at 50 cents a gallon, which is a low price.

C. E. Tate, an employee of the Willamette mills, had his right foot badly crushed yesterday morning while rafting logs. Dr. Stuart thinks that no serious results will follow.

The funeral of Clinton Hart, who died yesterday, was held this afternoon at 1 o'clock from his late home. A large number of friends were present, after following the remains to the Mountain View cemetery. Rev. Montgomery officiated.

The County Board of Commissioners met this morning in regular monthly meeting. No important business was transacted.

Marriage licenses were issued yesterday to Albert Wood and Maude Scriver, W. E. Jones and Amy Wegand. The former couple were married during the afternoon by Judge Ryan.

A hop contract was filed yesterday by which J. H. Daly of Mackaburg agrees to sell 6000 pounds of hops a year for the years 1903-4. The price for both years will be 15 cents.

P. B. Hastings and J. B. Taylor have secured \$200 at 10 per cent from the Bank of Woodburn on a mortgage given on their growing hops.

Notice of appeal was filed yesterday by the heirs of the Green estate against the O. V. P. & R. Co. This case has already attracted much notice, so now the outcome is awaited with interest.
