DOINGS IN OREGON CITY

Clackamas County Items and Matters at the Big Falls.

(Journal Special Service.)
OREGON CITY, Sept. 18.—An adjourned meeting of the City Council was held last night for the purpose of considering and examining the street car franchise asked for by Chas. Latourette. Every Councilman was present excepting Francis.

After the meeting had been called to order by Mayor Dimick, on a motion it was agreed that the council go into a committee as a whole and report. Chas. Albright was appointed chairman and then the maps and drawings for the proposed road were presented by Mr. Latourette who was present to answer any questions and to watch matters generally.

The franchise, as finally adopted by the committee, was changed concerning two important points. First, the road is to be a single tracked one with all necessary switches and turn tables, instead of a double one; second, the owner or owners of the franchise must deposit within 90 days with the Recorder \$500.00 which will be a guarantee that the actual construction shall not begin later than the time specified in the franchise.

With the exception of the two sections pertaining to these matters, all of the sections were carefully gone over and passed, generally as they stood, until the last one was reached. This section provided for other companies that might want to come in on this street at some future date. An amendment was offered which would allow any other company to use this track provided it made a just and equitable compensation to the first company. This was vigorously objected to by Mr. Latourette. A vote showed that the amendment was lost and that the original section had been allowed to stand. The deposit had been objected to by Mr. Latourette but he agreed to give it on condition that his track would not be molested by any other company.

The franchise as amended was then adopted by the committee who dissolved and reported to the council. Thus amended the franchise will be read at the next regular meeting of the council.

The Mayor reported that he had in his possession \$300.00 received during the day from the Merchants' Association of Portland for the benefit of the Clackamas County fire sufferers. A committee consisting of Mayor Dimick and Councilmen Albright and Hunter, was appointed to take charge of and distribute the money as they thought best for the comfort of the fire victims.

After several minor matters the meeting was adjourned.

Although this town held no public meeting for the relief of the homeless people over the county, an abundance of clothing and food has been given and sent where it was most needed. In money and clothing there have been collected so far about \$2000 worth, which is enough to relieve the wants of every person.

Mayor Dimick said this morning that the \$300 received from the Portland merchants will probably be expended for lumber, beds, nails and such other things as are not donated.

In the opinion of many of the business men of this town and county the losses will amount to at least \$750,000. Very little insurance was carried, although in several cases the insurance will almost cover the loss.

A small-sized strike is being waged by members of section gang No. 3 of the Southern Pacific Company. It has been on several days and so far no new men have been secured. The men were receiving \$1.50 a day and demanded \$1.75, which was refused. Most of the men have gone to work elsewhere, as there is a job for every man now at this place. Judge Caples of Portland was a visitor in the city yesterday.

Mrs. Nelson Lawrence, who has been visiting her mother for several months past, will return to her home in San Francisco tonight.

The funeral of Mrs. L. O. Smith was held at 10 o'clock this morning from the residence of her daughter, Mrs. Grey. Interment took place at Mountain View Cemetery.

W. Tiffany, superintendent of the Oregon Water Power & Railway Company, was badly injured last evening while helping to switch cars in Portland. At a late hour it was determined that his injuries were not fatal.

Oregon City is shortly to have an acropolis of the Fraternal Order of Eagles. Deputy Organizer Clyde has been working for several days until now he has secured enough charter members. The first meeting will be held at the Red Men's Hall next Friday night. Members of the lodges at Baker City, Vancouver and Portland will be on hand to assist in the organization.

ALBANY.

ALBANY, Sept. 18.—George W. McCamey, who was struck on the head by F. H. Cooper in Brownsville Sunday, is still unconscious and there is no hope for his recovery. Cooper waived examination and was held under \$1000 bonds for the action of the Circuit Court.

Professor George D. Horner of Clatsburg, W. Va., the new professor in charge of the commercial department of Albany College, arrived yesterday morning, ready to begin his new work. The college reopened Wednesday with a full attendance. This year promises to be one of the brightest for the college.

Attorney-General Blackburn and wife have returned from Salem and will again reside in their old home on Caspovia street. Mr. Blackburn, on the completion of his term of office, will reopen his law office in this city.

ASTORIA.

ASTORIA, Sept. 18.—J. E. Rawlins, a Seattle attorney, is in the city to consult with the Astoria contingent of the fishermen who were employed at the Nushagak River canneries during the past season. The men are about to institute proceedings against the packers to recover payment at the rate of 3 cents a fish, the packers holding out for payment at the rate of 2 cents.

The announcement from Portland that the O. R. & N. Company would discontinue its San Francisco steamship line caused great surprise in this city. It was all along thought the steamers were doing a profitable business. At the local offices the agent stated that he had no official notification of the plan to withdraw the ocean boats, nor had the matter been communicated to the operating department.

Gus Bennett, second mate of the barkentine Quicksilver, is locked up in jail, charged with larceny. Bennett came ashore from the vessel with \$90 and made the rounds of the bad lands. He spent \$5 in one resort, and when he declined to further separate himself from his coin he was arrested for stealing a sum of money from one of the women inmates. Franklin avenue, a fashionable residence thoroughfare, is to be improved, and a petition is being circulated asking that crushed rock be used. The county owns a rock crusher and the city will be able to secure the necessary rock at slight cost.

Yesterday District Attorney Allen returned an indictment against Renna Mahan and William Lacey, two lads who recently planned to hold up E. A. Olsen. Both of the boys are express drivers and are well connected. They were held on \$500 bail for trial.

GRANTS PASS.

GRANTS PASS, Sept. 18.—An automobile occupied by Mr. and Mrs. G. W. Carmack, passed through Grants Pass yesterday on its way south. Mr. and Mrs. Carmack were on their way from Seattle to San Francisco and have made this much of the journey without serious mishap. They stopped in this city for a short time to replenish their tank with gasoline. During its brief stay the auto was an object of much interest to many here, as it was the first time one has ever been seen in Grants Pass.

Yesterday afternoon the body of Ed. Johnson, the man who was shot and killed last Sunday night by Cal. Griffin, was disinterred and a post-mortem examination held over the remains by Coroner Kremer. A post-mortem examination was found necessary in order to elicit several important facts required by the District Attorney. These facts concerned the matter of whether or not Johnson was shot in the back. The examination and verdict rendered by the coroner's jury did not produce these facts. Griffin swears that he did not shoot Johnson in the back, but a number of witnesses state that he did, and that he was attempting to flee when Griffin shot him down. The case will be one of importance. The prisoner will be able to defend. An attorney from Portland will aid in the defense.

Last spring a number of tea plants were planted in Rogue River Valley, near this city, the plants being furnished by the Southern Pacific Company for the purpose of experimenting. Report has been recently received here that the plants thrived excellently and that so far as growing is concerned, raising tea could be a success in Southern Oregon. It is not likely, however, that Southern Oregon farmers could compete with the cheap labor of Asia in the growing and cultivating of the tea plant.

The timber-trading business will soon be a thing of the past in Douglas County. From the timber-traders and locators will have a chance to catch their wind and warm up their bank accounts. Not for lack of patronage have these sons of the forest ceased their labors, but because there is none of the "forest primeval" remaining where on the verdant pilgrims from the regions beyond the Rockies may squat at so much per acre—usually from \$100 to \$200. These locators have been buying a sum not common to all men of localities. One in particular, with headquarters at Roseburg, has been besieged day and night during the past six months just gone by hungry, yearning souls, eager to get on a quarter section of timber land, where a grower vegetation, and, perchance, timber. At one time he took a party of 25 men into the mountains of Douglas County and located seven on homesteads for \$200 each. Another time he took out a party of nine, and throughout the summer he has made almost daily trips to the mountains with one or more timber seekers. Others have done nearly as well and altogether they have helped to land a goodly sum of Eastern capital in Douglas County.

OREGON BRIEFS.

Matt Jarvis is being held at Astoria for the murder of his father, Gabriel Jarvis.

The 37th year of Albany College was opened yesterday with a large attendance. The faculty remains the same as last year.

The watermelon season in Josephine County is now at its height, 25 carloads having already been shipped from Grants Pass.

Baker City's carnival and street fair was a disappointment, neither the attendance nor exhibits being up to expectations.

August Kangus, an escaped convict from the Oregon penitentiary, has been arrested at Pendleton. He escaped in July, 1898.

The 27th annual session of the University of Oregon was opened yesterday under the new regime—the presidency of P. L. Campbell.

The harvesting of the Oregon hop crop is nearing an end. The yield is now estimated at 80,000 bales, as against 90,000 earlier in the season.

The State Printing Office is fast finishing up the work of printing Bellinger's Code of the State of Oregon, authorized by the last Legislature.

Relief work is being carried on in Oregon City with the utmost dispatch, two wagons loaded with clothing and provisions leaving yesterday for Springfield.

J. D. Irvine, aged 60, justice of the peace at Independence, and an old Oregon pioneer, dropped dead at his home Monday evening, just after performing a marriage service.

What appears to be a great find of coal has been made in the Western Spur of the Blue Mountains, about 21 miles southeast of Heppner. The field is about 12 miles square and the coal is of high quality.

Jack Craig, editor of the Adams Advertiser, who disappeared recently, leaving sundry creditors to mourn, has been heard from in San Francisco. He says he was disgusted with the way things were going at Adams.

OVER THE WIRES.

Secretary Shaw says that no other securities than bonds will be considered in a plan to relieve the money market.

Fire, supposed to be of incendiary origin, destroyed the washery of the Taylor Company, at North Scranton, early this morning.

On being arraigned before Judge Brennan, in Chicago, yesterday, on the charge of tax-filing and forgery, Luke Wheeler pleaded not guilty.

The forest fires in Wyoming and Colorado have been brought under control although in several portions of both states fires are still burning to a considerable degree.

During the hearing of the St. Louis meat case yesterday, James Steinkamp testified that he had been compelled to sell bad meat while working for Chicago and St. Louis packers.

In an interview in New York yesterday Rear Admiral Lord Beresford said that the English are somewhat alarmed over the possibilities of the contemplated combination of shipping interests.

In a fight with a posse near Winslow, Neb., Neineghind, the Pierce County man who murdered his wife and her father, and wounded his mother and sister-in-law, was shot and badly wounded.

An extension of the Rock Island railroad from Asher, O. T., to Dallas, Texas, was incorporated at Guthrie, Okla., under the name of Choctaw & Chickasaw Railroad Company, with a capital of \$1,000,000.

The London Graphic, in speaking of the shooting of Marriot, the San Francisco editor, severely criticizes the laws of California, and other states, wherein a man who attempts murder is given his liberty, pending the result of the assault.

The five Governors of the civilized tribes will hold a meeting at South McAlester, I. T., on September 26, for the purpose of formulating a plan for bringing the Indian Territory into statehood at the expiration of tribal government in 1906.

Benton Powers, of Ashland, has purchased the Hybee tract, on the Rogue River, of William Bybee, for \$13,000. There are 450 acres in the tract, 250 of which are located at Rogue River bridge, and 1500 acres on the Antelope.

An appeal to the Vatican has been made by Monsignor Enrique Perez, procurator of the Spanish Revolette Fathers in Rome, in which he contends that his order in the Philippines is the victim of injustice, and asks for protection by the Government.

A resolution providing for the electing of a court of appeals was presented at the annual meeting of the Milwaukee diocese of the Methodist Episcopal Church yesterday. The power heretofore vested in the bishop will be given to the court.

While standing in front of the bureau dressing, at her home in Roanoke, Va., last night, Mrs. Emerick was shot and killed by her niece, Mabel Carroll, aged 15 years. The girl snatched a revolver which she claims she did not know was loaded.

Word was received from Colon, Colombia, yesterday, that Commander Potter, of the United States cruiser Ranger, would today place guards on the trains running across the Isthmus. The Cincinnati has also landed a small rapid fire gun and 50 marines.

In an opinion filed with the Governor of Iowa yesterday, Attorney-General Mulien holds that the new Iowa corporation, the Chicago, Rock Island & Pacific Company, in connection with the Rock Island reorganization, cannot be called a merger scheme, under the laws of the state.

In the campaign in Porto Rico which has just commenced, there will be three political parties in the field. Besides the Republican party, which is now in power, there is the American Federation and the Unionists. It is impossible to forecast results as no nominations have yet been made.

According to a cable received by the London Mail yesterday 50,000 Bovers have surrounded Cheng Tufu since September 17, and that unless immediate help is rendered the city must fall. If Cheng Tufu is taken an uprising is inevitable as the feud between the Protestant and Catholic converts is very bitter.

A request has been made by the East Mark Society, having a membership of about 25,000, asking the German government to require Polish newspapers, hostile to Germany, to print a translation, in a parallel column, of all their editorial utterances, and to exclude from the mails all matter addressed in the Polish language. The society also opposes the establishment of a German university at Potsdam.

Money Per Capita.

The population of the United States on September 1, 1902, is estimated by the Treasury Department at 79,344,000, and an increase of \$67,143,121 of the money in circulation during the year ending with September 1, 1902, made an increase of only 37 cents in per capita circulation. The estimated population of the United States on September 1, 1901, was 77,986,000. The estimated increase for the year was 1,359,000. The per capita circulation on September 1, 1901, was \$79.18. It required \$38,294,620 to supply the 1,359,000 new population with \$23.13 each, so that of the increase of \$67,143,121 of money in circulation, only \$28,846,501 remained to increase the per capita circulation by 37 cents.

It is essential to the maintenance of prices that the per capita circulation should not be reduced materially. To prevent this there should be an annual creation of new money to the amount, as shown above, of about \$39,000,000.

No such increase of national bank circulation is possible under existing laws and conditions, but it appears from the record that the increase in the circulation of gold in the form of coin and certificates during the year ended August 31, 1902, was \$47,473,628, or more than enough to maintain the per capita circulation of September 1, 1901.

The increase of gold coin and certificates in circulation from September 1, 1901, to September 1, 1902, was \$58,296,294. The general stock of gold coin and Treasury bullion in the United States increased during that year \$98,498,141. During the year ended September 1, 1902, the general stock of gold coin and Treasury bullion increased \$55,676,606.

The maintenance of the per capita circulation depends upon the gold produced by the mines of the United States, Canada and Mexico and upon the amount of that gold which is retained in the United States converted into coin and exchanged for gold certificates.
