

WAS BUT A FARCE

Trial of Hellen in Police Court.

MAYOR DISPLEASED.

Banker Mills Thinks Gamblers Were Notified of Impending Raid.

Mayor Williams and Police Judge Harry Hogue have had a conference over the handling of gambling cases in the Municipal Court. Judge Hogue called upon the Mayor of his own volition to talk the matter over and get the chief executive's views.

"Judge Hogue explained to me," said Judge Williams this morning, "all about the arrest and prosecution of the four negroes caught playing poker, the Chinese fan tan players and Frank Hellen, manager of the Portland Club gambling house. I listened attentively to what Judge Hogue had to say, as I am deeply interested in the crusade against gambling and kindred vice and am giving every move my closest attention.

"Then I clearly defined by position to the judge. I told him that I am using every effort to stamp out banking games of every description. I do not want to hear of a single roulette wheel turning, a faro layout in sight, a set of crap dice in operation, or a stud poker game running. I have given

DRAW POKER GAMES a great deal of study and am not yet in a position to define myself. This is a hard matter to decide in my mind. The various clubs all have their card rooms where members sit down for a sociable game and depend upon their skill to beat the others. All have a common interest in the game and are not playing up against a strong percentage, which of course every banker of a game has in his favor.

"I also told Judge Hogue that I was not pleased with the way the cases had been handled in the Municipal Court. There seemed to be a lack of forethought,

A LACK OF ENERGY, or something which I could not see through. Judge Hogue assured me that he thought Deputy District Attorney Fitzgerald was an excellent prosecuting officer and I did not deny that but I still maintain that the cases were not handled right. Banker A. E. Mills was summoned to serve on the jury which tried and acquitted Hellen and he called upon me and said that the

TRIAL WAS A FARCE, inasmuch as he was satisfied in his own mind that the gamblers were warned in advance of the raid and prepared themselves accordingly. When the officers arrived and made the arrests Hellen and others were present in the gambling house but while the paraphernalia was in evidence they were not actively engaged in gambling. Yet they were charged at the police station and tried for gambling. How silly.

"I am satisfied that if I had the drawing of those complaints, I would have convicted every mother's son of them. What's the use of charging a man with gambling when you have not a scintilla of corroborative evidence? There is a law against visiting a gambling house. They were clearly guilty of that. Why were they not prosecuted under a charge like that. Then again a man can be prosecuted for having gambling implements in his possession and the same can be confiscated and destroyed. Was not Mr. Hellen guilty on this count? I tell you there is

SOMETHING WRONG somewhere and I shall endeavor to find out where it is and provide a remedy." Judge Williams is not at all in a good humor over the way his ideas about suppressing vice are being carried out.

STRIKE SETTLED.

LOWER DEATH RATE

Report of Surgeon-General Shows Decrease.

WASHINGTON, Sept. 20.—The War Department today made public the annual report of the Surgeon-General for the year ending July 1. The total expenditures were \$200,000, and 104 men killed by gunshot wounds in the Philippines. The total death rate in the Philippines was 19.91 per thousand, as compared with 27.74 last year.

Cattle Department Attracts Attention.

LADD'S FINE HERD

Best Imported Bull Ever Brought to Oregon—Other Awards Are Made.

Division B in the cattle department at the State Fair this year was the center of attraction to every admirer and breeder of fine cattle who visited the show. Sixteen head of shorthorns from the Oak Hill farm of Mr. Chas. E. Ladd, of Portland, claimed a lion's share of the attention. Lord Derby, head of the herd,

looked every inch the king he is. His is the distinction of being the first imported bull brought to the state of Oregon. He is a massive bull of fine quality and not yet at maturity. He is a show animal of the highest class in every sense and a winner in any company. The judges this year declared him first prize bull 3 years old and over and sweepstakes bull 2 years old and over.

Eighty 25th grand sweepstakes cow of last year's show, is beyond all doubt a fitting showmate for Lord Derby. Of cows in the shorthorn class, 3 years old or over, the judges place her first year and sweepstakes cow 2 years old or over.

Royal Hope, a magnificent specimen of his breed, bids fair to be a close competitor of Lord Derby in the show ring of the future. This fine animal was calved April 15, 1900, placing him in the 2-year-old and over class, in which he is judged first. Royal Hope is of the same foundation family as the great show cow Elgitha 25th.

to whom falls second honors in the yearling bull class. He is every inch a show bull and must be in fine company indeed to be forced from first place.

First prize bull calf, Money-maker, calved November 27, 1901, has all of the show points which marked his illustrious ancestors and bids fair to develop into a top-notch.

Lovely Lady, calved January 24, 1901, is sweepstakes heifer under 2 years, and is an animal of wonderful promise in the show ring.

Mr. Ladd has reason to congratulate himself upon his success at the Fair this year. It is admitted by competent judges that the stock shown here this year is of equal quality with the stock shown in any part of the country, and N. H. Gentry, president of the Missouri State

Fair Association, who judged the shorthorns this year, commented upon the fine quality of the cattle in this class in words that must have been gratifying indeed to Mr. Ladd.

Mr. Chas. E. Ladd's success in the show ring leaves no question as to who is the best breeder of shorthorns in the state. Constant study, the judicious expenditure of money, in improving his breeds and unceasing work has steadily raised the grade of his stock to its present state of perfection. The effort to improve and grade up stock has become general throughout the state, and to the Oak Hill farm breeders is due much of the credit for stimulating these efforts into life.

INDIAN SERVICE

Change on the Umatilla Reservation.

PENDLETON, Or., Sept. 20.—The Government has effected a marked change of affairs on the Umatilla reservation. The agency has been done away with and hereafter the interests of the Indians and Uncle Sam will be under the direction of a bonded superintendent. Charles Wilkins, who has been agent for the past four years, has been appointed to that position and Miss Mollie V. Galtier, who has been a teacher on the reservation for nearly 10 years, will be the assistant superintendent.

This change has been under contemplation by the Government for several months.

Under the present ruling of affairs there will be practically no change in the handling of the Umatilla Indian reservation. Mr. Wilkins will remain at the head and the only material change will be in name. He will continue to handle the business connected with the reservation and Indian affairs, while Miss Galtier will continue at the head of the school where she has been for the past nine years.

Mr. Wilkins was appointed agent by President McKinley and during his incumbency has given perfect satisfaction to the Government officials, as well as to the Indians and to all those who have business dealings with the reservation.

Miss Galtier is, universally liked and respected by all with whom she has come in contact. She has handled the Indian School with credit to herself and in such a way as to inspire confidence and promote the educational interests of the Indians. The appointment of superintendent is perpetual, or as long as he gives satisfaction. He is responsible to Indian Commissioner Jones alone, and may hold his position so long as he faithfully handles the affairs of Uncle Sam.

Mr. Wilkins' salary remains at \$1200 per annum, and Miss Galtier's remains at \$1000.

WOOL MEN ADJOURN.

PENDLETON, Sept. 20.—The Wool-growers' Association has adjourned and nearly all the delegates have gone home. The last session was perhaps the most interesting and harmonious ever held. It was expected a great fight would come up over the adoption of the new constitution, but it passed without a dissenting voice.

Upon the urgent request of Mr. Ayers, of Baker City, the Association decided to hold its next annual session in that city.

Resolutions of thanks to the Commercial Association, and to the people of Pendleton, for uniform kindness and liberality, were unanimously passed.

The Northwest Livestock and Wool-growers' Journal was selected as the official organ of the association, and Mr. Lockley, of the Journal, was chosen organizer.

The main subjects of discussion on the last day were the scalp bounty question the forest reserve, purchase of salt by the wholesale and the general welfare of the association.

The new constitution was suspended until January 1, 1903, the association to work under the old constitution and by-laws until that date.

The salary of the secretary was fixed at \$120 per year; the members promptly paid their dues, and the association adjourned.

The price of hop-picking has been raised from 80 cents to \$1.00 in Lane County as a result of the strike in Thornsbury & Campbell's yard.

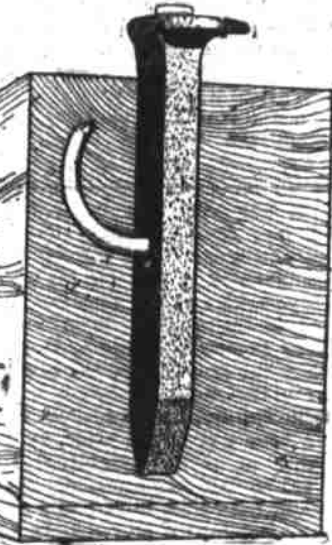
