DOINGS IN OREGON CITY

Clackamas County Items and Matters at the Big Falls.

(Journal Special Service.)
OREGON CITY, Sept. 25.—Owing to the fact that several of the subscription lists are still out among the people, it is impossible to state the exact amount of money thus far subscribed, but with yesterday's amounts added the total will reach near the \$500.00 mark. A meeting of the committee, appointed by the Mayor at the last council meeting to attend to the funds, was to have been held last evening in the Mayor's office, but as all were not present, nothing was accomplished. Mr. Dimick will leave for Springfield next Saturday evening or Sunday morning for the purpose of becoming in actual touch with the stricken people, which will enable him to gain an idea of what is most needed and how the money shall be expended to the best advantage. From reports received during the past week the money is needed most to buy seed wheat, lumber, nails, table ware and bedding, but the Mayor will inform himself by observation before proceeding to act on reports.

THE PUBLIC SCHOOLS.
As was expected, the enrollment at the public schools is larger this year than ever before. The Barclay school has the names of 229 pupils on its rolls, while the Eastern has an attendance of 250. With the exception of one or two rooms the different grades are not crowded at present but probably will be before Christmas when the heaviest enrollment takes place.

TO ORGANIZE FOOTBALL TEAM.
There is a movement on foot to organize a football team for the present season by members of Company A, O. N. G. and others who are interested in the game. There is no scarcity of material, for Oregon City has men who have played for the past several years on teams which have left good records in their wake. The only thing that will stop this town from having a winning team will be the men themselves if they should organize and then fail to practice. A meeting will be held this evening at the Armory when a temporary organization will be made, providing enough interest is shown.
