

REQUEST A HALF MILLION

Of the State for the Lewis and Clark Fair.

MEANS A LEVY OF 1 3-4 MILLS

Ways and Means Committee Meets
--Decides on Appropriation.

Five hundred thousand dollars is the sum that will be asked of the state for its appropriation towards the Lewis and Clark Fair. Five of the additional ten directors to be selected at the meeting of the stockholders on October 6 will be residents of Oregon outside of Portland. This was decided on at a meeting of the ways and means committee of the Lewis and Clark Fair last night. Those present were W. D. Fenton, I. N. Fleischner, G. W. Bates, A. H. Devers, J. F. O'Shea and Adolph Wolfe.

DUTY OF LEGISLATION COMMITTEE
The recommending to the state of an appropriation for the 1905 Fair is really the duty of the legislation committee, but as yet no such committee has been appointed, so the ways and means committee took the matter under discussion and decided to recommend to the legislation committee, which will be appointed on October 6, an appropriation of \$500,000.

The question of whether this appropriation should be taken from the general fund, by the legislature, or raised by a special tax, was discussed thoroughly, and finally it was decided that it would be best to have an appropriation made, the funds to be raised by a tax of 1 3-4 mills. This tax would make the total levy of the state 7.71 mills.

GETS EIGHT YEARS

MADRID, Sept. 25.—Senor Arana, who sent congratulations to the independence of Cuba to President Roosevelt, was today sentenced to eight years in prison by the Bilbao court.

Considerable displeasure is being expressed here over the verdict in the case of Senor Arana, who has been on trial for having sent to President Roosevelt congratulations on the independence of Cuba. The trial was conducted in the Bilbao court and watched with interest by sympathizers on both sides.

After the case had received the proper consideration and the evidence was thoroughly investigated the court rendered a verdict which sentenced the accused to imprisonment for a term of eight years. On the declaration of the independence of Cuba, Senor Arana became very enthusiastic in his demonstrations of satisfaction and sent a cable to President Roosevelt which contained hearty congratulations on the realization of this independence. Of course the Spanish government could not stand for that, and in consequence Senor Arana will have to go to prison unless he can in some way reverse the decision of the court.

RAIN INTERFERES

McMINNVILLE, Sept. 25.—On account of rain the attendance yesterday—the opening day of the Harvest Festival Civil Soldiers' Reunion—was small, yet towards noon the sun shone, and the afternoon was nice. Governor Geer spoke in the afternoon. The free exhibitions given by the Japanese and other attractions were given, but the program as intended was deferred off. In the various buildings many beautiful displays were made, and many words of commendation were heard. The Chemsaw Band is here and their music is first class. Tomorrow if the weather permits the program as announced will be carried out, and an extra effort made to see that strangers are well entertained and glad that they came.

COFFEE DRINKERS

WASHINGTON, D. C., Sept. 25.—Unquote Sam is a great coffee drinker, the coffee imports for 1901 amounting to \$63,000,000. Over two-thirds of these imports came from Brazil, that country sending shipments worth \$45,000,000. After Brazil the largest contributors to our coffee trade in the year mentioned were Venezuela and Guatemala.

The imports from Venezuela were valued at \$4,630,000, and those from Guatemala \$3,180,000. The shipments received from Mexico were unusually small, having a value of only \$1,900,000. Costa Rica, the Dutch East Indies, and Colombia were the other sources of importation, sending shipments worth more than \$1,000,000. The value of the imports from Costa Rica was \$1,511,000 from the Dutch East Indies, \$1,320,000; and from Colombia \$7,192,000.

ELECTED OFFICERS.

GEO. BALDWIN TESTIFIES

Gives His Version of Fatal Fight With Frank Carlson.

The defense in the Baldwin manslaughter trial opened its case this morning with Walter S. Norton, a barber, on the stand. Before any of his testimony was taken he was withdrawn until this afternoon. Mrs. William Baldwin testified as to the condition of her son after his two fights with Frank Carlson.

George Baldwin was then called. He testified that a week previous to the fatal fight while on his way home he met deceased with two girls (Ida Fiedler and Josephine Smith). One of the latter remarked as he passed: "There goes that — — — Shorty Baldwin." He paid no attention to the remark but continued on his way. One of the girls then accosted him and they were talking when Carlson and the other girl came up. Baldwin said that he was having some hot words with the girl when Carlson championed her cause. One word led to another and a fight resulted in which deceased was knocked down twice.

FIGHT ARRANGED.
During the next week one of the Carlson boys came down to the mill where defendant worked and told him that it was all arranged for him and Frank Carlson to fight it out the following Sunday night. The following night he was

again warned to be on hand as they, the Carlson boys, would "get him on the streets and do him up good." He consulted his father and they decided to take up the challenge and were at the mill at the appointed time.

THE FATAL MEETING.
One of the Carlson boys said: "This is to be a fight to a finish, rough and tumble." Baldwin testified that he objected, owing to the difference in weights. But finally they went at it and Baldwin knocked Carlson down, falling on top of him. Then this conversation is said to have taken place:

Carlson: "Shorty, I'm not mad at you; are you at me?"

Baldwin: "No, Frank, I'm not mad at you."

The Carlson boys insisted on their brother fighting it out and the mill was resumed.

NOSE BROKEN.
Baldwin hit Carlson in the nose, breaking it. They then fought and clinched for about 15 minutes, when he again hit his opponent in the nose. Carlson took out his handkerchief and holding it to his nose with his head bending forward, wobbled a moment, and then fell backwards unconscious.

Baldwin then said he did not remember hitting any solar plexus blow. He also told about giving himself up to the police.

LEGISLATION FOR CHARITIES

The Programme Agreed on for the Coming Legislative Action.

The next state legislature will find a considerable amount of legislation to consider, on behalf of the state charities interests. The following are some of the subjects that will come before the body, on each of which there will be a bill presented:

Creation of a state board of charities and correction.

Education of the feeble minded.

A school truancy law.

Extension of the age limit for commitment to the reform school.

Commitment of females to the insane asylum in charge of female attendants.

The foregoing is the result of the meeting of the Oregon State Conference of Corrections and Charities, held yesterday with the city board of charities. The following were present: Dr. T. L. Elliot, Dr. Stephen S. Wise, W. R. Walpole and W. T. Gardner. In the vacancy existing in the executive board, Mrs. B. H. Trumbull was chosen. Among matters also considered was the legislation against child labor that will be urged by the labor organizations, which the charities committee will assist all in their power.

As to the charities legislation above outlined, the state board plan is that adopted with so great success in many of the eastern states. The age of commitment of minors is to be 18 years, an extension of the present limit. The reform as to commitment of female inmates is for the purpose of relieving sheriffs and other male officers and is manifestly an improvement over the present plan. The charities committee will co-operate with the committee on legislation recently appointed by the Woman's Club.

NEW OKLAHOMA ROAD.

TEXARKANA, Sept. 25.—A territorial charter has been granted to the Kansas, Oklahoma & Southwestern Railroad, with a capital of \$1,500,000. The incorporators are Oklahoma capitalists. The proposed line will run from Cedarville, Kan., south, west through Stillwater, Guthrie and Reno, Okla., to Kinkaid, Texas, and will have two branch lines, one from Stillwater southeast to Fort Smith, Ark., and the other northwest to Woodward, Okla., on the Texas border. The total distance will be 400 miles. The principal place of business will be Stillwater.

CRIMINAL MATTERS.

Judge George this morning denied Baldwin the triple murderer, a new trial. He held that the grounds taken by the defense in their motion were without foundation. Until October 15th was given to file a bill of exceptions.

Upon motion of the district attorney the charge of robbery against Chester Harvey was dismissed this morning.

The chances of conviction being very slim, it was decided to save the county the expense of another trial.

The pleading on motion for judgment in the case of Mary A. Stockpole vs. Northern Pacific Railway Company was set for hearing on October 6.

FATAL EXPLOSION

Residence Wrecked by Gas Injuring Several Inmates.

ST. LOUIS, Sept. 25.—One man fatally injured and two other persons badly hurt was the result of an explosion of gas in a residence in this city this morning.

The residence of a well known family was wrecked here this morning by an explosion of gas in one of the rooms. William Barnes received injuries which will prove fatal and Mrs. Albert Munn and her son Thomas were so badly hurt that serious results may follow. The house was badly wrecked and narrowly escaped burning.

The explosion was caused by Mr. Barnes lighting a match in a room that was full of gas that had escaped from a break in the pipes. As he entered the room he smelled an odor of gas and supposed that the jet had been left turned on by some one and as it was somewhat dark he struck a match, intending to locate the leak, but no sooner had the match been lighted than the room was filled with a solid sheet of flame of burning gas. The explosion that followed was terrific and shook several buildings in the neighborhood. Mr. Barnes was severely burned besides being thrown against the walls with such force that he received injuries which will almost certainly cause his death.

NO DANGER

President's Wound Is Free From Bloodpoisoning.

INDIANAPOLIS, Sept. 25.—A microscopic examination of the contents of President Roosevelt's wound was made this morning by experts, all of whom agree that there were no traces of dangerous matter found in the serum and that there is nothing to cause blood poisoning.

CONDITION SATISFACTORY.
WASHINGTON, Sept. 25.—Dr. Rixey this morning announced that the President's condition was satisfactory.

CHINESE CREW ARE PRISONERS

The work of lining the British steamship Lime Branch was completed this morning. This afternoon she moved to the Irving dock where she will begin at once to take on her cargo of wheat, oats and barley for the United Kingdom.

The Lime Branch has a crew of 23 Chinamen who are practically prisoners. All they can do is to stand and gaze at the American soil, but they do not dare set foot upon it. Every avenue of escape from the vessel is guarded by United States custom officials and there is no possible show for the Celestials to get ashore.

WATCH THEIR CHANCE.
They possess the Oriental cunning in a marked degree, and if given the least opportunity to do so they would make their escape. While occupied at their work they are continually casting furtive glances at the guards. One of these officials said:

"If one of these fellows should get ashore and succeed in reaching the Chinese quarters it would be almost impossible to locate him. He would be spirited away by his countrymen, and it would be throwing time away to make a search for him. It requires constant vigilance on our part, particularly at night, to keep them aboard. All of them have heard how Chinamen prosper here, and it is the height of their ambition to come to America. At night our force is doubled, and even then I would not be surprised to see some of them sneak out into the darkness and disappear."

Runs an Orphan Asylum.

The Queen of Italy is caring for 50 children, all boys, whom she is educating, and will have them taught a trade. An enterprise of a somewhat similar character is being backed by the Dowager Empress of China, who intends to establish a girls' school in the palace at Peking. Ten daughters of princes will be the students. A female teacher will instruct them in English, that they may act as interpreters when the Empress entertains the wives of foreign Ministers.

Duff Is Buried.

The funeral of James Duff, the young man who died as the result of injuries received at an explosion at the Williametta Iron Works the other day, was held this morning from his late home at Woodlawn. The body was taken from the residence to St. Mary's Catholic Church in Albina, where the services were held.

CUMMINS IS BITTER

Accuses Speaker Henderson of Petulancy.

WRATHY INTERVIEW

Governor of Iowa States His Position—Says He Never Advocated Free Trade.

DES MOINES, Iowa, Sept. 25.—Stung by an interview accredited to Speaker Henderson at Atlantic City, accusing him of favoring free trade as a weapon against the trusts, Governor Cummins today issued a bitter interview, in which he accuses Henderson of petulancy owing to the discovery that he was out of harmony with his constituents. He denies that directly or indirectly he ever advocated free trade as a trust remedy, and asserts that the Iowa platform means that monopoly whether established by trust, partnership or individual, is not entitled to the benefit of tariff duties. That if this were the law it would effectively prevent the creation of monopolies.

"GAMS" CONVICTED

Jury Finds Band of Chinks Guilty of Gambling.

Samuel Connell, J. G. Luckel, M. J. Malley, H. A. Belding, W. E. Prudhomme and Carl H. Jackson acted as jurors in the gambling case tried yesterday afternoon. After being out nearly four hours they brought in a verdict of guilty in the case of 20. Seld Beck and two other Chinamen were dismissed, as they proved that they did business at the place and were not gambling. The officers who made the raid testified that they had on September 1 broke into a house on Second, near Burnside, and there found the defendants engaged in playing craps and "21." The gambling apparatus was all introduced as evidence in the case. An electric light globe was also introduced as evidence, when was hanging in the entrance to the place. On this was printed "Gambling Upstairs, Twenty-one."

The doors were found locked at the time the raid was made. Everything indicated that the defendants had assembled for the purpose of gambling, and were engaged in that pursuit. The sentence will be given later.
