 "There are enough teachers in the state possessing the necessary qualifications and papers, to fill all the positions, but they are not all teaching, many of them holding to the remuneration is insufficient to warrant them in taking up the work; that while there has been an increase in the average monthly salary of teachers, yet said increase has not kept pace with the increase in the cost of living, and the further fact that the opportunities for securing employment in other lines have materially increased."

The ordinance was then read and adopted section by section. On an amendment by Kuerner the first section was changed so that there will be no tracks on Third street east of Main street. A single track instead of double tracks on that street is the amendment added by Albright to section 2. When section 10 was reached, Al. E. D. Kelly objected to the ordinance, but was sustained by the Council. They named the license to be paid to be \$40 per year for the first five years, and \$50 per year for the remaining five years. Their amendment was adopted. As they amended section 11, the life of the ordinance is reduced from 25 years to 10 years, this section also being adopted.
 After it has passed another reading by the Council at a regular meeting, the document will be ready for the signatures of those concerned. As the matter now stands, all of the merchants and the manufacturing plants are in favor of granting this ordinance, while a portion of the property owners on Main street are against. Seventeen and two-thirds lots on the improved portion of the street are in favor of it, 19 1/2 lots are against it. While 10 lots have not been heard from. The city will receive for the privilege granted the sum of \$150 for the 20 year term.

SOME LEGISLATION

Representative Burrell, of Wallowa, Prepares a Few Bills.

JOSEPH, Ore., Oct. 7.—State Representative Burrell, of Wallowa County, states that he will introduce in the Legislature this winter the following bills:
 A bill for a state primary law, providing that nominations for county and district officers be made by direct vote of the people under the Australian ballot system.
 A bill providing that assessments shall be made by precinct assessors; that assessments shall begin the first day of January; that the tax roll be in the hands of the collector by October 1, and taxes become delinquent December 1; that the treasurer shall be the collector and that it shall be compulsory to collect a tax within the time limit and be and his bondsmen be liable for all taxes remaining unpaid at the expiration of the time limit are deemed collectable.
 A bill providing that sheep shall not be herded within a mile of any ranch or homestead.
 A bill providing that stockmen grazing their stock in a country where they are not bona fide residents shall pay to such county a rental per head on the stock thus grazed within the county.
 It is needless to add that Mr. Burrell does not expect all these bills to become laws, but he believes that they should be enacted into law. Mr. Burrell also believes that thus far the scap bounty law has accomplished the desired results and he will resist its repeal.
