NEWS OF THE STATE CAPITAL

Matters of Interest of and to Salem and Marion County.

(Journal Special Service.)

SALEM, Oct. 11.—Edgar Hobart and Huxley Galbraith, aged 16 and 11 respectively, were yesterday arrested near Silverton and brought to Salem on a charge of having killed Chinese pheasants and having them in their possession on September 23, during the closed season. The warrants were issued on complaint of Alonzo Brown, deputy game warden. When the two boys were brought into court, Deputy District Attorney C. L. McNary dismissed the charge against the younger boy, while young Hobart pleaded guilty and was fined \$5 and costs, which was promptly paid by the young man's father, the total cost of the two birds, as measured by the fine and costs, being \$28.30. Young Hobart insisted on serving out his fine in the county jail, but his father, one of the most respectable farmers of this county, would not listen to it, but insisted on paying the fine and costs at once.

AN OFFICE ABOLISHED. The report in yesterday's dispatches from Washington that the position of Superintendent of the Cascade Forest Reserve, held by Captain S. B. Ormsby, of this city, had been abolished did not occasion a surprise to that gentleman, as he said he knew the office would be abolished under the new Bureau of Forestry, and he expresses himself as perfectly satisfied with the arrangement. Captain Ormsby, in an interview yesterday afternoon, stated that it was his intention to leave the service at the end of the year, whether the office was abolished or not, and when Commissioner Binger Hermann, of the General Land Office, was in Oregon in August last, it was the understanding with that gentleman that Mr. Ormsby would retire at his pleasure.

THE HOP MARKET. Quite a few hops are beginning to move in this section, and the dealers are all extremely busy taking in samples and arranging for the moving of hops at an early date. Dealers last night stated that the market was firm and strong.

OREGON BRIEFS.

The Lents school district at Mount Scott will build a schoolhouse to replace the one destroyed by fire, to cost about \$3000. The directors have decided to erect a two-story structure and to finish two rooms on the ground floor for present use. The number of children of school age in the district is 114.

The O. R. & N. Co. has libeled the Cypresses for \$3000 damages caused the Hassalo in the collision near Near City, opposite Kalama. The neglect charged is that of anchoring in the steamboat channel.

Mr. C. Gasley, the well known prune buyer, is in Roseburg and vicinity making purchases of the local crop. He has already bought 30 carloads of prunes in this county this season. He made the first shipments of 1902 prunes from this state.

The Sunnyside Milling & Mining Company, of Oregon City, with a capital stock of \$1,000,000, has filed in Salem articles of incorporation. The incorporators are Dr. R. Goucher, S. W. Minton, W. A. Hogg, Walter Adam, Frank A. Wheeler and G. G. Holt.

Several hop sales were reported at Salem Friday, at 23 cents and better. Twenty-five cents will probably move some thousands of bales that are in the growers' hands, waiting for the market to come up to that point.

Agricultural Hall, at the Oregon Agricultural College, was accepted by the building committee of the board of regents Friday, and settlement made with the contractor.

PENDLETON, Oct. 11.—The City Council has settled the bicycle question. By paying 50 cents a month license bicyclists can ride the sidewalk from October 15 to April 15. THE NEW HARVESTER.

Since it has been proven that the Rigby-Clove harvester is going to be a success and will revolutionize the harvesting methods in the Northwest, it has been decided to build a manufacturing establishment somewhere in this part of the country to turn out the machine for the farmers. Portland would like to have the plant, Alhena has already been making overtures to the inventors for the establishment of the plant there, while Pendleton has practically done nothing to secure it. A company will be organized within a few days for the manufacture of the machine and then steps will be taken toward finding a location.

OBSTRUCTION OF STREETS.

A great deal of complaint has been heard lately about people of Pendleton using the streets as a public dumping ground. Street Commissioner Fee has declared war against the practice. People have a habit of using the streets to dump piles of wood, or whatever it happens to be, leaving them in the streets for days at a time regardless of the ordinance prohibiting this. The matter has not been strictly looked after in the past but in the future it will be different.

OREGON CITY, Oct. 11.—By the first of next February Oregon City will have an elevator with a capacity of fully 100 persons per trip running from lower Sixth street to the bluff overhead. This is a proposition that has been under contemplation for nearly 20 years and now its consummation is assured. The man at the head of this is County Judge Thomas F. Ryan, who returned the first of the week from a six-weeks' visit to Eastern cities, where he spent some time examining appliances of this kind with a view to utilizing them in this city, where conditions are such that thousands of people who work in the factories down town and on the west side of the river, and a large number of business men, all of whom reside on the hill, are compelled and have been for many years to endure the fatigue of climbing a long flight of steps in all kinds of weather to reach their homes. Judge Ryan found nothing in the East in the way of elevators to satisfy him and as a result the company of which he is the prime mover, will draw its own plans to meet the difficulties confronting them. It is proposed to organize a company without delay and construct an elevator at the west end of lower Sixth street, where it meets the Southern Pacific railroad tracks, run the shaft straight up in the air to a level with the bluff, a distance of about 100 feet. From the bluff the shaft will be extended out to meet the shaft so that passengers will be able to step from the elevator on to the street and be on a level with their homes. Whether electricity or hydraulics will be used for power is yet to be determined. The former is the cheapest to construct and the most expensive to operate and the latter is just the reverse. Many years ago Judge Ryan secured a franchise from the city and will work under this for the present at least. The shaft will be within the reach of all and will be placed so low that everybody may afford to ride. The news of the approaching construction of the elevator will be hailed with delight by residents of the hill, who will gladly welcome the end of a climb which is always tedious and difficult. Along the edge of the bluff, in connection with the elevator, a path will be made, so that strangers and Eastern visitors may be given an opportunity to see Canemah Park and obtain a fine view of Willamette falls and other scenes of interest.

Mrs. Alfred Corning Clark, Becomes Mrs. Henry Codman Potter.

RICHEST DIVINE IN AMERICA

Said to be Worth \$25,000,000, While His Wife has Nearly as Much More—After the Ceremony Mob Carried Away the Flowers and Other Decorations of the Church as Souvenirs of the Occasion.

ROCHESTER, N. Y., Oct. 5.—

At noon today Mrs. Alfred Corning Clark and the Right Rev. Henry Codman Potter were married in Christ Episcopal Church here. The ceremony was performed by the Rev. Dr. William Mercer Grosvenor, assisted by the Rev. Dr. W. W. Lord. For fifteen minutes before the appointed hour for the ceremony a continual stream of carriages conveyed the guests to the church. No one except the guests was allowed inside the churchyard. Uniformed guards were posted at the gates and in other places around the church.

Promptly at 12 o'clock a carriage rolled out of the Clark grounds, almost opposite the church and white ribbons on whip and harness betokened the carriage of the bride. There was a hush as the carriage approached the church and the bride and her maid of honor, Miss Mary Chaffee, and Mrs. F. D. Woods, of Philadelphia, alighted. The procession formed quickly in the vestibule and at the first strains of the familiar march from Lohengrin the bridal party entered the church. The ushers were Edward Severin Clark, Frederick Ambrose Clark, Stephen Carlton Clark, Waldo C. Johnston and Sutherland G. Irving. The bride entered on the arm of her second son, Lieutenant Robert Sterling Clark, who gave her away.

The bride wore a gown of white satin crepe de chine, trimmed with point applique lace. She wore a dainty fichu of point applique lace and carried a shower bouquet of lilies of the valley. At the church the bride's party was met by Rev. Dr. William Mercer Grosvenor, rector of the Church of the Incarnation; the Rev. Dr. W. W. Lord, and the Bishop and his best man, the Rev. Dr. George F. Nelson, formerly of Grace Church, New York. The Rev. Dr. Grosvenor read the ceremony and the Rev. Dr. Lord pronounced the benediction.

Following the ceremony the following musical program was rendered by the regular organist, Ernest E. Leigh: "Wedding Prelude," Sir George Elvey, as played in St. George's Chapel, Windsor, at the wedding of His Royal Highness, the Duke of Albany; "Gavotte," from "Mignon," Thomas; "Festival Prelude," Leigh; "Pilgrim Song of Hope," Batiote, and an offertory in E flat, Wey.

After the ceremony the Bishop and his bride were driven to Farnleigh, where the wedding breakfast was served. Less than twenty-five guests were at the house, and the breakfast was served by the regular chef of Farnleigh. The reception was devoid of all formality.

The Bishop and his bride left Cooperstown on a special car attached to the regular 3:35 train this afternoon. There was a crowd at the station, which included most of the guests at the wedding. As the train pulled out the bride appeared on the car platform and returned the salutations with a wave of her hand. She discovered, but too late, that trailing behind the parlor car were yards of white ribbon and old shoes galore.

Carried Away the Flowers. The interior of the church was elaborately decorated by Siebrecht & Son, of New York, a carload of flowers, palms and ferns having been sent up from the city. At the entrance to all the pews in the center aisle were bouquets of white asters and cape smilax. Around the organ and pulpit were screens of ferns and other green stuff. Clusters of giant palms were used with fine effect about the church and in the chancel, as well as on either side of the altar. Pink and white roses were also used in profusion on the streets outside the churchyard. A crowd of several hundred villagers stood for an hour, anxious to get a peep at the bride. As soon as the guests had left the church word was sent out that the edifice was open to the public. There was a rush for the doors and in a short time the church was packed. The decorations, except in the chancel, were stripped from their places and dragged away as souvenirs of the occasion. It was with difficulty that the florists and his helpers restrained the crowd from breaking down and carrying away the costly plants, palms and ferns. The decorations in the chancel will remain until after tomorrow.

Farnleigh is the name of the beautiful country place owned by Bishop Potter's bride. It is situated almost directly across the street from Christ Church, where today's wedding took place. The house is a square structure of stone and marble, built many years ago by the late Edward Clark, founder of the Clark millions. After his death it was occupied by Alfred Corning, but since his death, ten years ago, his widow occupied it but little until two years ago, preferring to spend her summers in the old-fashioned cottage in the same yard, but nearer the street, where her housekeeper now resides.

LOCAL METHODIST PREACHERS. SIGHT-SEEING TRIP

Two Noted Brothers Make a Brief Visit to Portland.

Col. Daniel Appleton, commander of the celebrated Seventh Regiment, New York National Guard, and business manager of D. Appleton & Co., and his brother, Robert Appleton, manager of the subscription department of the same firm, were registered at the Portland Thursday. They were entertained at lunch at the Arlington Club by General C. F. Beebe, where they met many of those prominent in the business and social affairs of Portland.

It is their first trip to the Northwest and is being made to study conditions on the Pacific Coast.
