NEWS OF THE STATE CAPITAL

Matters of Interest of and to Salem and Marion County.

SALEM, Oct. 14.—Governor T. T. Gear yesterday received a requisition from Governor McBride, of Washington, for the arrest and delivery to the agent of the State of Washington of Earl Hansen, the Salem lad who is held in Hillsboro on a charge of stealing horses in Yakima County, Washington. This is the third time that a requisition has been made. The first requisition was dishonored, because based on the information of the District Attorney and Hansen was released. A second requisition was issued, but dishonored because the papers had not been certified to by Governor McBride. A third set was secured by the Washington officers, and these were yesterday received in the Governor's office. Meanwhile the Washington County officials have indicted young Hansen and refuse to surrender him. Today the matter of the extradition will be argued before Governor Gear, and the case promises to become most interesting.

REFUSED TO BE CONVERTED.
In the breach of promise suit brought here several months ago by Martha Wilson against David B. Smith, an answer was yesterday filed by the defendant. He alleges that he and plaintiff had agreed to marry, and while they were engaged she induced him to attend church, and attempted to convert him and secure his membership for her church, when he broke off the engagement. He asks for a dismissal of the action and for his costs.

LAST WILL OF G. W. HUNT.
The last will and testament of the late George W. Hunt, who died on October 4, was yesterday afternoon admitted to probate, and his two sons, M. W. Hunt, of Salem, and J. L. Hunt, of Roseburg, were appointed executors under the terms of the will. The estate is valued at \$5000 in real and personal property. The will was made in 1890, when decedent's first wife was alive. It provides that the property shall be retained by his wife during her life, and at her demise, it is to go to the surviving children or their issue, as per the terms of the will, the property of decedent being minutely divided. Mrs. Hunt died a number of years since, and he married again a few years ago, but his second wife is not provided for in the will.

SALEM NOTES.
Scott Bonarth, manager of the Pacific Homestead, leaves this afternoon for Kansas City to attend the big stock sale, whence he goes to Des Moines, Chicago, and St. Paul to attend the sale of blooded stock—beef breeds and swine. He will also attend the Angora goat exhibition and sale at Kansas City.

In the lecture hall of the Unitarian Church, last night, a reception was tendered Rev. W. G. Elliot, Jr., pastor of the church, the occasion being the 6th anniversary of his birth. The reception was well attended, about 70 members of the congregation and friends being present. A banquet followed the reception, at which Governor T. T. Gear made one of his timely addresses.

The State Board of Education has issued a life diploma to George H. Randle, of Lebanon, a graduate of the Santiam Academy; and a state certificate to Miss Eva L. Marshall, of Cove, Union County, the certificate in this case being issued on Iowa papers.

EUGENE.

EUGENE, Or., Oct. 14.—L. O. Beckwith, a well known grocer of this city, with his store on Seventh and Willamette streets, has sold out to J. C. Small. Mr. Beckwith, who has conducted the store for 13 years, will now retire from active business life.

DIDN'T LIKE THEIR FOOD.
A number of the miners employed at the Lucky Boy mine in Blue River district are out on a strike and are in Eugene. The reason given for the walk-out is that the food furnished the men in the company's eating house is not fit to eat, the fault lying with the cook. It is said the company will at once procure other men to take the places of the strikers. At present only three men out of a force of 14 or 15 are working.

EUGENE IN DARKNESS.
Owing to an accident at the electric light plant, the streets of Eugene have been in darkness during the past two nights. The arc dynamo is alone affected by the accident.

A NARROW ESCAPE.
Wallace Anderson, an 11-year-old boy of this city, came near losing his life by drowning yesterday afternoon. He was riding down First street on his way home, when he met a team at the bridge which crosses the Albany Woolen Mill Company's ditch. In attempting to squeeze by the wagon on the bridge his horse became frightened and jumped into the ditch, throwing the boy off and falling on top of him. The water runs swift in the ditch and the boy was carried quickly down stream under the bridge, to be rescued, in a dazed but unharmed condition, by a half dozen youngsters who happened to be playing in the street.

He leaves a wife and four children. The deceased was one of the early pioneers, having crossed the plains to Oregon from Missouri in 1853.

DOINGS IN OREGON CITY

Clackamas County Items and Matters at the Big Falls.

OREGON CITY, Oct. 14.—An important rule was adopted at the meeting of the school directors last evening. From now on no teacher in the public schools of this city will be allowed to strike or in any way touch a pupil in order to correct them while other pupils are present, or during school hours. Whenever a teacher shall find it necessary to use corporal punishment on a child, it must be done in the presence of the principal after school hours. This rule will stop all slapping and other punishment except in cases where it is actually needed. Other than this, no business out of the ordinary routine work was transacted at the meeting.

MORE ROOM FOR STUDENTS.
The new room that is being constructed in the Eastern school will soon be ready for occupants, but as the seats are coming from an Eastern house, it will probably be ten days yet before the room will be used. Each day makes the demand for the room more urgent, as new pupils are still coming in. There are about 75 more children in the schools now than there were at this time last year.

COLLIDED WITH ELECTRIC CAR.
This morning at about 8 o'clock as Dr. Carll was driving on the roadway between Oregon City and Canemah, his buggy was struck by the electric car, which leaves for Portland at 8:30, and was badly damaged. Owing to the fact the doctor managed to keep the horse from becoming excited, a runaway was averted, thus saving a much worse accident. When the car came in sight the motorman tried to stop but he could not, because of slippery rails. When he saw that there was to be a collision, the doctor got his horse out of the way allowing the buggy to take the blow. The doctor escaped unhurt, except for a shaking up, and the horse was not scratched, but the buggy was wrecked.

TALK ABOUT ELECTION.
Now that it will soon be time for the election of the city officers, including several Councilmen, much talk is being heard on the streets as to the qualifications of different citizens for the several offices. As there has been so much bitterness expressed by some of the citizens over the granting of the railroad franchise it is likely that this will be one of the issues to be used in the election of the Mayor. From present indications the anti-saloons people intend to have a say in the election this fall. Other than these two questions no other point has been brought up. Just who the candidates will be for the office of Mayor has not been settled upon, although several names are being discussed. There is some talk of asking Mayor Dimick to run for a third term, but he is as yet undecided. Little is being said of the candidates for the other offices.

THE OREGON KING

Court Decision Causes a Celebration at Ashwood.

ASHWOOD, Ore., Oct. 14.—The little town of Ashwood, in Crook County, celebrated the decision of the Court of Appeals in the Oregon King Mining case, in a true Fourth of July spirit. The miners shot all the giant powder they could lay their hands on, and everybody participated and greeted the verdict as a just one. This little town is growing slowly but surely, and the growth is thought by everybody who knows the mining possibilities of this camp, to be a substantial growth, and is not believed to be like some towns, to bloom like the morning glory and close at night; it is going to force ahead, regardless of all the obstacles that are encountered in new districts. Of course these difficulties will always retard the progress of any mining camp, but the atmosphere at this place is fast clearing away, and it will only be a matter of time, until the Columbia Southern railway will be loaded with the precious metals, from some of the richest mines on the Pacific Coast. And if those able and learned judges who rendered a decision favorable to the Oregon King Company, could see the joy and enthusiasm at Ashwood, they would surely have cause to believe, that they had guided in the right path, for their verdict had the approval of all disinterested people familiar with the case. The sentiment of the people who know both sides of the controversy is without an exception in favor of the Oregon King Company.

We feel at this place that the Devil himself should have his due; and our sympathy cannot be extended to those who are wrong, be they rich or poor. Justice will predominate in the end, it may for some time be snowed under, but the snow will melt away and right will surely prevail, and though slightly bruised it will come before the world stronger than ever.

With the Oregon King mine in operation, and the other different companies developing their properties, the camp in a very short time will take on a new life, and capital may be induced to invest in the many promising properties now being held by local men, not able to develop them.

MORE PROFITABLE

Dairying Supplants Wheat Raising in Polk County.

INDEPENDENCE, Ore., Oct. 14.—This section is rapidly being turned from a grain-growing territory to that of dairying and kindred industries. Five years ago a silo was a strange sight, but now they are quite frequent, and are considered a necessary adjunct to dairying. Recently Geo. McLaughlin has erected two very large ones, Elmer Hall a good sized one, and H. Mattison, M. Getty, E. Hayer and others are well supplied with silos for the winter. The dairying and kindred industries are gaining foothold here. A good cow will easily bring to her owner a monthly income of \$4 or \$5, and some as much as \$8. The cream is sold to the creamery and the separated article fed to pigs, which find ready market at 5 to 6 cents per pound gross. Many farmers here are deserting wheat raising and engaging in dairying, as it is so much more profitable with much less investment.

ORDER ABSORBED

Pioneers of Pacific Taken Over by the Order of Washington.

PENDLETON, Ore., Oct. 14.—One of the most important business transactions in the history of Pendleton's secret and beneficiary societies was consummated at the last meeting of William Martin encampment, No. 1, Pioneers of the Pacific. Briefly, it was an absorption of the Pioneers by the Order of Washington, a society with headquarters at Portland. The Pioneers of the Pacific was organized in Pendleton five years ago, and has made an excellent showing, both socially and financially. The supreme officers are well known in legal, business and political circles. The object of the consolidation was to reduce the expense of operating the two societies and to increase the solidity of the orders. The vote for the consolidation was almost unanimous; the proposition of the Portland society being considered absolutely fair. The Pendleton branch of the organization will be known as William Martin union No. 145, Order of Washington. There will be practically no change in the local encampment officials. Many of the charter members of William Martin encampment were present, and while deep regret was expressed, all seemed to realize that the change would be beneficial in the end.

The Order of Washington has a membership of 12,000, which, with the 400 from the Pioneers, will make quite a strong society.

J. L. Mitchell, supreme secretary of the Order of Washington, of Portland, came up to conduct the negotiations, while the principals for the Pioneers were Colonel James H. Riley, legal adviser and president of the board of control, and Max Moorehead, supreme scribe.

NORTHWEST NEWS.

The lumbermen of Washington will erect a state building at the St. Louis Exposition to cost \$10,000. The structure will be 100 ft. square and four stories high.

Work on the Columbia Northern on the grade between Washington, Lytle and Goldendale is reported completed for 25 miles out of the entire 42 miles of line, and the track laying will commence shortly.

Monday afternoon a team of horses owned by Charles Peterson, of Ballard, Wash., was struck by an incoming train and one horse was instantly killed and the other injured so that it had to be shot. The driver, Mr. Peterson, narrowly escaped death.

Albert Dray, a bridge carpenter, was struck by a south-bound Northern Pacific train near Ostrander Monday and almost instantly killed. Dray tried to cross the track in front of the moving train. He leaves a widow and three children, living at Kalama.

The steel bridge across Lewis River between Vancouver and Kalama is nearing completion, but a lack of material has put back the work several months. This is one of the finest bridges in the Northwest and will cost \$100,000.

The awarding of the contract for 11,000,000 feet of lumber for the Philippines, to be used in the construction of an Army post, is still hanging fire. It has been announced unofficially that Portland bidders are lower on the aggregate amount.

Wheat is commanding from 51 to 56 cents at Palouse country points, and fully 50 per cent of the crop of 1902 has been sold. Never, since wheat growing became the principal industry of Whitman County, has the crop been so nearly sold out at this time of year.

Fourteen mills will be the tax levy for Walla Walla County this year against 19 mills last year. The value of the county for purposes of taxation is \$10,500,000 against \$9,600,000 for last year. Upon this increased valuation the levy will raise \$147,000, against \$132,000 last year.

For the first time in four years blue-stem wheat has reached the price of 60 cents per bushel in Walla Walla. During the last three days more than 250,000 bushels of grain have been sold. Club wheat lags far behind its normal following price, and is quoted at 55 1/2 to 55 3/4 cents.

From the interior of Norway, to Uwece, in a coffin shaped box, was the trip com-

pleted last week by Mrs. E. Lind, aged 80 years and paralyzed. The box was improvised that Mrs. Lind might travel comfortably, notwithstanding her affliction. She stood the trip well. Edward Lind, her son, accompanied her across the ocean and two continents.

OREGON BRIEFS.

Fire Monday night destroyed a large sawmill and a large portion of the little town of Klamath, near Ashland.

John Newsom, an Oregon pioneer of 1851, died suddenly at his home in Salem, Monday, of paralysis. Deceased was born in Monroe County, Virginia, in 1823.

The Slade freighting outfit has a contract to deliver from Baker City at the Maid of Erin mine 140,000 feet of lumber to be used in the construction of a quartz mill building at the mine.

The new directory of Gales, Stratton & Churchill, which will be issued the last of this week, will show the population of Albany to be 424. This is an increase of 1693 over the census of 1900.

At Dallas, Monday, Kirkpatrick & Williams purchased of local growers 300 bales of choice hops for the London market for 25 cents per pound. These buyers predict that 1903 hops will reach 30 cents.

Over in Linn County ten or twelve schools are unable to open owing to scarcity of teachers. This is largely due to the fact that teachers' wages have not advanced in line with that of other occupations.

The District Fair, which closed at Roseburg Saturday evening, proved a successful meeting, both financially and in the excellence of the exhibits. The displays were all meritorious, both in the pavilion and livestock departments.

Mr. and Mrs. David Whiteaker, aged residents of Independence, were badly injured in a runaway Monday. Mr. Whiteaker, who is in feeble health, received a deep gash in the back of his head and a bad wound on the forehead.

Miss Nina Robinson, who was supposed to have committed suicide by drowning near Redding, Cal., a short time since, while in a fit of despondency, has been discovered at Redding, where she has secured employment as a domestic.

An effort is being made by Athena business men to induce W. T. Rigby to locate a factory for the manufacture of hairy combine harvesters at Athena. Mr. Rigby is a prominent Umatilla farmer, who invented a 12-horse, two-man combine this season.

Mr. Maurice Winters, a prominent

Portland drummer, and Mr. Oscar Zeys, of Albany, were arrested Monday afternoon upon complaint of T. L. Dugger, a Linn County farmer, on the charge of trespassing upon his place while hunting pheasants.

OVER THE WIRES.

Unknown parties shot Judge Allen Hyden, county judge of Owsley County, Ky., from ambush early yesterday morning.

A dispatch from Berlin yesterday says that there is no truth in the rumor that has been circulated that Minister Jackson was going to The Hague.

Pickpockets traced Edward Egbert to a room in the Murray Hotel at Melrose, Iowa, yesterday. Egbert is charged with originally assaulting Gerta Klinton, aged 13 years.

Millard S. Denlow was arrested at Buffalo, N. Y., yesterday, charged with stealing \$23,000 from the firm of I. A. Millmore, of Chicago, dealers in iron and steel. He was employed by the firm as buyer.

A child weighing one pound and seven ounces was born in New York city yesterday. It was at once taken to the Post-Graduate Hospital, where it is being kept in an incubator. It is the smallest living child ever born.

The crew of the steamer Dos Hermanos mutinied and attempted to kill the officers and secure \$15,000 which was on board. Owing to the fact that the attack was made near the Manila constabulary barracks it was a failure.

While in a drunken frenzy last night Thomas Dougherty, a blacksmith of Ottumwa, Iowa, attempted to kill his entire family by shooting them. When he found out that he could not accomplish his purpose he committed suicide.

While entertaining Ambassador Choate and Generals Corbin, Wood and Young at luncheon at the Buckingham Palace yesterday, King Edward expressed himself as glad to see them, "because," he said, "I feel that we are not only friends but brothers."

At Nacogdoches, Tex., a mob is making every effort to get hold of Jim Buchanan, a negro, who confessed that he killed Duncan Hicks, wife and daughter. It is more than likely the fiend will be burned at the stake if he can be gotten away from the officers.

John A. Hobson, a well known sociologist, who is now the guest of Harvard University and the Twentieth Century Club, prophesies serious conflicts in Eng-

land between organized labor and organized capital, according to the Times special from Boston.

In order to press her suit regarding the crown lands Queen Liliuokalani will come to the United States in November. During Republican political meetings in various Porto Rico towns yesterday there were a number of riots, in which several prominent men were injured.
