SMITH CASE IS POSTPONED

Question of Gambling at the State
Fair Will Be Investigated.

(Journal Special Service.)
SALEM, Oct. 17.—The case of A. C. Smith, a prominent stock buyer, residing near here, who was arrested charged with obtaining money under false pretenses, came up for hearing in Justice of the Peace E. D. Horgan's Court yesterday, but owing to the absence of material witnesses for the defense, a postponement was had to next Tuesday, at 1 p. m. Smith is charged with issuing a check for \$200, and securing the money thereon, after which he stopped payment on the check. The defendant claims that he was playing cards and had lost heavily, when he drew the check, and after cashing it, lost the money in the game, when he stopped payment on the check, claiming that the money he received was his own. The holder of the check asserts that he was not gambling with the defendant, but paid him the cash for his paper.

This matter, it is asserted, will bring up the whole question of gambling in this city, as run during the State Fair, when this transaction occurred, and an investigation may be made that will go deeper than it is now anticipated. Smith is a well-to-do man, who recently arrived here from Iowa. In his old home he stood well, and at one time served his home county as Sheriff for eight years. He is represented by Ford, Kaiser & Slater, and the state's interests are looked after by Deputy District Attorney C. S. McNary.

Don't Want the Job.

GRANTS PASS

A RAILROAD TO SALT WATER

Necessary Funds Have Been
Secured for Right-of-Way
and Terminal Grounds.

GRANTS PASS, Oct. 17.—At a mass meeting of citizens called to raise another thousand dollars to purchase a terminal site for the proposed deep salt water railroad, the necessary funds were raised, over \$4000 being now subscribed. It was stated that the cost of the surveys to date amounted to about \$15,000, and that construction will commence immediately. A report of P. H. Harth, chairman of the committee on right of way and terminal grounds, showed the bonding of some 30 acres for the purpose near the Southern Pacific Company's track, east of town.

OREGON CITY, Oct. 17.—Because some practical joker tried to be funny last evening A. F. Parker, the barber, was rendered unconscious for several hours and in this condition was left to take care of himself. A few minutes after 8 o'clock he closed his shop and started on his wheel for his home in Gladstone. As he was riding over one of the bridges on the bicycle path he noticed that the upper rail had been pulled off, but looked around just in time to see it across the bridge about a foot from the floor. He remembers nothing more until his senses were restored to him at 4:30 this morning. He had either found his way home or had been assisted, but this is a blank to him. The right side of his face is badly bruised and scratched and his body is painful him this morning, but he was able to go to his shop during the day. It is not known who placed the rail across the bridge.

OREGON BRIEFS.

R. G. Marsland, who escaped from the county jail at Dallas last Saturday night, was captured near Corvallis early Thursday morning.

Near Coquille, one day last week, 13 calves were killed by a freight train. Eight flat cars were piled up and completely wrecked.

The little steamer Rufus struck a rock in Indian rapids, west of Arlington, and sank in 20 feet of water. The vessel and cargo is a total loss.

Hugh Hogan, a well known young man of The Dalles, has been arrested on the charge of having robbed H. H. Grant's cigar store last Monday night.

The yield of corn in the fields around Athena will be from 25 to 35 bushels per acre. Corn is a paying crop in Umatilla County, and the acreage is increasing each year.

Dr. Douglas Riggs was found dead Thursday on the Mount Hood road. He had left his team standing on the road, tied up the lines, and had lain down beside the wagon, where he was found.

Fort Stevens has again been visited by firebugs, and twice within the past two weeks there have been recurrences of the attempted incendiary work similar to those which happened some months ago.

It has been discovered that under the new initiative and referendum amendment no act of the Legislature can go into effect for 90 days after the close of the session. This applies also to appropriations.

It is understood that a large part of the Hood River exhibit of apples at the recent fruit fair will be taken to Chicago by the Harriman system of railroads to be placed on exhibition at their office in that city.

The woman who is establishing agencies for an alleged book concern, has been victimizing Corvallis girls, one of whom, Miss Ida Van Hoesen, was induced to part with \$15, her earnings in the hop fields this season.

John G. Porter, Deputy County Assessor, died at Oregon City Thursday, aged 67 years. He came to Oregon in 1886, and was prominently identified with the interests of the county, and was a man of prominence in Republican politics.

Charles Meserve, a newspaper man of ability, has completed arrangements for installing an up-to-date printing plant at Medford, the cost of which will be several thousand dollars. He will issue a newspaper and conduct a job printing office.

The body of an unknown man was found on the beach near the Point Adams Lifesaving Station by a soldier from Fort Stevens Thursday afternoon. The remains were those of a man about 25 years of age, six feet in height and weighing fully 175 pounds.

The Klondike's output for this year is estimated at \$12,000,000. The total shipped to date from Dawson is given at \$10,255,000.

When the registration books at Walla Walla closed Wednesday night 1850 voters had received certificates. This is almost 15 less than at the general election.

The average salaries paid to male school teachers in Washington is \$36.42, and to females \$44.38. The number of school children in the state is 185,582.

There were 1200 paid admissions to the Whitman County Fair at Colfax Thursday. The fair in all respects is said to be the best Whitman County has ever had.

Arrangements have been made for the departure of the Ten'h Battery, field artillery from Fort Walla Walla Saturday afternoon. They will go to Fort Snelling, Minn.

A postoffice has been established at Sumner, Snohomish County, Wash. The office at Midford, King County, has been abandoned, its mail going to North Bend.

Grove Meyers, a young Centralia shingle-weaver, was fined \$100 yesterday by Justice White, of Chehalis, for furnishing a girl about 14 years old with liquor last Sunday and getting her drunk.

F. A. Bell, formerly treasurer of the Issaquah Coal Company, and a well known shipping agent of Seattle, was arrested Wednesday, charged with the embezzlement of \$15,000 from the Issaquah Coal Company.

There has been an alarming spread of smallpox in Walla Walla during the last few weeks. Eight cases are now at the post house west of the city and over a dozen persons are quarantined within the municipal limits.

An active campaign will likely be instituted against the practice of transporting logs to San Francisco in the form of huge rafts. It is considered dangerous and masters and pilots will petition congress to enact legislation forbidding it.

The United States assay office at Seattle on Wednesday shipped nearly a half million dollars in gold to the United States mint in San Francisco. With that big amount of the yellow metal gone the office still has on hand gold amounting to within a few thousand dollars of \$1,500,000.

Evidence of what may prove to be a marine tragedy were reported by the Rosalie upon her arrival at Seattle from Victoria. A derelict fishing schooner, abandoned and partially filled with water, was found tossing about in the waters of the Strait of Juan de Fuca and there is no absolute evidence to determine the fate of her crew.

OVER THE WIRES.

Ex-Minister to Italy Potter entertained the Crown Prince of Siam in Philadelphia yesterday. During an informal reception held in the evening for newspaper men the Prince made the statement that he wished the American newspapers would use larger type.

Seven hundred coal miners struck at Parsons, Kan., yesterday because the company refused to pay the engineers the union scale.

A cable dispatch from Manila yesterday, dated October 16, says that of 12 enlisted men whose deaths have been reported to the department, only one died of cholera.

When the tariff bill was taken up at the session of the Reichstag in Berlin yesterday Chancellor von Bulow made a strong speech in favor of its adoption. He maintained that it would promote trade in Germany as well as abroad.

The report which was circulated on Wall street yesterday that Russell Sage was dead was without foundation.

While holding up a train near Odessa, Russia, yesterday, Cossack brigands stabbed to death the conductor and Prince Gedevanoff, who was sleeping in the first class carriage.

Another sensation is looked for in the St. Louis boodle cases. It has been intimated that the sheriff or his deputies have been aiding the bootleggers to delay the prosecution.

Because he thought his wife's parents had induced her to secure a divorce, Archie Woodin killed Mr. and Mrs. Guicke and his own 18-months-old baby, yesterday. He then tried to kill his wife.

Yesterday two of the men who severely beat and attempted to rob the aged Meach brothers, were identified by the Cleveland, Ohio, police.

M. M. Booth was appointed special master by Judge Kohlsaat in Chicago yesterday, to take evidence in an effort to recover \$700,000 from Captain Carter, who was convicted of defrauding the government by a conspiracy with contractors at Savannah, Ga.

Slow progress is being made in the Horn murder case, which is now being tried at Cheyenne, Wyo.

The famous Vienna surgeon Dr. Lorenz successfully operated on three children yesterday in Chicago. The cases were all dislocation of the hip, and the operations were witnessed by a large audience of physicians and surgeons.

A report was given out in Havana yesterday by business men who had been called in to consult with President Palma, that Cuba will accept the treaty with America.

General Bruce-Brown, pastor of the Christian church in Denver, was asked to resign his position yesterday at the session of the Christian church convention, now in session at Omaha. He is charged with sensationalism.
