WEATHER FORECAST.

Heavy rains have fallen in Northern California, and moderately heavy rains in the North Pacific States, while the weather west of the Mississippi River is generally cloudy and threatening.

High winds occurred yesterday along the Oregon and Washington Coasts, and a maximum velocity of 36 miles southeast was reported from North Head, Wash. The high winds have now subsided, and the rains have ceased in California and Western Oregon.

It is much warmer in Northwestern Washington, Northern Idaho, Montana, Western South Dakota, and Nebraska.

The indications are for showers Thursday in Northern Oregon, Washington, and Idaho.

Oregon—Tonight, partly cloudy, with showers and cooler east portion; warmer southwest portion; Thursday, partly cloudy south, probably showers north; southwesterly winds.

Washington—Tonight and Thursday, showers; cooler northeast portion tonight; south to west winds.

Idaho—Tonight and Thursday, showers; cooler North and Southeast portions tonight.

CROWN OF DENMARK

Arrives From Santa Rosalia After a Long Passage.

The Crown of Denmark is now in the stream waiting a berth at the docks. She came from Santa Rosalia in ballast and was 55 days in making the passage. It usually takes but about 45 days to make the run. Captain Milman, her master, reports that contrary winds were encountered during a great portion of the voyage. In the Gulf of California three local storms were met with, and 15 days were occupied in coming down the Gulf. BARRY RESIGNS

No Longer Secretary of State Federation.

ACTIVE UNION MAN

His Letter of Resignation States Other Matters Will Occupy His Mind.

William H. Barry, one of the most prominent and active labor leaders in the city and state, has tendered his resignation as secretary of the State Federation of Labor. Mr. Barry will be missed in labor circles, and it will be a difficult matter to secure a man so well fitted for the position as he. A copy of his letter of resignation is self-explanatory and is as follows:

another conference take place next week, when G. Y. Harry, president of the State Federation of Labor, would be present.

Various ways of inducing Mr. Wakefield, the contractor for building the dry dock, to build it in Portland were discussed. It was suggested that the unions make a modification in wages so that the dry dock may be built in Portland as cheaply as in Vancouver. The labor people replied to this that high cost of lumber was one of the causes why the dry dock is not built here, so why should not the lumber interests bear the burden of reduced rates. The answer to this was made by Mr. McInnes, who said:

"The lumber is being supplied by mills in Portland. The demands of the unions have made it impossible to engage with Puget Sound shipbuilders, for example, on even terms; the carpenters here get \$3.50 to \$4 a day of eight hours, where they got from \$2 to \$4 a day of nine or ten hours there. There helpers could be hired as low as \$2 per day, while here they cost \$3.50 per day.

Mr. Thomas responded to this that carpenters get \$2.50 per day here and not \$4, as stated, and that the carpenters were reasonable as to who the helpers should be. He concluded by referring the rest of the discussion for next week to be answered by Mr. Harry.

WATER THEIR CRY

Water Commissioners Unable to Get Needed Pipe.

Whitney Boise appeared before the Water Commissioners on their regular meeting yesterday afternoon and made a strong plea for the extension of water mains in Hawthorne's First Addition. He said there were about 30 houses in course of construction in the addition and asked the Commissioners what the people were going to do for water when they got ready to occupy them. In Hawthorne Park Mr. Boise said they had sold a number of houses, guaranteeing the purchasers that they would have water. Petitions were filed in proper form but so far the mains had not been laid and the occupants were getting along without the use of city water. Some of them get water from an old stand pipe where the street contractors use to water their horses and some have laid iron pipe at their own expense to the nearest main 500 feet away. Mr. Boise said the condition was intolerable.

CITY IS GROWING.

"This part of the city is growing rapidly," said Mr. Boise, "and we want to encourage its further growth instead of retarding its progress by not furnishing the proper encouragement. The city should encourage the building of houses by giving the people every convenience. The members of the board assured him they were doing all they could to relieve the situation. "We can not get the pipe," Commissioner Ladd said. "Eastern manufacturers will not agree to furnish pipe at any given time. We are taking the output of the Oswego mill, but that does not give us sufficient supply for our needs."

All admitted that the situation was serious, and that every endeavor would be made to relieve the immediate needs of the people, but it was frankly admitted that nothing encouraging could be offered.

THE BROKEN MAIN.

The question of who should pay for the broken main on the Macadam road which was destroyed by the contractor's dynamiting was discussed and referred to the city attorney for an opinion.

A communication was read from the Port of Portland, regarding the subject of a deep channel from the Mallico street bridge, to Inman, Poulsen & Co.'s mill. If the channel is deepened the Ruil Run pipe will have to be lowered. The matter was left with the construction committee to confer with the Port of Portland people.

COLUMBIA TELEPHONE CO.

Is Ordering Material and Making Plans to Rebuild—Have Asked City to Allow Them to Place Wires Underground.

The latest telephone statistics show that there are 3,600,000 telephones in the United States, and of this number 2,000,000 belong to what is known as independent telephone companies and 1,600,000 to companies controlled by the Bell Telephone Company.

These figures show the independent companies to have 400,000 more than the old companies, which is a most remarkable showing, when we consider that the Bell company started in the '70s and was protected by patents into the '90s, and that the independent companies have been in the field only about seven years.

To the people of the Pacific Coast these figures seem almost incredible, inasmuch as so little has been done West of the Rocky Mountains in the independent field, but all this is changing very rapidly and the best posted telephone men predict that within the next three years the independent telephone business will be developed on this Coast the same as it is in the East today. A strong movement in this direction has even now started. At Los Angeles a new company is building a large plant which will be in operation about January 1. Up to date they have over 8000 signed subscribers. Other exchanges are being built in California and new franchises are being granted all the time.

The new exchange movement in the Northwest is the new exchange just put in operation at Seattle by the Independent Telephone Company, and which is one of the finest plants in the country.

In keeping with the spirit of the times the Columbia Telephone Company of this city have asked the Board of Public Works to allow them to place their wires underground, and the same company is preparing their plans and ordering material to commence rebuilding their plant throughout, so as to give Portland first-class telephone service and take care of the people who desire the best.
